Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Superior Steel, Inc. 401(k) and Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. 

NOTE 1 - DESCRIPTION OF PLAN

The following description of Superior Steel, Inc. 401(k) and Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution plan that covers all eligible employees of Superior Steel, Inc. (collectively, the "Company"). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

The Plan has entered into an agreement with Great-West Life & Annuity Insurance Company (marketed as "Empower Retirement") and has appointed this company as trustee of the Plan assets. The recordkeeping of the Plan has also been delegated to Empower Retirement.

Eligibility - Employees of the Company become eligible to participate in the Plan after reaching the age of eighteen years and completing one year of service. For the purposes of both employee and employer contributions, employees may participate in the Plan on January 1 and July 1 following the day the eligibility requirements are met.

Contributions - Participants may defer up to 100% of their eligible compensation into the Plan, up to the maximum amount allowed by the Internal Revenue Code ("IRC"). Contributions are made on a pre-tax basis. Participants who have attained the age of fifty before the end of the Plan year are eligible to make additional "catch-up" contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants directly allocate their contributions into various investment options offered by the Plan. The Plan offers multiple registered investment companies and a common/collective trust as investment options for participants. The Company contributions under the Plan are at the discretion of management.

Participant Accounts - Each participant's account is credited with the participant's contributions and allocations of (a) Company contributions (if any) and (b) plan earnings (losses), and charged with an allocation of administrative expenses. Allocations to each participant are based upon the ratio of their account balances to the total of all participant account balances.

Vesting - Participants are immediately vested in their contributions and rollovers along with the actual earnings thereon. Participants vest in employer contributions, plus earnings thereon, based on years of continuous service at a rate of 20% per year, beginning with second year of participation. Participants shall become fully vested upon death or total and permanent disability.

Forfeited Accounts - At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$31,995 and \$53,646, respectively. Balances may be used to reduce Company contributions or to pay Plan expenses, and are typically paid into the plan in the following period. The Company expects to use approximately \$28,000 of the forfeiture balance to offset the 2024 employer profit sharing match contribution, paid in 2025.

Hardship Withdrawals - The Plan allows participants to withdraw a portion of their account balance in the event of immediate and heavy financial need. Any hardship withdrawal is limited to the amount needed to meet the financial need and must qualify with respect to plan provisions.

Payment of Benefits - On termination of service due to death, disability, retirement, or separation, participants may receive a lump-sum payment equal to the participant's vested interest in his or her account. Vested account balances less than \$7,000 are automatically distributed without participant consent.

Administrative Expenses - Plan expenses may be paid out of Plan assets unless paid directly by the Company.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates - The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition - The Plan's investments are reported at fair value. Quoted market prices are used to value investments. Shares of registered investment companies are valued at the net asset value of shares held by the Plan at year-end. The common/collective trust is stated at contract value based on the net asset value of the underlying securities.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments held during the year. Employee contributions are recorded when salaries are paid.

Contributions Receivable - The Company makes discretionary profit sharing contributions, allocated to each participant using the percentage of each participants compensation divided by the total compensation for all participants eligible to participate in the profit sharing amount. These contributions are calculated at the end of the plan year to be paid in the following year. As of December 31, 2024 and 2023, the Company recorded employer contribution receivables of \$750,000 and \$2,000,000, respectively, and at December 31, 2024 and 2023, recorded employee contribution receivables of \$3,554 and \$2,778, respectively.

Benefit Payments - Benefit payments are recorded when paid.

Date of Management's Review - Management has evaluated events and transactions occurring subsequent to the statements of net assets available for benefits date for items that should potentially be recognized or disclosed in these financial statements. The evaluation was conducted through October 15, 2025, which is the date these financial statements were available to be issued.

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information with the related information included in the financial statements and supplemental schedule.

NOTE 4 - FAIR VALUE MEASUREMENTS

Fair value is defined as the exchange price that would be received for an asset or paid to transfer a liability in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date. A valuation hierarchy has been established for disclosure of the inputs used to measure fair value. This hierarchy prioritizes the inputs into three broad levels. Level 1 inputs are quoted prices (unadjusted) in active markets for identical assets or liabilities. Level 2 inputs are quoted prices for similar assets and liabilities in active markets or inputs that are observable for the asset or liability, either directly or indirectly through market corroboration, for substantially the full term of the financial instrument. Level 3 inputs are unobservable inputs based on the Plan's assumptions used to measure assets and liabilities at fair value. A financial asset or liability's classification within the hierarchy is determined based on the lowest level input that is significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value.

Registered Investment Companies (Level 1) - The fair value of registered investment companies (mutual funds) is based on quoted net asset values of the shares held by the Plan at December 31, 2024 and 2023.

Common/Collective Trust (Level 2) - The common/collective trust (the "Trust") invests in a variety of investment contracts such as guaranteed investment contracts issued by insurance companies and other financial institutions and other investment products with similar characteristics. The contract value of the common/collective trust, approximates fair value. The contract value of the Plan's investment in the Trust was computed based on the value for the Trust as a whole obtained from the Trust's annual reports.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 - COMMON/COLLECTIVE TRUST

The Plan sponsor has a trust agreement with Empower Retirement which authorizes participation in the Key Guaranteed Portfolio Fund (the "Fund"), a common/collective trust. As clarified by the Financial Accounting Standards Board (FASB) with the issuance of Accounting Standards Update (ASU) 2015-12, fully benefit-responsive investment contracts are required to be reported at contract value. Because the Fund is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributed to the Fund because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The beneficial interest of each participant is represented by units. Units are issued and redeemed daily at the Fund's NAV. Distribution to the Fund's unit holders is declared daily from the net investment income and automatically reinvested in the Fund on a monthly basis, when paid. It is the policy of the Fund to use its best efforts to maintain a stable net asset value, although there is no guarantee that the Fund will be able to maintain this value.

Participants ordinarily may direct the withdrawal or transfer of all or a portion of their investment at contract value to any other investment option offered under the Plan at any time with no restrictions or penalties. Contract value, as reported to the Plan by Empower Retirement, represents contributions made into the Trust, plus earnings, less participant withdrawals and administrative expenses. The crediting interest rate of the Fund fluctuates. The average yield earned by the Plan (derived by averaging the Fund's quarterly gross interest rates) for 2024 and 2023 was 1.41% and 1.23%, respectively. The actual average yield earned by the Plan (derived by averaging the Plan's quarterly interest rates) was 1.41% and 1.23%, respectively.

NOTE 6 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan at any time subject to the provisions set forth in ERISA. In the event of a Plan termination, no further contributions would be made to the Plan and participants would become 100% vested in their Company contributions.

NOTE 7 - TAX STATUS OF PLAN

The initial effective date of the Plan was January 1, 2006. Effective June 1, 2022, the Plan was amended and restated and adopted the Tennessee Pension Administrators, LLC Prototype Plan (the "TPA Prototype Plan"). The Internal Revenue Service determined and informed Tennessee Pension Administrators, LLC (the "TPA") by a letter dated June 30, 2020, that the TPA Prototype Plan, as then designed, was in accordance with applicable sections of the IRC. The Plan has not filed for its own determination letter. Although the Plan has been amended since the prototype determination letter was issued, the Plan administrator and the Plan's tax counsel believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

The Plan recognizes tax loss contingencies when it is probable that a liability had been incurred and the amount of the loss could be reasonably estimated. The amount recognized would be subject to estimates and management's judgment with respect to the likely outcome of each uncertain tax position. Although the tax years ending December 31, 2021 through December 31, 2024 remain open for examination by various taxing authorities, it is management's opinion that no significant uncertain tax positions remain open at December 31, 2024.

NOTE 8 - RISKS AND UNCERTAINTIES

The Plan's investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 9 - PARTY-IN-INTEREST

The Company is the administrator of the Plan and, as such, executes the normal duties associated therewith. Costs incurred for audit, legal, and other administrative functions are paid by the Company on behalf of the Plan. There were no financial transactions recorded between the Company and the Plan other than contributions made by the Company to the Plan. TPA provides certain administrative services to the Plan. The Plan's investment adviser is Rather & Kittrell Capital Management. The Plan invests in funds managed by Empower Retirement. Empower Retirement acts as contract holder and recordkeeper for those investments as defined by the Plan. Transactions in such investments qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.
