Notes to Financial Statements

December 31, 2024

1. Description of Plan

The following description of the Cape Physicians Associates 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions, including definitions of key terms.

General

The Plan is a defined contribution safe harbor plan covering all employees of Cape Physicians Associates, P.A. d/b/a Cape Regional Physicians Associates (the Plan Sponsor, or the Practice). Employees are automatically enrolled in the Plan immediately upon commencement of employment. The Board of Directors of the Plan Sponsor controls and manages the operation and administration of the Plan. The Plan utilizes State Street Bank and Trust Company, Inc. (State Street) as trustee and Transamerica Financial Life Insurance Company, Inc. (Transamerica) as custodian. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions

Participants may make pre-tax contributions based on an elected dollar amount or percentage of eligible compensation, as defined in the Plan document, subject to certain Internal Revenue Service (IRS) limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make additional catch-up contributions. Participants may also contribute amounts representing eligible rollover distributions from an eligible plan sponsored by a previous employer. The Plan allows participants to make Roth deferrals and direct rollovers from another qualified Roth contribution program into the Plan.

The Plan also provides for non-elective employer contributions equal to 3% of wages, up to the amount defined by IRS regulations as Highly Compensated Employees (HCE), for the full Plan year. The HCE limit was \$345,000 for the year ended December 31, 2024. The non-elective employer contribution totaled \$656,152 for the year ended December 31, 2024. Effective January 1, 2022, the Plan allows for automatic enrollment which includes a default contribution of 4% with annual escalation of 1% up to a maximum of 8%.

Notes to Financial Statements (continued)

1. Description of Plan (continued)

Participant Accounts

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contribution, non-elective contribution and investment earnings, and is charged with withdrawals and an allocation of investment losses and administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participants direct the investment of their account balances into various investment options offered by the Plan and may change their investment options at any time, subject to the terms of the funding vehicles. Plan earnings (losses) are allocated to participants' accounts on a daily basis according to the type of funding vehicle in which balances are invested.

Fund managers' fees are charged to participants' accounts as a reduction of the return earned on each investment option.

Vesting

Participants are immediately fully vested in all employee and employer contributions to the Plan.

Notes Receivable from Participants

Participants may borrow from their 401(k) accounts a minimum of \$1,000 up to a maximum of the lesser of 50% of their vested 401(k) account balance or \$50,000. Loan terms range to a maximum of five years, but can extend for up to a 15-year period if used for the purchase of a primary residence. Loans to participants are secured by the balance in the participant's account, and a participant may only have one loan outstanding at a time. Interest rates are fixed at the time of borrowing at the current prime rate plus 2%. Interest rates on notes receivable from participants ranged from 5.25% to 10.50% at December 31, 2024 and 2023. Principal and interest are paid by the participants directly to the custodian based on prescribed due dates.

1. Description of Plan (continued)

Payment of Benefits

Upon separation of service from the Practice due to death, total and permanent disability, retirement or termination, participants whose vested account balance exceeds \$5,000 may elect to receive a distribution of his or her entire accumulated Plan balance, subject to the terms and certain limitations of the funding vehicles. Account balances that are greater than \$1,000 but less than \$5,000 can be distributed without a participant's consent in direct rollover to an individual retirement account. Participants whose vested account balances are less than \$1,000 will automatically receive immediate lump-sum distributions equal to their vested account balances. Distribution options include lump-sum payments, annuities, partial payments or installments. In addition, participants may elect in-service withdrawals after reaching age 59½. Participants are also permitted to make hardship withdrawals in certain cases of immediate and heavy financial need. Rollover account balances may be withdrawn at any time. Minimum required distributions for participants who have reached age 73 also apply per IRS regulations.

Administrative Expenses

The Plan's administrative expenses are paid by either the Plan or the Plan Sponsor. The expenses paid by the Plan Sponsor are excluded from these financial statements. The expenses paid by the Plan pertain to investment consulting fees and other administrative charges incurred by the Trustee and Custodian in connection with the administration of the Plan. Investment management fees and operating expenses charged to the Plan are deducted from investment income earned on a daily basis and are not separately reflected. Investment management and loan processing fees and distribution fees are paid by the participants.

Plan Termination

Although it has not expressed any intention to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting.

2. Summary of Significant Accounting Policies (continued)

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes and supplemental schedule. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments held by the Plan are reported at fair value, except for fully benefit-responsive investment contracts which are reported at contract value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). See Note 4 for further discussion and disclosures related to fair value measurements.

Contract value is the relevant measurement attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. See Note 5 for further discussion of the New York Life (NYL) Guaranteed Interest Account.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Payment of Benefits

Benefit payments are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants represents participants loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded when it is earned. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant's loan to be in default, the participant's loan balance is reduced and a benefit payment is recorded.

3. Investments

All information disclosed in the accompanying financial statements and supplemental schedule, including investments held and notes receivable from participants at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest income on notes receivable from participants, and dividends and interest for the year ended December 31, 2024, was obtained or derived from information provided to the plan administrator and certified as complete and accurate by State Street, the trustee of the Plan, Transamerica, the custodian of the Plan, and New York Life Insurance Company, for the NYL Guaranteed Interest Account.

4. Fair Value Measurements

Fair value is defined under Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, as the price that would be received to sell an asset or paid to transfer a liability in orderly transaction between market participants at the measurement date (i.e., an exit price). To measure fair value, a hierarchy has been established that requires an entity to maximize the use of observable inputs and minimize the use of unobservable inputs. As such, the hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

- Level 1 – Unadjusted quoted prices in active markets that are accessible to the reporting entity at the measurement date for identical assets and liabilities.
- Level 2 – Inputs other than quoted prices in active markets for identical assets and liabilities that are observable either directly or indirectly for substantially the full term of the asset or liability.
- Level 3 – Unobservable inputs for the asset or liability (i.e., supported by little or no market activity). These inputs reflect management’s judgment about the assumptions that a market participant would use in pricing the investment and are based on the best available information, some of which may be internally developed.

The asset’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The NYL Guaranteed Interest Account seeks to provide a low-risk, stable investment option. The fund provides the guarantee of principal and accumulated interest, subject to the terms of the contract. The fund invests in diversified fixed income portfolio within the NYL general account. The general account is invested primarily in a conservative array of securities and cash-equivalent investments in accordance with the investment restrictions of New York Insurance Law.

The investments are valued at contract value. All withdrawals and transfers from the fund are payable at contract value. Contract value represents contributions made to the account plus earnings less participants' withdrawals and administrative expenses. Due to the size of the fund and the specific percentage allowance negotiated by the fund, it is highly unlikely (not probable) that any event would occur that would limit the fund's ability to transact at contract value with each issuer under these events.

Notes to Financial Statements (continued)

5. Investments at Contract Value (continued)

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer, but will always be subject to a range between 1.00% to 3.00%. Such interest rate is reviewed on a semi-annual basis. The interest rate credited to participants was 3.00% as of December 31, 2024. The contract value of the amounts held in this account was \$81,706 and \$67,652 at December 31, 2024 and 2023, respectively.

The Plan also holds certain investments in an insurance company general account managed by Transamerica with a contract value of \$36,698 and \$24,329 at December 31, 2024 and 2023, respectively.

6. Related-Party and Party-in-Interest Transactions

The Plan holds certain investments in an insurance company general account managed by Transamerica, the custodian of the Plan, and New York Life Insurance Company, for the NYL Guaranteed Interest Account. Certain administrative functions are performed by officers or employees of the Practice. No such officer or employee receives compensation from the Plan. Administrative expenses are paid from the Plan to the trustee and custodian. These transactions qualify as party-in-interest transactions that are exempt from the prohibited transaction rules under ERISA.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are reported as notes receivable from participants in the accompanying statements of net assets available for benefits.

7. Tax Status

The underlying non-standardized prototype plan has received an opinion letter from the IRS dated June 30, 2020 stating that the form of the Plan is qualified under Section 401 of the Internal Revenue Code (the Code) and, therefore, the related trust is tax exempt. The Plan Sponsor has determined that it is eligible to and has chosen to rely on the current IRS prototype plan opinion letter. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualification. The Plan administrator believes the Plan, as amended, is being operated in compliance with the applicable requirements of the Code and, therefore, believes that the Plan is qualified and the related trust is tax exempt.

7. Tax Status (continued)

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

9. Subsequent Events

Management has evaluated the need for additional disclosures and/or adjustments resulting from subsequent events for the Plan through October 15, 2025, the date the accompanying financial statements were available to be issued.
