NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024

NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the Benchmark Group Employee Stock Ownership Plan (the “Plan”) provides only general information. For a more complete description of the Plan’s provisions, participants should refer to the Plan Document, which is available from the Plan Administrator, Benchmark Group, Inc. (the “Plan Sponsor” and “Employer”).

General

The Employer established the Plan effective January 1, 2024. The Plan operates as a employee stock ownership plan (“ESOP”). It is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code of 1986, as amended (“Code”), and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”). The Plan is administered on the basis of a Plan year, which is the 12-month period ending December 31 each year. The Employer is the Administrator of the Plan. The trust department of an independent third-party bank is the Plan’s Trustee.

Allocated and Unallocated Shares

Future Plan borrowings (see Note 7) will be collateralized by the unallocated shares of the Employer’s common stock and guaranteed by the Employer. The Employer, in its role as lender, has no rights against shares once they are allocated under the Plan. Accordingly, the Plan’s financial statements present separately the assets and liabilities and changes therein pertaining to:

- a) The accounts of employees with allocated stock (Allocated); and
- b) Stock not yet allocated to employees (Unallocated).

At December 31, 2024, the Employer contribution receivable is presented as Allocated and Unallocated based on how the Employer contribution will be used to provide allocated stock to participants.

Eligibility

The Plan covers all employees of the Employer who have completed 1,000 hours of service in a Plan year and who are not employees of affiliated companies (unless such affiliated companies have specifically adopted this Plan in writing), leased employees, nonresident aliens, residents of Puerto Rico or employees covered under a collective bargaining arrangement. An employee is allowed to enter the Plan on the first day of the Plan year in which such employee satisfies the eligibility requirements. Participants who have at least 1,000 hours of service during a Plan year and are employed on the last day of the Plan year are eligible for an allocation of Employer contributions for such year. Any participant who terminates employment and is re-employed by the Employer, before a one-year break in service occurs, shall immediately be reinstated as a participant in the Plan.

### Contributions

For each Plan year, the Employer shall contribute to the Plan such amount as needed by the Plan to meet its obligations, as determined by the Employer. The Employer is obligated to make contributions in cash to the Plan which, when aggregated with the Plan's dividends and interest earnings, if any, will be sufficient for the Plan to make its regularly scheduled payments of principal and interest due on the future plan borrowings (see Note 7). Participant contributions to the Plan are not permitted.

As of December 31, 2024, the Plan's assets consisted only of a contribution receivable from the Employer to meet the obligations of the future plan borrowings as described in Note 7.

### Vesting

Participants vest in their account 20% per year beginning after two years of service, resulting in 100% vesting after six years of service or upon (a) satisfying the age requirement for normal retirement (age 62); (b) suffering a disability (as defined) while employed by the Employer or (c) death while employed by the Employer. A year of service is any year that a participant completes at least 1,000 hours of service during twelve consecutive months. Years of service shall include service prior to the effective date of the Plan.

Forfeitures of the nonvested portion of terminated participants' accounts after the terminated employee incurs five consecutive one-year breaks in service may be used to pay Plan expenses. Any forfeitures not used by the Plan will be added to the discretionary contribution and allocated to the accounts of remaining ESOP participants eligible to share in the contribution. There were no forfeited nonvested account balances at December 31, 2024.

### Payment of Benefits

No distributions will be made from the Plan until a participant retires, dies (in which case payment shall be made to his or her beneficiary or, if none, his or her legal representatives) or otherwise terminates employment with the Employer. Distributions shall be made in cash.

Account balances of participants who terminate for reasons other than death, disability or retirement at age 62 will remain in the participant's account until the later of five years after termination or the year following the Plan year in which the note payable issued to purchase the Employer's common stock is repaid. At that time, the vested portion of the account will be distributed in substantially equal annual installments over a period not longer than five years, unless the participant elects in writing a longer distribution period. In the case of a participant with an account balance attributable to Employer stock in excess of \$50,000, the five-year period shall be extended one additional year (but not more than five additional years) for each \$50,000 or fraction thereof by which such balance exceeds \$1,380,000, as adjusted. Accounts with vested balances less than \$50,000 will be distributed in a lump sum cash payment.

Voting Rights

The Plan Trustee votes all Employer stock held by it as a part of the Plan assets, as directed by the Employer, provided that the participant or participant's beneficiary is entitled to direct the Trustee as to the manner in which voting rights on shares of Employer stock which are allocated to the participant's account are to be exercised with respect to the approval or disapproval of any corporate merger or consolidation, recapitalization, reclassification, liquidation, dissolution, sale of substantially all assets or such similar transaction. If the by-laws of the Employer require the Plan to vote on an issue in a manner that reflects a one-man, one-vote philosophy, each participant or beneficiary shall be entitled to cast one vote on an issue and the Trustee shall vote the shares held by the Plan in proportion to the results of the votes cast on the issue by the participants and beneficiaries. If the participant does not exercise his or her right to vote Employer stock, the Trustee will vote such shares.

Participant Accounts

The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account is credited as of the last day of each Plan year with an allocation of (1) shares of the Employer's common stock (see Note 7) released by the Trustee from the unallocated account and (2) forfeitures of terminated participants' nonvested accounts. Only those participants who have completed at least 1,000 hours of service during the Plan year and are employed on the last day of the Plan year are eligible to share in the discretionary contribution for the year. Allocations are based on the ratio of a participant's eligible compensation to the total eligible compensation of all participants. Plan earnings, if any, are allocated to each participant's account based on the ratio of the participant's beginning of the year account balance to the total beginning of the year account balances of all participants.

At December 31, 2024, participant's accounts were credited as of the last day of the Plan year with an allocation of the participant's share of the Employer contribution receivable.

Put Option

Under Federal income tax regulations, Employer stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is the right for a participant to demand that the Employer redeem any shares of its stock distributed to the participant for which there is no market. The put price is representative of the fair market value of the stock. The Employer can pay for the purchase with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

Diversification

Participants who are at least age 55 with at least 10 years of participation in the Plan may elect to diversify a portion of their accounts into other investments. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may diversify up to 25% of his or her stock account balance, less any shares previously diversified. In the sixth year, the percentage changes to 50%. Participants who elect to diversify receive a cash distribution of the applicable amount.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (“GAAP”).

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Expenses

All expenses of maintaining the Plan are paid by the Employer.

Risks and Uncertainties

The Plan investments will consist primarily of the Employer’s common stock, which will be exposed to various risks such as interest rate, market and credit risks, as well as valuation assumptions based on earnings, cash flows and/or other such techniques. Due to the level of risk associated with the investment in the common stock and to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in the value of the common stock will occur in the near term and that such changes could materially affect the amounts reported in the Statement of Net Assets Available for Benefits.

Events Occurring After Report Date

The Plan Administrator has evaluated events and transactions that occurred between December 31, 2024 and October 15, 2025, the date the financial statements were available to be issued, for possible recognition or disclosure in the financial statements.

NOTE 3 - ADMINISTRATION OF PLAN ASSETS

Employer contributions are managed by the Trustee, which invests cash received from the Employer contributions and interest and dividend income and makes distributions to participants. The Trustee also administers the payment of principal and interest on future plan borrowings.

Certain administrative functions are performed by officers or employees of the Employer with no compensation from the Plan. Administrative expenses, including the Trustee's fees, may be paid out of the Plan unless paid by the Employer.

NOTE 4 - PLAN TAX STATUS

The Internal Revenue Service ("IRS") determined and informed the Plan Administrator by letter dated September 15, 2025, that the Plan and related trust was designed in accordance with the applicable requirements of the Code. The Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code and, therefore, believes that the Plan is qualified, and the related trust is exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the IRS.

NOTE 5 - PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under United States Department of Labor Regulations as any fiduciary of the Plan, any party rendering service to the Plan, the Employer and certain others.

Employer contributions are considered party-in-interest transactions. These transactions are exempt from the prohibited transaction provisions of ERISA and the Code.

NOTE 6 - PLAN TERMINATION

Although it has not expressed any intention to do so, the Employer reserves the right to terminate the Plan at any time, subject to the Plan provisions. Upon such termination of the Plan, the respective participant interests will be distributed to the participants or their beneficiaries at the time and in a manner prescribed by Plan terms and the Code.

NOTE 7 - SUBSEQUENT EVENTS

Effective January 3, 2025, the Plan Sponsor and Employer converted to an S Corporation and added BG Holdings, Inc. as the Benchmark Group, Inc. parent company.

On January 3, 2025, the Plan purchased 100% of the outstanding common stock (630,000 shares) of BG Holdings, Inc. for \$1,000,000 in a leveraged buyout. The transaction was financed by a \$1,000,000 term loan obtained from the Employer. The loan is payable in 30 equal installments of \$54,786.49, including principal and interest at 4.53% through December 15, 2054, and is secured by unallocated shares of BG Holdings, Inc's common stock. The note may be repaid in whole or in part without penalty. The borrowings are to be repaid by the Plan out of fully deductible contributions to the Plan by the Plan Sponsor. The Employer has authorized \$109,574 of Plan contributions as of December 31, 2024, which is recorded as a receivable on the Plan's financial statements. Payment of \$109,574 was received on February 21, 2025 and the Plan released shares from collateral and allocated the shares to participants in accordance with the allocation of the contribution receivable as of December 31, 2024.

After the February 21, 2025 payment, aggregate annual principal maturities of the term loan are scheduled as follows for Plan years ending December 31:
