## INDEPENDENT AUDITOR'S REPORT

**To the Board of Trustees and Administrative Committee  
of Pharma-Bio Serv PR, Inc. Retirement Plan  
Dorado, Puerto Rico**

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of **Pharma-Bio Serv PR, Inc. Retirement Plan**, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of **Pharma-Bio Serv PR, Inc. Retirement Plan's** financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### ***Opinion***

**1. DESCRIPTION OF THE PLAN**

The following description of the Pharma-Bio Serv PR, Inc. Retirement Plan ("the Plan"), provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**a. General**

The Plan, as amended, is a defined contribution plan covering all full-time employees of Pharma-Bio Serv PR, Inc. ("the Plan Sponsor" or "the Employer") who have completed one year of service and are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Trustees is responsible for oversight of the Plan. The Administrative Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Plan's Board of Trustees.

**b. Contributions**

Under Section 1108 of the Puerto Rico Internal Revenue Code of 2011, as amended, the deferred contribution was limited to \$15,000 in 2015, and thereafter. The code also allows the participants to invest up to \$5,000 in a qualified IRA account, without considering the contributions made to 401(k) plans. Participants who have attained age 50 before the end of the Plan year are eligible to make additional catch-up contributions of \$1,500, annually. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investments of their contributions into various investments options offered by the Plan. The Employer matches participants' savings contributions, on a discretionary basis. Additional amounts may be contributed at the option of the Plan Sponsor's Board of Directors, such as the profit-sharing contribution, as defined.

Employer's discretionary contributions match participant's contributions at the following rates based on years of service:

<u>Years of continuous service</u>	<u>Employer's match</u>
1 - 3 years	dollar-for-dollar up to 25%
4 - 6 years	dollar-for-dollar up to 50%
7 - 9 years	dollar-for-dollar up to 75%
10 or more years	dollar-for-dollar up to 100%

Effective November 25, 2024, the Plan Sponsor temporary suspended the discretionary employer matching contributions until further notice.

**c. Participant Accounts**

The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account is credited with the participant's contributions, employer matching contributions, as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**d. Vesting**

Participants are vested immediately on their contributions plus actual earnings thereon. Vesting in the Plan Sponsor's contribution portion of their accounts is based on years of continuous service.

A participant is entitled to a benefit equal to his vested accrued benefit payable at his normal retirement date based on the following schedule:

<u>Years of continuous service at date of termination *</u>	<u>Vested benefit</u>
Less than 3 years	0%
3 or more years	100%

\* A year of service is an eligibility computation period, in which a participant is credited with at least 1,000 hours of service within twelve (12) consecutive months.

However, vesting in the Employer's profit-sharing contribution portion of their accounts plus earnings thereon will vest after five years of continuous service.

**e. Payment of Benefits**

On termination of service due to death, disability, or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a single lump-sum payment or periodic installments. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

**1. DESCRIPTION OF THE PLAN (CONTINUED)**

**f. In-Service Distributions**

In-service distributions from pre-tax, matching and profit-sharing contributions, including earnings thereon, are only allowed in case of financial hardship that may include among other the following events: (a) major medical expenses of the participant or his spouse, or dependent that is not covered by insurance or otherwise; (b) purchase (excluding mortgage payments) of a principal residence for the participant; (c) payment of funeral expenses; (d) payment of tuition for the following twelve months of post-secondary education for the participant, spouse, or children or dependent; (e) payment of amounts necessary to prevent the eviction of the participant from his principal residence or foreclosure on the mortgage of the participant's principal residence; and (f) immediate and heavy financial need that generally would apply to all participants in a similar situation.

**g. Forfeiture Accounts**

Upon a participant's termination from the Plan Sponsor or withdrawal from the Plan for any reason other than death, retirement or disability, the employer contributions on behalf of the participants not then vested are forfeited and first applied to reduce the Plan's administrative expenses and then to reduce employer matching or profit-sharing contributions. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$6,442 and \$6,352, respectively. No forfeitures were used to reduce Plan expenses or employer contributions during 2024 or 2023.

**h. Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate is set at 1 percent above the prime rate when the loan is made. Principal and interest are paid ratably through monthly payroll deductions.

**2. SUMMARY OF ACCOUNTING POLICIES**

**Basis of Presentation**

The Plan's fiscal year ends on December 31st. All references to years in these notes to financial statements represent calendar years unless otherwise stated.

**Basis of Accounting**

The accompanying financial statements have been prepared following the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Administrative Committee determines the Plan's valuation policies utilizing information provided by the investments advisers, custodians, and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividends date, while interest income is recorded when earned. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

**2. SUMMARY OF ACCOUNTING POLICIES (CONTINUED)**

**Excess Contributions Payable**

In order to comply with the non-discrimination requirements of the Puerto Rico Internal Revenue Code (PRIRC), the Plan is required to perform tests to ensure that contributions made on behalf of highly compensated employees (HCEs) do not disproportionately exceed those of non-highly compensated employees (NHCEs). When test failures occur, the Plan may take corrective actions such as (i) returning excess contributions to certain highly compensated employees, (ii) allocating a qualified non-elective employer contribution (QNEC) to non-highly compensated employees, or (iii) recharacterizing excess contributions as after-tax contributions.

As of December 31, 2024 and 2023, the Plan recorded liabilities of \$54,822 and \$42,589, respectively, with corresponding reductions in contributions. These amounts represent corrective distributions pending at year-end to maintain compliance with applicable PRIRC nondiscrimination requirements.

**Payment of Benefits**

Benefits are recorded when paid.

**Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Plan Sponsor. Expenses that are paid by the Plan Sponsor are excluded from these financial statements. Investments related expenses are included in net appreciation of fair value of investments.

**Subsequent Events**

The Plan has evaluated subsequent events through October 15, 2025, the date the financial statements were available to be issued. As of such date, there were no significant subsequent events that would require disclosure or adjustment to the financial statements.

**3. CERTIFIED INVESTMENTS**

Certain information in the accompanying financial statements and ERISA-required supplemental schedule, related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Retirement, LLC, a qualified institution.

**4. FAIR VALUE MEASUREMENTS (UNAUDITED)**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- **Mutual Funds:** Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
- **Collective Trust Fund:** Valued at the net asset value of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient would not be used if it were determined that it is probable the fund would sell its investment for an amount significantly different from the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan were to initiate a full redemption of its interest in the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**5. FULLY BENEFIT-RESPONSIVE CONTRACT**

During 2019, the Plan entered into a group annuity contract with Great-West Life & Annuity Insurance Company ("Great-West") that invests contributions in the Key Guaranteed Portfolio Fund. This investment choice is not guaranteed by the Federal Deposit Insurance Corporation (FDIC) or any other government agency. Because the Key Guaranteed Portfolio Fund is a general account product offered through a group annuity contract, participant principal and interest are fully guaranteed by the entire general account assets of Great-West. The crediting interest rate is based on a formula agreed upon with the insurance company. Such interest rates are reviewed on a quarterly basis for resetting. The crediting rate of the product will be established based on the earnings of the underlying assets in the entire medium-long term portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. The average yield earned by the Plan for the benefit responsive fund can be derived by averaging the quarterly gross interest rates for the fund over the year. The average was 1.41% and 1.23%, for 2024 and 2023, respectively. The actual average yield earned by the Plan for the benefit responsive fund is derived by averaging the Plan's quarterly interest rates. The contract meets the fully benefit-responsive investment contract criteria and therefore, is reported at contract value.

Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses.

**5. FULLY BENEFIT-RESPONSIVE CONTRACT (CONTINUED)**

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from Puerto Rico income taxes or any required prohibited transaction exemption under ERISA or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the participants.

**6. RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS**

Notes receivable from participants represent receivables from officers and employees of the Plan Sponsor, including the Plan Administrator. Under ERISA rules, these transactions are not prohibited, and they qualify as exempt party-in-interest transactions. See Notes 1 and 2 for additional information regarding notes receivable from participants.

**7. TAX STATUS**

The Plan was adopted incorporating the required provisions of the PRIRC of 2011, as amended, which complies with the provisions of the Puerto Rico Treasury Department's Circular Letters no. 11-10 and 13-02. On April 10, 2014, the Plan filed a request for a favorable Determination Letter regarding the qualified status of the Plan under PRIRC of 2011 and received a letter from the Puerto Rico Treasury Department which indicates that the Department has no objection to the amendments made to the Plan and that such amendments will not affect in any way the ruling issued on behalf of the Plan on June 26, 2007. In addition, to maintain the tax-exempt status, the Plan must comply with certain Minimum Coverage and Nondiscrimination tests. The Plan complied with said test requirements as of December 31, 2024 and 2023, after using the available correction methods.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon a tax examination by the Puerto Rico Treasury Department. The Plan Administrator has evaluated the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress.

**8. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

**9. RISK AND UNCERTAINTIES**

The Plan invests in various investment securities, including mutual funds within various markets. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
