Basis for Opinion

NOTE 1 – DESCRIPTION OF THE PLAN

The following description of the Dhillon Healthcare Group 401(k) Profit Sharing Plan & Trust (the Plan), provides only general information. Participants should refer to the plan agreement for a more complete description of the plan's provisions.

General: The Plan is a defined-contribution plan covering all eligible employees of Dhillon Healthcare Group, Seva Hospice, Inc., CareOne Home Health & Hospice, St. Francis Assisted Care Inc., Seva Home Health, Legacy Home Care Services, and Angel Love Hospice Services, Inc. (collectively the Companies), who are age 18 or older and have two months of service. Employees may enter the Plan on the first day of each month, following the satisfaction of eligibility requirements. The Plan was adopted July 1, 2013, and was amended October 1, 2022. The Plan is subject to the provisions of the Employee Retirement Income Security Act (ERISA).

Contributions: Each year participants may contribute up to the annual federal tax law limit of annual compensation, as defined in the Plan. Participants may elect to make both pre-tax deferrals and Roth 401(k) deferral contributions. Those who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined-benefit or defined-contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Companies provide each employee a safe harbor matching contribution of 100% of the participant's salary deferrals up to 4% of the participant's compensation. Eligible participants who have been working at least six months and make elective deferrals are able to receive the safe harbor matching contribution. Safe harbor matching contributions were \$523,256 during the year ended December 31, 2024.

Additional profit-sharing amounts may be contributed at the Companies' discretion. All participants with one year of service qualify to participate. The Companies did not make profit sharing contributions during the year ended December 31, 2024.

Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant accounts: All of the plan's assets are invested, as directed by the participant, in registered investment companies and common collective trusts. Each participant's account is credited with the participant's contribution and allocations of: (a) the Companies' contributions and, (b) plan earnings, and charged with an allocation of the administrative expenses. Allocations are based on participant account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are vested immediately in their contributions and the Companies' safe harbor matching contributions plus actual earnings thereon. Vesting in the Companies' profit-sharing contribution is based on years of continuous service. A participant is 100% vested after six years of credited service.

Notes receivable from participants: Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or the greater of 50% of their vested account balance or \$1,000. Loan terms range from one to five years; however, terms may exceed four and a half years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear a reasonable rate of interest, which is the prime rate plus 1%. Principal and interest is paid ratably through payroll deductions.

NOTE 1 – DESCRIPTION OF THE PLAN (CONTINUED)

Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the plan document.

Payment of benefits: On termination of service, the participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in their account or directly roll over the balance to an Individual Retirement Account (IRA) or other eligible plan. However, if a participant's vested balance is less than \$5,000, and they do not elect to directly roll over the balance to an eligible retirement plan, the account will be automatically paid to the participant in a lump-sum payment or as a direct rollover to an IRA.

Forfeited accounts: There were no forfeited non-vested accounts at December 31, 2024 or 2023. Forfeited account balances are used to cover administrative expenses, to restore forfeited account balances of rehires who are eligible for a restoration of forfeitures, and/or to reduce future employer contributions. \$11 in forfeitures were used for the year ended December 31, 2023. No forfeitures were used for the year ended December 31, 2024.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The summary of significant accounting policies of the Plan is presented to assist in understanding the Plan's financial statements and supplemental schedules. The financial statements, notes, and supplemental schedules are representations of the plan's management who is responsible for their integrity and objectivity. These accounting policies conform to generally accepted accounting principles and have been consistently applied in the preparation of the financial statements and supplemental schedules.

Basis of accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of estimates: The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and investment income recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Quoted market prices are used to value investments. The Plan's Trustees determine the Plan's valuation policies utilizing information provided by the investment advisers and the custodian.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance which approximates fair value. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Expenses: Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Companies. Expenses that are paid by the Companies are excluded from these financial statements. Investment related expenses are included in net appreciation in fair value of investments.

NOTE 4 – FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB), Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include: (a) quoted prices for similar assets or liabilities in active markets; (b) quoted prices for identical or similar assets or liabilities in inactive markets; (c) inputs other than quoted prices that are observable for the asset or liability; (d) inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered investment companies (mutual funds): Valued at the daily closing price as reported by the fund. These funds are required to publish their daily Net Asset Value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded.

NOTE 4 – FAIR VALUE MEASUREMENTS (CONTINUED)

Common collective trusts: Valued at net asset value as reported by the common collective trust. The net asset value is not a publicly quoted price in an active market, but it is made available to current investors by way of the employer portal on Ascensus Trust Company’s (the recordkeeper) website. All redemptions of the common collective trust investments are measured at the net asset value on the date of the redemption.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective value or reflective of future fair values. Furthermore, although the plan administrator believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 – RELATED-PARTY AND PARTIES-IN-INTEREST TRANSACTIONS

Certain plan investments are registered investment companies managed by Ascensus Trust Company, the custodian of the Plan, and, therefore, these transactions qualify as party-in-interest transactions. Certain administrative services were paid for by the Plan. Direct fees paid by the Plan for contract administration, fiduciary services, and compliance reporting services totaled \$29,441 for the year ended December 31, 2024.

NOTE 6 – PLAN TERMINATION

Although they have not expressed intent to do so, the Companies have the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

NOTE 7 – TAX STATUS

On June 30, 2020, the IRS stated that the prototype adopted by the Plan, as then designed, qualifies under Internal Revenue Code (IRC) section 401(a). The Plan has not received a determination letter specific to the Plan itself; however, the plan administrator and the plan's tax counsel believe that the Plan was designed and is being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken a significant uncertain position that more likely than not would be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 9 – SUBSEQUENT EVENTS

The plan sponsor evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of events that affect the financial statements. Subsequent events have been evaluated through October 14, 2025, the date the financial statements were available to be issued.
