## REPORT OF INDEPENDENT AUDITORS

To the Plan Administrator of  
Highgate Hotels Puerto Rico Retirement Plan  
(formerly Highgate Hotels 1081.01(d) Plan)

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Highgate Hotels Puerto Rico Retirement Plan (formerly Highgate Hotels 1081.01(d) Plan) (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year then ended December 31, 2024, and the related notes to the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

### **1. Description of Plan**

The following description of the Highgate Hotels Puerto Rico Retirement Plan (formerly Highgate Hotels 1081.01(d) Plan) (the Plan) provides only general information. Participants should refer to the Summary of the Plan Description for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution profit sharing plan covering all full-time employees of Highgate Hotels LLC (the Plan Sponsor, the Company, or the Employer) who have completed six consecutive months of service and are age 18 years or older. The original effective date of the Plan was August 1, 2018. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### Plan Administration

Effective February 1, 2020, the plan's Trustee appointed Oriental Bank as non-discretionary directed trustee for purposes of ERISA section 403(a)(1), and will have no discretionary control over, nor any other discretion regarding the investment or reinvestment of the Trust assets.

The recordkeeper and custodian of assets was John Hancock Retirement Plan Services LLC until March 15, 2020, when John Hancock made the decision to leave the Puerto Rico retirement plan market. The Plan Sponsor contracted Massachusetts Mutual Life Insurance Company to be the new recordkeeper and custodian of assets.

On January 1, 2021, Great-West Life & Annuity Insurance Company (Empower Retirement LLC) became the recordkeeper and custodian after the acquisition of the retirement business of Massachusetts Mutual Life Insurance Company.

On August 1, 2024, the Company moved the plan assets to Principal Trust Company and became the new recordkeeper and custodian. On the same date the Company made several amendments including the name of the plan. The amendments have been included in the notes to financial statements.

#### Contributions

A participant may contribute not less than 1% of pre-tax annual compensation as defined in the Plan and shall not exceed the pre-tax contribution limit allowed under Puerto Rico Internal Revenue Code section 1081.01(d) (\$15,000). Participants who have attained age 50 or over are eligible to make catch-up contributions up to \$1,500 per Plan Year. Participants direct the investment of their total contributions into various investments options offered by the Plan.

The employer will make matching pre-tax contributions equal to \$0.25 for each dollar of pre-tax contributions made to the plan by an eligible employee up to the first 4% of his/her compensation contributed to the plan throughout the Plan year.

#### Rollover Contributions

Participants may rollover their funds previously held for their account in another employee benefit plan on a tax-free basis.

#### Participants accounts

Each participant's account is credited with the participant's and Company contributions and a pro-rata allocation of the Plan's earnings, net of administrative expenses. The pro-rata allocation is based upon the proportion of individual account balances to total participants' accounts balances in the respective investment funds. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Vesting

Participants become immediately vested at the time of participation in the Plan in their contributions and/or after-tax contributions and actual earnings thereon. Also on qualified matching and/or qualified non-elective contributions and earnings thereon, made by the Plan Sponsor.

Vesting in the Plan Sponsor's profit-sharing contributions portion of their accounts plus actual earnings thereon is based on years of continuous service as follows:

Notes Receivable from Participants

Active employees who participate in the Plan may request loans from their fully vested accounts. The minimum loan amount that a participant may request is \$1,000. The maximum loan amount that a participant may request is \$50,000 or 50% of the vested account balance, whichever is less. The notes are secured by the balance in the participant's account and bear an interest rate of 1% over the prevailing prime rate. As of December 31, 2024, the notes receivable had an interest rate which range from 5.00% through 9.50%. Participants loan installments of principal and interest are paid ratably through monthly payroll deductions.

Payment of Benefits

Upon a participant's retirement, death, total and permanent disability, other termination of employment with the Company, or termination of the Plan, the participant's account is distributed in the form of a lump sum distribution equal to the value of the participant's vested interest in his/her account or monthly, quarterly, semiannual or annual installments over a period of years certain.

In conditions of "financial hardship", a participant may apply to the Plan administrator for approval to withdraw that portion of his retirement account balance necessary to meet the financial hardship, subject to the limitations of the Plan and the Internal Revenue Code.

Upon termination of the Plan, the assets will be distributed to participants in accordance with the Plan's provisions and existing laws and regulations.

Forfeited Accounts

When certain terminations of participation in the Plan occur, the nonvested portion of the participant's account, as defined by the Plan, represents a forfeiture. The balance on these accounts will be used by the Plan's Sponsor to reduce future employer profit sharing and matching contributions or plan administrative expenses. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$2,459 and \$867, respectively. The available funds have not been used in 2024 and 2023.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in the Company contributions of their account.

**2. Summary of Significant Accounting Policies**

**Basis of Presentation**

The accompanying financial statements of Highgate Hotels Puerto Rico Retirement Plan (formerly Highgate Hotels 1081.01(d) Plan) have been prepared on the accrual basis and have been prepared in conformity with accounting principles generally accepted in the United States of America (“GAAP”).

**Investments Valuation and Income Recognition**

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair Value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

The Plan’s fully benefit-responsive investment contracts are reported at contract value. Contract value represents contributions made under the contract, plus interest at the contract rate, less withdrawals and funds used to pay administrative expenses. Interest income is recorded on an accrual basis.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

**Use of Estimates**

The preparation of financial statements in conformity with United States generally accepted accounting principles requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Benefit Payments**

Benefit payments are recorded when paid. Benefit payments are recorded when paid. For the year ended on December 31, 2024 the benefits paid amounted to \$75,081.

**Administrative Expenses**

The Company provides certain administrative and accounting services to the Plan at no cost. Administrative expenses including audit fees and legal fees are paid directly by the Company. Other administrative expenses directly incurred by the Plan include investment management and distributions fees charged directly to the participant’s accounts. These administrative expenses are presented as a deduction to net assets on the Statement of Changes in net Assets Available for Benefits.

**Risk and Uncertainties**

The Plan provides for various investment options that are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the Statements of Net Assets Available for Benefits and the Statements of Changes in Net Assets Available for Benefits.

**3. Fair Value Measurements**

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits.

Financial Accounting Standard Board (FASB) established the Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, which provides a framework for defining and measuring fair value under generally accepted accounting principles. This codification establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs have the lowest priority.

The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. In some cases where market prices are not available, observable market-based inputs are used to calculate fair value, in which case the measurements are classified within Level 2. If quoted or observable market prices are not available, fair value is based upon internally developed models that use, where possible, current market-based parameters such as interest rates, yield curves and currency rates. These measurements are classified within Level 3.

As of December 31, 2024, the following methods and assumptions were used to determine the fair value of investments recorded at fair value in the statements of net assets available for benefits:

Mutual Funds

Valued at quoted market prices, which represent net asset value ("NAV") of shares held by the Plan at year end. The mutual funds held by the Plan are deemed to be actively traded.

Collective Investments Trust

Valued at the net asset value ("NAV") of the units of the investment fund's trustee. Participants are allocated units of the collective trust funds, not specific securities. The net asset value, as provided by the fund houses or investment provider, is used as a practical expedient to estimate fair value. The net asset value is based on the fair value of the underlying investments held by the fund less its liabilities. The practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. There are no restrictions as to the redemption of these investments, nor does the Plan have any contractual obligations to further invest in any of these collective trust funds.

\*In accordance with FASB guidance the collective trusts have not been classified in the fair value hierarchy as they are measured at fair value using NAV as a practical expedient. As of December 31, 2023, the assets of the Plan were under a group annuity contracts which invests its assets in a Variables Annuities (Annuities). The Annuities' principal is not guaranteed. Contract holders are allocated units of the annuity contract, not specific securities. The value of the Annuities units is the net fair value of the underlying assets on the last day of the Plan's reporting period. The fair market value of the securities in the Annuities includes reinvested dividend and interest income (received and accrued) realized gains and losses, and unrealized gains and losses on a valuation date minus any outside custodial service provider fee of the underlying assets. The underlying investments' performance (interest, dividends, and realized and unrealized gains and losses) is reflected in the unit value. The Annuities Fair Value of each annuity contract is determined by computing the value of the total assets held in such annuity contract and deducting total liabilities, including accrued liabilities, similar to a mutual fund NAV calculation.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values.

Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

In accordance with FASB guidance the Annuities have not been classified in the fair value hierarchy as they are measured at fair value using NAV as a practical expedient.

**4. General Account Fixed Annuity Contract**

As of December 31, 2023, the Plan had a general account fixed annuity contract with MassMutual Life Insurance Co. that invests contributions in a guaranteed contract with fixed annuity options (the Contract). The Contract is a stable value investment with a guaranteed rate of return and a guaranteed principal that is backed by MassMutual Life Insurance Co. general investment account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses.

Contract value is the relevant measurement attributed to that portion of the net assets available for benefits attributable to the contract which was determined to be fully benefit responsive. The contract is presented on the face of the statement of net assets available for benefits at contract value. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses.

**4. General Account Fixed Annuity Contract (continued)**

The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 1 percent. Such interest rates are reviewed on a semi-annual basis for resetting.

Participants may ordinarily direct the withdrawal and/or transfer of all or a portion of their account balance at contract value. The Contract issuer is contractually obligated to repay the principal, and a specified interest rate guaranteed to the Plan.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following:

- a) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan),
- b) removal from the plan one or more groups or classifications of participants,
- c) partial or complete plan termination,
- d) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan or
- e) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA.

The Plan Administrator does not believe the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, are probable of occurring.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include:

1. Puerto Rico Department of Treasury determines that the Plan no longer meets the requirements of Code section 1081.01(a) or any other applicable Code provision
2. a breach of material obligation under the contract
3. a termination or partial termination of the Plan
4. a material amendment to the agreement without the consent of the issuer

Investment income earned from these instruments as of December 31, 2024 and 2023 were as follows; net appreciation (depreciation) in fair value of investments, \$250,862 in 2024 and \$275,505 in 2023 and interest and dividends of \$64,364 in 2024 and \$107 in 2023. Interest income from notes receivable from participants were of \$9,720 in 2024 and \$3,522 in 2023.

**6. Tax Status**

On September 21, 2018, the Plan Administrator received the determination letter approving the participation on the new prototype retirement plan and establishing that the established new Trust is exempt under Section 1081.01 of Puerto Rico Internal Revenue Code of 2011. On February 20, 2020, the Plan was amended to change the Trustee.

Accounting principles generally accepted in the United States of America requires to the management of the Plan to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Puerto Rico Treasury Department.

The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

**7. Related-Party Transactions and Party in Interest Transactions**

As of December 31, 2023, the Plan had a general account fixed annuity contract with Great-West Life and Annuity Insurance Company. Great-West and its subsidiaries provide administration, custodial and recordkeeping services. These specific investments are issued and managed by Great-West Life and Annuity Insurance Company and qualified as party-in-interest transactions. On December 31, 2020, Great-West acquired the retirement business of Massachusetts Mutual Life Insurance Company (MassMutual), the Plan used insurance products of MassMutual and also qualified as a party-in interest.

Several employees of the Company provide administrative services to the Plan. These services include Plan oversight and day-to-day Plan administration. The Plan is not charged by the Company for these services of the employees to the Plan.

**8. Subsequent Events**

Subsequent events were evaluated through October 15, 2025, which is the date of the financial statements were available to be issued. No events have occurred subsequent to the balance sheet date, and the date the financial statements were available to be issued that would require additional adjustment, to or disclosure in the financial statements.

**9. Non-exempt Transactions**

As required by ERISA Section 2510.3-102, the Company is required to segregate employee contributions to the Plan from its general assets as soon as practicable but in no event more than 15 business days following the end of the month in which amounts are withheld from wages. During the years 2024, and 2023, the Company did not remit employee contributions as soon as they are able to remit the contributions to the custodian. The Company is able to remit five days after payroll payment and they remit in an average of 4 to 165 days. Total participant contributions considered late amount to \$102,717 in 2024, \$66,968 in 2023, and \$119,799 in 2023.
