### 1. Description of Plan

The following description of the Los Angeles Truck Centers, LLC 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### *General*

The Plan is a defined contribution plan covering eligible employees of Los Angeles Truck Centers, LLC (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Company is the Plan's sponsor and an employee of the Company serves as Plan Administrator.

#### *Trustee and Administration of the Plan*

The trustee and recordkeeper of the Plan are State Street Bank and Trust Company (State Street or the Trustee) and Transamerica Retirement Solutions, LLC. and Reliance Trust Company (collectively, Transamerica). Transamerica has been appointed by State Street to execute certain transactions on its behalf. The administrator of the Plan is the Company. The trustee holds all assets of the Plan in accordance with the service provider contract with the Company. The Investment Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

#### *Eligibility*

Employees are eligible to make elective deferrals upon reaching the age of 18 and after completing three months of service, except for union employees (unless participation in this Plan covered by a collective bargaining agreement), leased employees and employees of any controlled group employer that does not affirmatively adopt this Plan. Employees may enter the Plan on January 1, April 1, July 1, and October 1, after eligibility requirements are met.

#### *Contributions*

Participants can elect to make tax-deferred contributions and/or Roth after-tax contributions to the Plan, subject to certain Internal Revenue Code (IRC) limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions up to the IRC maximum. Participants may also contribute amounts representing distributions from other qualified plans, which are reflected as rollover contributions in the statement of changes in net assets available for benefits. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan includes an auto-enrollment provision whereby all newly eligible participants are automatically enrolled in the Plan, unless they affirmatively elect not to participate. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in designated balanced funds until changed by the participant. The automatic deferral rate increases 1% up to a maximum of 6% on the first day of each Plan year unless the participant elects a different deferral rate.

The Plan provides for an employer matching contribution, in which the Company will match 35% of a participant's elective deferral, up to 6% of the participant's eligible compensation.

### ***Participant Accounts***

Each participant's account is credited with the participant's contributions as well as allocations of the Company's matching contributions, if any, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan, as applicable. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### ***Plan Merger***

Effective August 23, 2024, The Velocity SBA, LLC 401(k) Plan merged into the Plan. In connection with the plan merger, The Velocity SBA, LLC assets of \$1,766,802 were transferred into the Plan in August 2024. Such amounts are included in Transfer of Assets from Other Qualified Plan in the statement of changes in net assets available for benefits.

### ***Vesting***

Participant contributions and related net earnings are fully vested at all times. Company contributions and related net earnings vest at a rate of 20% per year of service and are fully vested after five years of service. Upon retirement, disability or death, account balances become 100% vested. If a participant's employment terminates before full vesting of the Company's contributions and related earnings is attained, the remaining non-vested balances are forfeited and will be used to pay Plan administrative expenses and reduce future Company contributions.

### ***Payment of Benefits***

On termination of service, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in their account. The Plan permits in-service withdrawals if the participant has attained the age of 59½, and hardship distributions are permitted if a participant meets certain criteria, as defined in the Plan document.

If, upon termination of employment, the value of the vested portion of a participant's account is \$5,000 or less, it will automatically be distributed as soon as administratively feasible. For participants with account balances in excess of \$5,000, no distribution will occur until participant consent is obtained.

### ***Forfeitures***

Forfeitures from non-vested terminated participant accounts are used to pay administrative expenses or reduce employer contributions. During the year ended December 31, 2024, \$220,545, was used to reduce the Company's contributions. As of December 31, 2024 and 2023, the balance of forfeited non-vested accounts were \$258,079 and \$202,932, respectively.

### ***Notes Receivable from Participants***

Participants may borrow from their fund accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance (Notes). The Notes are secured by the balance in the participant's account and bear a reasonable rate of interest (prime rate plus 2%). The maximum number of Notes outstanding at any one time is one. Notes must be repaid within

five years, unless such loan is for the purchase of a participant's primary residence, in which case the repayment period shall be no more than 15 years. As of December 31, 2024, the Notes outstanding had interest rates ranging from 4.25% to 10.50%, maturing on various dates through December 2039. Principal and interest are paid ratably through payroll deductions.

## 2. Summary of Accounting Policies

### *Basis of Accounting*

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

### *Use of Estimates*

The preparation of financial statements in accordance with GAAP requires that management make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Actual results could materially differ from those estimates.

### *Investment Valuation and Income Recognition*

The Plan's Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's valuation policies utilize information provided by State Street, the trustee which holds the assets, and Transamerica, which has been appointed by State Street to execute certain transactions on its behalf. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### *Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid, interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. There were \$1,406 in deemed distributions for the year ended December 31, 2024.

Management determines the collectability of notes receivable from participants on a periodic basis. This determination is made based on the terms of the Plan document and the related Plan policies and procedures. If notes receivable from participants are deemed to be uncollectible, they are written off and included as benefits paid to participants in the financial statements and deemed distributions in the Form 5500 for financial reporting purposes in the year the determination is made. Amounts recovered on notes receivable from participants previously deemed uncollectible are reported as a reduction of benefits paid to participants in the financial statements and the Form 5500 for financial reporting purposes in the year the recovery is made.

### *Payment of Benefits*

Benefits are recorded when paid.

### *Administrative Expenses*

Certain expenses of maintaining the Plan such as investment advisory fees are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to participant-initiated transactions, such as distribution and loan processing fees, are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation or depreciation in fair value of investments. Administrative expenses paid by the Plan totaled \$362,777 for the year ended December 31, 2024.

### **3. Certified Investment Information**

Certain information disclosed in the accompanying financial statements and Schedule H, Line 4i - Schedule of Assets (Held at End of Year), related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company and State Street Bank and Trust Company, qualified institutions.

### **4. Fair Value Measurements**

Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board (FASB) ASC 820 are described as follows:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodologies used as of December 31, 2024 and 2023. The following is a description of the valuation methodologies used for investments measured at fair value.

*Interest-Bearing Cash* - These investments are valued at fair value based on quoted market prices.

*Mutual Funds* - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Stable Value Fund* - The Plan invests in a stable value fund held within a common collective trust that is composed of fully benefit-responsive investment contracts and is valued at the NAV. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund, less its liabilities. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Generally, there are no restrictions on a participant's ability to redeem their investment in the stable value fund at the investment's NAV, with no advance notice. However, withdrawals prompted by certain events (e.g., termination of the stable value fund, changes in laws or regulations) may restrict a participant's ability to redeem the investment at its NAV. At December 31, 2024 and 2023, the Plan had no unfunded commitments related to this investment. This investment is a direct filing entity.

The valuation methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

## 5. Related Party and Parties-in-Interest Transactions

State Street and Transamerica are parties-in-interest as defined by ERISA. Plan investments are managed by a division of Transamerica on behalf of State Street, and therefore, these transactions qualify as party-in-interest transactions. Notes receivable from participants also reflect party-in-interest transactions. These transactions are exempt from prohibited transaction rules.

For the year ended December 31, 2024, administrative expenses of \$312,964, was paid by the Plan to Transamerica Retirement Solutions, LLC, a division of Transamerica Life Insurance Company, for recordkeeping services and \$50,000, was paid to the Plan's investment advisor, Sage View Advisory Group, LLC. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan for these services.

## 6. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment

securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

### **7. Plan Termination**

Although it has not expressed any intent to do so, the Company reserves the right to discontinue its contributions and terminate the Plan at any time subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

### **8. Tax Status**

Effective April 1, 2021, the Plan was amended and restated to, among other things, incorporate prior Plan amendments and reflect statutory changes to the IRC. The Plan adopted Transamerica Retirement Solutions LLC pre-approved defined contribution plan which received a favorable opinion letter from the IRS dated June 30, 2020. Although the Plan has been amended since the date of the opinion letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and continues to qualify for tax-exempt status.

GAAP requires the Plan Administrator to evaluate uncertain tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **9. Delinquent Participant Contributions**

During the Plan year ended December 31, 2023, participant contributions and loan repayments totaling \$750,883 were not remitted to the Plan within the period prescribed by DOL regulations. During the Plan year ended December 31, 2022 and 2021, participant contributions and loan repayments totaling \$4,680,631 and 400,082 were not remitted to the Plan within the period prescribed by DOL regulations. These transactions constitute non-exempt party-in-interest transactions or prohibited transactions as defined by ERISA. The related lost earnings were remitted to the Plan as of March 12, 2025.

### **10. Subsequent Events**

Management has evaluated subsequent events through October 15, 2025, the date the Plan financial statements were available to be issued, for potential recognition or disclosure in these Plan financial statements.
