### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Green Valley Corporation 401(k) Profit Sharing Plan and Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

**NOTE 1 - DESCRIPTION OF PLAN**

The following description of the Green Valley Corporation (“Company”) (“Plan Sponsor”) 401(k) Profit Sharing Plan and Trust (“Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General - The Plan is a defined contribution plan established to provide eligible employees of the Company with retirement, death and disability benefits. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan changed its reporting yearend from May 31 to December 31.

Participant Eligibility, Contributions and Vesting - All employees are eligible to participate in the Plan providing they are at least 21 years of age and complete 1,000 hours of service from the date of hire, except the following classes: (a) independent contractors, (b) nonresident aliens who receive no compensation from the employer which constitutes U.S. source income, (c) collectively bargained employees, if the collective bargaining agreement does not provide for participation by such employees of the Plan, (d) leased employees, and (e) employees of related employers. Participants may begin deferring up to 100% of their compensation into the Plan upon meeting eligibility requirements. Effective January 1, 2024, the Plan allows participants to designate contributions as Roth contributions. Contributions to the Plan are limited to the maximum amount allowable under the provisions of the Internal Revenue Code (IRC). Effective June 1, 2024, the Plan Sponsor amended their plan document to remove the 1,000 hours of service eligibility requirement.

Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers twenty-one investment options to Plan participants. The Company contributes to the Plan an amount of matching contributions equal to 100% of each participant’s “eligible contribution” that does not exceed \$1,000 plus 50% on the next \$4,000 of “eligible contribution” for a maximum matching of \$3,000. A participant’s “eligible contribution” is an amount equal to the participant’s elective deferral for the plan year. Additional profit sharing amounts may be contributed at the option of the Company’s board of directors. These employer discretionary profit sharing contributions are invested on the participant's behalf in their self-directed accounts by the Trustee of the Plan.

Participants are immediately vested in their deferral contributions and qualified matching contributions plus actual earnings thereon. The employer’s contributions and earnings shall vest in accordance with the following schedule:

Participant Eligibility, Contributions and Vesting (Continued) - As of December 31, 2024 and May 31, 2024, forfeited nonvested accounts totaled \$114,678 and \$27,556 respectively. For the seven months ended December 31, 2024, \$20,000 and \$7,556 of forfeitures were used for the May 31, 2024 employer contribution and plan expenses, respectively. Subsequent to year end, \$100,519 of forfeitures were used for the December 31, 2024 employer contribution.

Investment Options - Participants exercise control over the types of investments made on their behalf, provided that such accounts are invested in investment funds designated by the Plan. Participants may invest in any one or more investment funds and change their investment options at any time.

Payment of Benefits - On termination of service due to death, disability or retirement, the form of the distribution depends on the amount of the participant's vested account. If the vested account balance is less than \$1,000, the Plan will distribute the vested interest of the account in a lump sum. If the vested account balance exceeds \$1,000, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in (a) a lump sum amount or (b) in annual, monthly, or quarterly installments.

Participant Accounts - Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution, (b) Plan earnings, and (c) forfeitures of terminated participants' non-vested accounts and charged with an allocation of administrative expenses. Allocations are based on participant compensation or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Administration - The Plan Sponsor is the plan administrator and has engaged the services of Northwest Plan Service, Inc. (NWPS), as a Third Party Administrator to handle daily administration of the Plan. The Plan's participant-directed assets are managed by Charles Schwab Trust Bank (Charles Schwab), the custodian of the Plan. The custodian, appointed by the Plan Sponsor, executes investment transactions and holds Plan investment assets. The plan administrator reviews the performance of the various available investments and makes decisions on the addition or deletion of an investment fund.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting - The accompanying financial statements have been prepared on the accrual basis of accounting and in accordance with accounting principles generally accepted in the United States of America. Contributions from participants are recorded when withheld. Benefit payments and expenses are recorded when paid.

Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties - The Plan provides for various investment securities. These securities are exposed to various risks such as interest rate, market fluctuations and credit risks. Further, due to the level of risk associated with these securities and the level of uncertainty related to changes in the values of investment securities, it is possible that changes in the various risk factors in the near term would materially affect the participants' account balances and the amounts reported in the accompanying financial statements.

The Plan often maintains cash deposits in commercial banks in excess of federally insured limits.

Valuation of Investments - Investments in interest-bearing cash and mutual funds are stated at fair value. Purchases and sales of investments are recorded on a trade-date basis. Net change in value of investments consists of the change in unrealized appreciation or depreciation during the year and the realized gain or loss of sold investments during the year. Acquisition costs are included in the cost of investments and sales are recorded net of selling expenses.

Administrative Expenses - The Plan permits the payment of administrative expenses to be made from the Plan's assets and for them to be allocated either proportionately based on the value of the account balances or as an equal dollar amount based on the number of participants in the Plan. However, substantially all administrative expenses of the Plan are paid by the Plan Sponsor. Expenses relating to specific participant transactions such as distribution requests are paid by the requesting participant.

Subsequent Events - Subsequent events were evaluated through October 14, 2025, the date the financial statements were available to be issued.

**NOTE 3 - CERTIFIED INFORMATION**

In accordance with 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, information certified by Schwab Trust regarding the current value of assets held as of December 31, 2024 and May 31, 2024, and transactions entered into during the seven months Plan short year were used in the preparation of the accompanying financial statements and supplemental schedules. **NOTE 4 - FAIR VALUE MEASUREMENTS**

Generally accepted accounting principles establish a hierarchy to prioritize the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest ranking to fair values determined using unadjusted quoted prices in active markets for identical assets (Level 1) and the lowest ranking to fair values determined using methodologies and models with unobservable inputs (Level 3). Observable inputs are those that market participants would use in pricing the assets based on market data obtained from sources independent of the Plan. Unobservable inputs reflect the Plan's assumption about the inputs market participants would use in pricing the asset or liability developed based on the best information available in the circumstances.

The fair value hierarchy is categorized into three levels based on the inputs as follows:

Level 1 - Values are unadjusted quoted prices for identical assets or liabilities in active markets accessible at the measurement date.

Level 2 - Inputs included in quoted prices for similar assets or liabilities in active markets, quoted prices from those willing to trade in markets that are not active, or other inputs that are observable or can be corroborated by market data for the term of the instrument. Such inputs include market interest rates and volatilities, spreads and yield curves.

Level 3 - Certain inputs are unobservable (supported by little or no market activity) and significant to the fair value measurement. Unobservable inputs reflect the Plan's best estimate of what hypothetical market participants would use to determine a transaction price for the asset or liability at the reporting date.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value at December 31, 2024 and May 31, 2024.

*Interest-bearing cash:* Valued at the closing price at year end.

*Mutual funds:* Valued at the net asset value (NAV) of shares held by the plan at year end.

**NOTE 5 - TAX STATUS**

The Plan adopted a 401(k) profit sharing plan with a cash or deferral arrangement which has received a favorable determination letter from the IRS, which states that the Plan is designed in compliance with the applicable sections of the IRC. The Plan has been amended since receiving the determination letter. However, the Plan sponsor and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

**NOTE 6 - PLAN TERMINATION AND MODIFICATION**

The Plan Sponsor intends to continue the Plan indefinitely for the benefit of its employees; however, it reserves the right to terminate and/or modify the Plan at any time by resolution of its Board of Directors and subject to the provision of ERISA. In the event the Plan is terminated in the future, participants would become fully vested in their accounts.

**NOTE 7 - PARTY-IN-INTEREST**

Participant directed Plan investments are managed by Charles Schwab, the custodian of the Plan. Any purchases and sales of these funds are performed in the open market at fair value. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA. During the seven months ended December 31, 2024, the Plan incurred \$3,900 and \$10,692 of administrative fees to Charles Schwab and NWPS, respectively.

**NOTE 8 - PROHIBITED TRANSACTIONS**

During the seven months ended December 31, 2024, the Company inadvertently failed to deposit \$43,308 within the required timeframe stated by the DOL. The Company remitted lost earnings for the 2024 late contributions and filed Form 5330 to pay applicable excise taxes in 2024. The lost earnings were made from the Company's assets and not from Plan assets.
