## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator  
Koeller Nebeker Carlson Haluck LLP 401(k) Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audits**

We have performed audits of the accompanying financial statements of Koeller Nebeker Carlson Haluck LLP 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Koeller Nebeker Carlson Haluck LLP 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

### **Opinion**

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of Koeller Nebeker Carlson Haluck LLP 401(k) Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audits does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Koeller Nebeker Carlson Haluck LLP 401(k) Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

1. DESCRIPTION OF THE PLAN

The following description of Koeller Nebeker Carlson & Haluck, LLP 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan documents for a more comprehensive description of the Plan's provisions.

General

The Plan is a defined contribution plan sponsored by Koeller Nebeker Carlson Haluck LLP ("KNCH", "Employer", "Company", or "Plan Sponsor"), established on January 1, 1997, and most recently restated effective January 1, 2023, and is designed to provide eligible participants with a means to defer a portion of their compensation for retirement and to provide benefits in the event of disability, death, termination, or financial hardship. The Plan is subject to the provisions of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 (ERISA) and subsequent laws.

An expansion of Setting Every Community Up for Retirement Enhancement Act of 2019 ("SECURE 2.0") was signed into law on December 29, 2022, as part of the Consolidated Appropriations Act of 2023. The effective dates of provisions within SECURE 2.0 vary through 2026. The Company has until the end of the first Plan year beginning on or after January 1, 2026, to amend the Plan for the changes related to SECURE 2.0. The Plan has not been formally amended to adopt these provisions as of the date the financial statements were available to be issued.

Plan administration

KNCH is the administrator of the Plan and, as such, carries out the duties imposed by ERISA. KNCH has delegated certain responsibilities for the operation and administration of the Plan. All Plan assets are held by Empower Trust Company, the trustee of the Plan (the "Trustee"), and Massachusetts Mutual Life Insurance Company (the "Custodian"). The Trustee and Custodian are responsible for the custody of the Plan's assets and executing investment transactions. Empower Retirement, LLC provides recordkeeping and administrative services to the Plan.

Eligibility

Employees, excluding non-resident aliens, residents of Puerto Rico, and employees covered by a collectively bargained agreement, are eligible to participate by making elective deferrals beginning on the first day of the month coinciding with or following their date of hire. Employees become eligible for discretionary profit sharing contributions upon completion of one year of service, as defined. To receive discretionary nonelective contributions for a given Plan year, eligible employees must work at least 1,000 hours during that year and be employed on the last day of the Plan year.

Contributions

Participants may elect to contribute a portion of their compensation to the Plan, subject to calendar year contribution limits set forth by the Internal Revenue Code (IRC). Participant contributions may be made on a pre-tax basis or after-tax basis as Roth contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions which are also subject to IRC limits. Participants may also contribute amounts (rollovers) representing distributions from other qualified defined benefit or defined contribution plans.

Unless participants affirmatively elect otherwise, the Plan automatically defers a minimum of 6% of eligible compensation, on a pre-tax basis, each pay period and contributes that amount to the Plan. Under the provisions of the Plan, the participant's elective deferral rate will automatically increase each year by 1% of eligible compensation up to a maximum of 10%.

The Company makes nonelective safe harbor contributions in an amount equal to 3% of each participant's compensation. During the year ended December 31, 2024, the safe harbor nonelective contribution totaled \$620,673. The Company may make discretionary profit sharing contributions and discretionary matching contributions to the Plan of amounts determined and authorized by the Plan and the Company's Board of Directors up to the maximum amounts permitted by the IRC.

During the year ended December 31, 2024, the Company made a discretionary profit sharing contribution approximating \$122,000. No discretionary matching contributions were approved or made for the year ended December 31, 2024.

Participant accounts

Each participant's account is credited with the participant's contributions or rollovers and an allocation of (a) the Employer contributions, if any, and (b) Plan earnings, if any, and charged with an allocation of Plan losses, if any, and administrative expenses not paid directly by the Employer. Allocations of investment earnings (losses) are based strictly on the participant's selection of investments and timing of purchase. Other allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance. Participants' investment accounts are directed by the individual participant.

Notes receivable from participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of i) \$50,000 reduced by the highest outstanding note receivable balance over the prior twelve months or ii) 50% of their vested account balance, whichever is less. The notes receivable from participants are secured by the vested balance in the participant's account and bear interest at the prime rate plus 2.0%. Principal and interest are paid ratably through payroll deductions over a period generally not to exceed five years, unless the funds are used for purchase of a principal residence, in which case repayment terms may be extended. Outstanding notes receivable from participants at December 31, 2024 carry interest rates ranging from 5.25% to 10.50% and have varying maturity dates through November 2028.

Vesting

Participants are immediately vested in their voluntary contributions, plus actual earnings thereon. Vesting in Employer contributions, plus earnings thereon, is based on years of continuous service, as defined. In the event of death, disability or attaining normal retirement age, participants are immediately 100% vested in all contributions.

Forfeitures

Non-vested balances of participants' accounts may be subject to forfeiture upon termination of their employment with the Company. A forfeiture occurs in the Plan year in which the participant receives a distribution of their vested account. Forfeitures are retained in the Plan and used either to pay Plan administrative expenses or to reduce future employer contributions. There was no balance in the forfeited unvested account at December 31, 2024 or 2023. During 2024, \$4,176 of forfeitures were used to reduce Employer contributions.

Payment of benefits

Distributions and withdrawals are payable upon retirement, termination, financial hardship, disability or death. If a participant's account balance is less than or equal to \$1,000 upon termination, the balance is distributed immediately in a lump-sum cash payment. Balances greater than \$1,000 and less than or equal to \$5,000 (the "involuntary cash out amount") upon termination will be rolled over to an individual retirement account designated by the administrator if the participant has not requested a lump-sum cash payment or a direct rollover into another qualified benefit plan. If the account balance is over the involuntary cash out amount, the participant can consent to either a distribution paid in the form of a lump-sum cash payment, a direct rollover into another qualified plan or postpone payment to a later date and remain in the Plan as described in the plan document. Effective April 1, 2024, the Plan's involuntary cash out amount was increased from \$5,000 to \$7,000.

Hardship distributions are permitted under limited circumstances, as defined, if approved by the plan administrator. In addition, the Plan permits in service withdrawals from a participant's vested account upon attaining the age 59½.

Administrative expenses

Certain administrative expenses of the Plan, including recordkeeping fees, were paid directly by KNCH for the year ended December 31, 2024. The Plan is not required to reimburse KNCH for expenses paid on its behalf. Transaction fees for certain participant-initiated activity are charged to the specific account of the participant initiating any such transaction. Investment fees, which may vary according to the individual funds selected, are paid indirectly out of the assets of the Plan.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting

The accompanying financial statements have been prepared using the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of estimates

The preparation of financial statements in conformity with U.S. GAAP requires plan management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent liabilities. Actual results may differ from those estimates.

Risk and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and changes therein.

Investment valuation and income recognition

The Plan's investments are reported at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (See Note 3). Contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan (See Note 4).

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Management fees and expenses charged to the Plan for investment accounts are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be a distribution, the participant loan balance is reduced and a benefit payment is recorded.

Contributions and contributions receivable

Contributions from participants are recorded based on the date the contributions have been separated from a participant's pay by KNCH, which is the pay date.

Employer contributions are recorded in the year earned to coincide with the year in which KNCH records contributions. The Plan records receivables for all contributions based upon the contributions recognized, less amounts received by the Plan as of the last day of the Plan year.

Rollover contributions from participants are recorded based on the date the rollover contributions were received by the Plan.

Payment of benefits

Benefit payments are recorded when paid.

Administrative expenses

Administrative expenses are recorded when incurred.

Subsequent events

The Plan has evaluated subsequent events through October 15, 2025, the date the financial statements were available to be issued. No subsequent events have occurred that would have a material impact on the presentation of the Plan's financial statements.

3. FAIR VALUE MEASUREMENTS

Accounting standards establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to the unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of fair value hierarchy are as follows:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.

*Level 2* - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability; or

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement of the assets or liabilities.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value on a recurring basis. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual and money market funds: Valued at the daily closing price as reported by the fund. Such funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. The funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds and money market funds held by the Plan are deemed to be actively traded and are classified within level 1 of the fair value hierarchy.

Collective trusts: Valued at its NAV as a practical expedient to fair value and as determined by the fund issuer, based on the market value of its underlying investments minus the fund's liabilities. While the majority of the underlying asset values are quoted prices, the NAV of the collective trusts are not publicly quoted. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the collective trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

Pooled separate accounts: Valued at the NAV of the fund, as a practical expedient to fair value and as determined by the fund provider, based on the fair value of the underlying investments held by the fund less its liabilities. Participant transactions may occur daily. As of December 31, 2024, there were no restrictions on redemptions or unfunded commitments for any of the pooled separate accounts.

Self-directed brokerage accounts: The Plan offers a participant-directed brokerage account as an investment option. If elected, a participant-directed brokerage account allows a participant to direct the investment of the participant's contributions to the Plan among various mutual fund and common stocks offered by such affiliate, including funds that are not otherwise offered as investment options under the Plan. These investments are valued on the basis of readily determinable market prices, using their respective published rates on the open market and are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

As of December 31, 2024 and 2023, there were no restrictions on redemptions or unfunded commitments for any of the major classes of assets.

4. GUARANTEED INTEREST ACCOUNT

The Plan has a Guaranteed Interest Account ("GIA") with the Custodian (or "Issuer") under which participant directed contributions in the GIA are commingled with the general assets of the Issuer. The GIA is considered a fully benefit-responsive investment contract determined and certified by the Issuer. Contract value represents contributions made the contract, plus earnings, less participant withdrawals, and administrative expenses.

The crediting interest rate for the contract at December 31, 2024 and 2023 was 3.15% and 4.45%, respectively. The crediting interest rate is determined by the Issuer and is reset quarterly and is guaranteed to never fall below zero.

The GIA can be terminated by the Issuer if the total fair value of the investments or the annual contribution amounts fall below minimum levels as stated in the contract. The GIA can also be terminated by either the Company or the Issuer for additional reasons as defined in the contract. Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial Plan termination or merger with another plan), (2) the Plan breaches a provision of the agreement with the Issuer (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the Plan's trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with the Issuer or the Plan's participants are probable of occurring at this time.

5. INFORMATION PREPARED AND CERTIFIED BY THE TRUSTEE AND CUSTODIAN (UNAUDITED)

The plan administrator, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of ERISA. Accordingly, the Trustee and Custodian, determined to be qualified institutions by the plan administrator, have certified to the completeness and accuracy of:

- Investments and notes receivable from participants as shown in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023;
- Investment income and other income as shown in the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024;
- Investments and notes receivables from participants reflected on the schedule of assets (held at end of year) as of December 31, 2024.

Accordingly, as requested by the plan administrator, the Plan's independent auditor performed no procedures on the certified information other than to agree the certified information to the related information included in the financial statements and supplemental schedule of assets (held at end of year).

6. PLAN TERMINATION

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in their accounts as defined in the plan document. After deducting all charges and expenses, the balances of all individual accounts will be adjusted, and the remaining assets distributed.

7. TAX STATUS

The Plan has adopted a Non-Standardized Pre-Approved Profit Sharing/Money Purchase/CODA Plan sponsored by Empower Retirement LLC. The Non-Standardized Pre-Approved Profit Sharing/Money Purchase/CODA Plan received a favorable opinion letter from the Internal Revenue Service dated November 14, 2022, which states that the document satisfies the applicable provisions of the IRC, and is appropriate for use by employers for the benefit of their employees. The Plan has been amended since the opinion letter; however, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

The Plan administrator has determined that certain operational errors exist with respect to the Plan for the years ended December 31, 2024 and 2023. The Plan Sponsor is in the process of quantifying and correcting these operational errors in accordance with applicable IRS guidelines in order to maintain the Plan's continued qualified status.

8. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

ERISA defines party-in-interest similarly to the definition of a related party in financial accounting standards, except that ERISA's definition is broader and includes all entities and individuals that provide services to the Plan; however, these entities may not necessarily be related parties. Management did not identify any related parties to the Plan that were not also considered to be parties-in-interest. The Plan did not enter into any material related party transactions during the Plan year related to compensation arrangements, expense allowances, or similar items.

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, and an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee associate or relatives of such persons.

Transactions conducted by the Trustee and Custodian and their affiliates and the Company, on behalf of the Plan, qualify as party-in-interest transactions. Also, the Plan Sponsor pays certain fees on behalf of the Plan.

The Trustee and Custodian retain as compensation, any interest on amounts earned while certain transactions are pending. This applies to both contributions and distributions. Earnings are at institutional money market rates.

Revenue sharing accounts are used to pay Plan expenses or are reallocated to participant's accounts. At December 31, 2024 and 2023, there was no balance in the revenue sharing account. During December 31, 2024, revenue sharing contributions to the Plan totaled \$71,426 and were used to pay Plan expenses.

The Plan has included in its investment fund options certain funds managed by the Trustee and Custodian or one of their affiliates. Transactions in these funds are considered party-in-interest transactions under ERISA. Such transactions are permitted under the provisions of the Plan and are specifically exempt from prohibition of party-in-interest transactions under ERISA.
