**INDEPENDENT AUDITOR'S REPORT**

To the Trustees and Investment Committee  
Bois Forte Enterprises 401(k) Retirement Plan

**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed an audit of the accompanying financial statements of Bois Forte Enterprises 401(k) Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Bois Forte Enterprises 401(k) Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

**Opinion**

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly,

in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. ### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Bois Forte Enterprises 401(k) Retirement Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**NOTE A – DESCRIPTION OF PLAN**

The following description of the Bois Forte Enterprises 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

1. *General.* The Plan is a defined contribution plan covering all eligible employees of Bois Forte Reservation Tribal Council (the Company), who have completed one year of service, as defined by the Plan, and have attained age sixteen or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). A member of the Company's management and a member of the Tribe's governing body (Tribal Council) act as trustees of the Plan. The trustees have delegated the administration of the Plan to the Investment Committee. The Investment Committee has responsibility for determining the appropriateness of the Plan's investment offerings and monitors investment performance. The Company serves as the Plan Administrator, which is responsible for establishing the Plan's benefits, contributions, and other provisions, and for approving all Plan amendments.
2. *Participant Contributions.* Each year, participants may contribute a pre-tax or after-tax (Roth) elective salary deferral contribution up to the maximum allowable by law of the participant's annual eligible compensation, as defined by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollover). Participants direct the investment of Plan contributions into various investment options offered by the Plan.
3. *Employer Contributions.* The Company contributes employer discretionary matching contribution and employer nonelective contributions to the Plan, subject to certain Internal Revenue Code limitations as follows:
  - a. *Employer Discretionary Matching Contribution.* The Company contributed 100 percent of the participant's contribution up to 5 percent in 2024 and 2023. The Plan will include catch-up contributions in the elective deferral amount used to determine the amount of your matching contributions.
  - b. *Employer Discretionary Nonelective Contribution.* The Company may make a discretionary nonelective contribution to the Plan. For a participant to share in the nonelective contribution there are conditions that are needed to be satisfied. The nonelective contribution will be allocated or divided among eligible participants for the Plan year. There were no discretionary profit-sharing contributions made for the years ended December 31, 2024 and 2023.
4. *Participant Accounts.* Each participant's account is credited with the participant's contributions and the Company's discretionary matching contributions, as well as allocations of the Company's nonelective contribution and Plan earnings (losses), and charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.
5. *Vesting.* Participants are vested immediately in the participants and rollover contributions plus actual earnings thereon. Vesting in the Company's contributions portion of their accounts is based on years of

credited service, as defined by the Plan. A participant vests 100 percent in Company contributions after three years of credited service.

6. *Notes Receivable from Participants.* Participants previously were able to borrow from their fund accounts a minimum of \$1,000 up to maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. This plan provision was eliminated effective January 1, 2020 and any outstanding loans continued to be administered in accordance with the terms of the Loan Policy. A new loan policy was adopted effective March 1, 2023. Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$20,000 or 50 percent of their account balance. Loan terms range from 1 to 5 years. The loans are secured by the balance in the participant's account and bear interest at a rate of Prime plus two percent. Principal and interest are paid ratably through payroll deductions or remitted directly by participants.
7. *Payment of Benefits.* Benefits are paid to the participant or beneficiary upon death, disability, normal retirement age (age 62) or termination of employment reasons other than death, disability, or retirement. If the participant has a vested account balance, the participant may elect to receive a single lump sum amount or elect to postpone distribution until their required beginning date, as defined in the Plan. After normal retirement age or death and the participant has a vested account balance that exceeds \$5,000 the participant may elect to receive installments, as defined in the Plan. If the vested account balance is \$1,000 or less, involuntary cash outs are automatically distributed in a lump sum distribution without Participant's consent. In addition, in-service distributions are permitted if participant has attained age 59-1/2 from all contribution accounts. Financial hardships are allowed if participant satisfies certain conditions and limitations.
8. *Forfeitures.* Participant forfeitures may be used to pay Plan expenses or to reduce any nonelective or matching contribution. At December 31, 2024 and 2023, forfeited and non-vested accounts totaled \$72,240 and \$61,546, respectively. During 2024 and 2023, \$497 and \$5,911 of forfeitures were used to pay administrative expenses, respectively.

**NOTE B – SUMMARY OF ACCOUNTING POLICIES**

*Basis of Accounting*

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting standards promulgated by the Governmental Accounting Standards Board (GASB). The Plan is sponsored by the Bois Forte Enterprises, a component unit of the Bois Forte Band of Chippewa (the Band). These financial statements present only the Bois Forte Enterprises 401(k) Retirement Plan and are not intended to present the financial statements of the Band.

*Use of Estimates*

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

*Investment Valuation and Income Recognition*

Mutual funds are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Trustees or Investment Committee determines the Plan's valuation policies utilizing information provided by the custodian of the Plan. See Note D for discussion of fair value measurements.

General investment option contract held by a group annuity contract is reported at contract value. Contract value is the relevant measurement attribute for fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The investment in the general account is reported at contract value. See Note E for discussion of the general account.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

*Notes receivable from participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. No allowances for credit losses have been recorded as of December 31, 2024 and 2023.

Notes receivable from participants have been classified as an investment asset for Form 5500 reporting purposes and, accordingly, have been included as an investment in the supplemental schedule, Schedule H, Line 4i – Schedule of Assets (Held at End of Year).

*Payment of Benefits*

Benefits are recorded when paid.

*Investment policy and risks*

*Investment policy*

The Plan offers a broad range of diversified investments that enable a participant to construct a portfolio with aggregate risk and return characteristics at any point within the participant's desired range. Adherence to the specific investment objectives and criteria contained herein will be evaluated over a full-market cycle, which is based on one, three, five, and ten-year average annualized past performance of the investment option.

*Interest rate risk*

Interest rate risk is the risk that changes in market interest rates of investments will adversely affect the fair value of an investment. Investments with longer maturities have greater sensitivity to fair value changes based on market interest rates. As of December 31, 2024 and 2023, mutual funds classified as bond-type investments and the general account could be exposed to this risk.

*Credit risk*

Credit risk exists when there is a possibility that the issuer or other counterparty to an investment may be unable to fulfill its payments on a security under the original term. As of December 31, 2024 and 2023, mutual funds classified as bond-type investments and the general account could be exposed to this risk.

**NOTE C – INFORMATION PREPARED AND CERTIFIED**

The following is a summary of the Plan's asset information as of December 31, 2024 and 2023, and for the years then ended, included throughout the Plan's financial statements and supplemental schedules, that was prepared or derived from information provided by Empower Retirement (Empower), the Plan's recordkeeper, and furnished to the Plan Administrator. Empower refers to the products and contracts offered by Massachusetts Mutual Life Insurance Company (Mass Mutual), the Plan's contract issuer and Great West Life & Annuity Insurance Company (GWLA), the Plan's custodian.

The Plan Administrator has obtained certifications from Empower that information provided to the Plan Administrator by Empower related to the following assets is complete and accurate. Accordingly, as permitted by 29 CFR 2520. 103-8 of the United States Department of Labor's Rules and Regulations for Reporting and Disclosures under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information which appears throughout the financial statements and supplemental schedules related to the following assets:

The recordkeeper also certified to the completeness and accuracy of \$982,118 and \$1,246,297 of net appreciation in fair value and \$74,931 and \$73,151 of interest income related to the aforementioned investments for the years ended December 31, 2024 and 2023, respectively.

**NOTE D – FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2      Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Fixed Annuities:*

MassMutual SAGIC (managed by Great West Investments) is a market value separate account investment option with a general investment account guarantee that provides a stated rate of return and insulates plan participant activity from daily fluctuations in the market. Under the terms of the SAGIC group annuity contract, participants may direct plan-permitted withdrawal and/or transfer transactions of all or a portion of their balance in the SAGIC investment option at Contract Value. Contract Value represents contributions plus credited interest less participant withdrawals and fees. Contract Value is also often referred to as 'Book Value'.

The fair value presented below represents the liquidation value of the contract, equal to the market value of the assets in the separate account. Great West considers the SAGIC to be fully benefit responsive not withstanding the liquidation value events under the contract that limit the ability of the plan to transact at Contract Value.

*Mutual funds:*

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**NOTE E – GROUP ANNUITY CONTRACT WITH INSURANCE COMPANY**

The trustee of the Bois Forte Enterprises 401(k) Retirement Plan is a group annuity contract with MassMutual SAGIC (managed by Great West Investments). MassMutual SAGIC maintains contributions in a market value separate account investment option with a general investment account guarantee. For group annuity contracts that are fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment account. Contract value represents contributions made under that contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on an agreed-upon formula with the issuer, but it may not be less than 3 percent. Interest rates are declared in advance and guaranteed for a year. The guaranteed investment percentages were 4.10 percent and 4.65 percent for the years ended December 31, 2024 and 2023, respectively.

**NOTE E – GROUP ANNUITY CONTRACT WITH INSURANCE COMPANY (CONTINUED)**

The Plan's ability to receive amounts due in accordance with the group annuity contract is dependent on the third-party issuer's ability to meet their financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) termination of the Plan, (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (e.g. divestitures or spin-offs of a subsidiary, etc.) which cause significant withdrawal from the Plan or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA or (5) premature termination of the contracts. The Plan Administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

The contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following: (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation or (4) a material amendment to the agreement without the consent of the issuer.

**NOTE F – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested interest in their accounts. Any unallocated assets of the Plan would be allocated to participant accounts and distributed in such a manner as the Company may determine.

**NOTE G – TAX STATUS**

The Plan adopted a defined contribution volume submitter plan and trust sponsored by Empower Retirement LLC. The plan has received an opinion letter dated March 31, 2014, from the Internal Revenue Service (IRS) as to the plan's qualified status. The plan opinion letter has been relied upon by this Plan. The Plan has been amended since the date of the opinion letter; however, the Plan Administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and therefore believes that the Plan is qualified, and the related trust is tax-exempt as the financial statement date.

Accounting principles require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS or DOL. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
