Scope and nature of the ERISA Section 103(a)(3)(C) audit

We have performed audits of the financial statements of National Futures Association Employee Retirement Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note G to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (US GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of management for the financial statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's responsibilities for the audit of the financial statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with US GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with US GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.

- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other matter – supplemental schedules required by ERISA

The supplemental schedule of assets (held at end of year) is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such supplementary information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures. These additional procedures included comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with US GAAS. NOTE A - DESCRIPTION OF THE PLAN

The following description of the National Futures Association Employee Retirement Savings Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

General

The Plan is a profit-sharing plan with a 401(k) feature covering all employees of National Futures Association (the Company). The Plan was established effective January 1, 1983. The Plan is administered by the Company's benefit plan trustees, the members of which are selected by the board of directors of the Company. Schwab Retirement Plan Services is the record keeper, administrator, and custodial trustee for the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Participant Eligibility and Contributions

Full-time and part-time employees of the Company become eligible to participate in the Plan and make employee contributions on the date the employee is hired. Temporary employees will not be eligible to make employee contributions until completion of one year of service, as defined by the Plan document. Participants may elect to make pretax deferrals up to 100% of their compensation, not to exceed the maximum amount allowable under applicable income tax laws. Participants shall have automatic pretax deferrals equal to 6% of their compensation and the right to elect a different deferral percentage or no deferrals. A participant's deferral percentage shall automatically increase 1% each year. In addition to pretax deferrals, participants may elect to make contributions on an after-tax basis, which include Roth conversion contributions. Participants may elect to make an irrevocable contribution from another account under the Plan, other than any outstanding loan balance and the Roth contribution account, which is rolled over to the Roth conversion account. Participants who have attained age 50 before the end of the Plan year are eligible to make pretax and Roth catch-up contributions.

If the eligible employees elect an automatic deferral rate increase greater than one percentage point, then the deferral rate will increase by the elected percentage. Automatic increases shall not apply once a participant makes an affirmative election to change his or her contributions to the Plan, including an affirmative election to cease all deferrals.

Company Contribution

During the 2024 Plan year, the Company made matching contributions on behalf of each eligible participant equal to 100% of the employee contributions made by the participant, not to exceed 6% of the employee's compensation and not to exceed the maximum amount allowable by law. A participant's compensation is defined as his or her gross base salary, including bonuses, incentive compensation and overtime and, therefore, includes any pretax contributions.

Additionally, the Company may contribute to the Plan a profit-sharing contribution expressed as a percent of the annual compensation of the Plan participants who are employed on the last day of the Plan year. For the 2024 Plan year, a profit-sharing contribution was made of 5% of eligible wages. The Company may also contribute an additional supplemental contribution for Company officers and the Special Policy Advisor as long as such contribution meets all applicable limitations under the tax law. For the 2024 Plan year, an additional supplemental contribution was made of 3% of eligible wages. The amount contributed to the Plan for profit sharing was approximately \$3,691,658 for the year ended December 31, 2024.

Participant Accounts

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contribution, any matching contribution and profit-sharing contribution by the Company, and an allocation of the Plan's net investment income or loss, less expense. Any allocation of the Plan's net income or loss is based on the percentage of a participant's account balance in each of the funds as compared to each fund's total balance compared to the net income or loss each fund generates. The benefit to which a participant is entitled is the amount that can be provided from the participant's vested account.

Investments

Participants direct the investment of their account balances and future contributions into various investment options offered by the Plan. Company contributions are automatically invested in the same proportion as the participant's contributions. The Plan currently offers a number of mutual funds and a collective trust fund as investment options for participants.

Vesting

Participants are fully vested at all times to the extent of their individual contributions and earnings thereon.

A participant's vested percentage in the employer matching contributions account shall be no less than the percentage determined in the following schedule:

Vesting in the Company's profit-sharing contribution and the Company's additional supplemental contributions is based on years of service as shown in the following table:

Participants' accounts, as to Company contributions and earnings thereon, become fully vested upon a participant's death, permanent disability or termination from the Company after reaching 55 years of age.

Notes Receivable from Participants

The Plan allows for participant loans. The minimum loan amount is \$1,000. The maximum loan amount is 50% of the participant's vested balance up to a maximum of \$50,000.

Loans are secured by the participant's remaining account balance. All loans require promissory notes providing for payment of principal and interest at a rate of 1% above the prime rate published in The Wall Street Journal on the first day during the month that the loan was requested.

Employees can have two loans in any year. The loan must be repaid through equal payroll deduction installments and must be repaid within five years from loan commencement, except for loans related to the purchase of a primary residence, which may be for a period of more than five years in accordance with the Internal Revenue Code (IRC). If the employee should leave or terminate employment with the Company, the participant may elect to continue loan repayments as scheduled pursuant to rules established by the Plan administrator.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service (IRS) are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 excess contributions to the applicable participants in 2025.

Payment of Benefits

Upon termination of service, a participant can receive an amount equal to the value of the participant's vested interest in his or her account or maintain his or her vested funds in the Plan. A participant may elect distributions in substantially equal installments payable over a period of time or a lump sum distribution of either the participant's entire account balance or a portion of the participant's account balance as of the date of termination. Withdrawals of pretax contributions are prohibited unless a participant (1) has attained the age of 59½ or (2) demonstrates financial hardship. After-tax contributions can be withdrawn once per calendar year at any time throughout the year.

Hardship Withdrawals by Participants

For the purposes of the Plan, financial hardship exists if funds will be used to pay for non-reimbursed medical expenses, post-secondary education, to purchase a primary residence, to prevent eviction or foreclosure of a mortgage, for burial or funeral expenses, for repair of damages to principal residence, for disaster expenses and losses, or other purposes constituted as immediate and heavy financial need by the IRS.

Financial hardship withdrawals are limited to the participant's salary reduction contributions account and any earnings prior to January 1, 1989.

Forfeited Accounts

Forfeited amounts are used to reduce future Company matching contributions and profit-sharing contributions to the Plan. At December 31, 2024 and 2023, forfeited non-vested amounts were approximately \$226,000 and \$143,500, respectively. For the 2024 plan year, the Company applied approximately \$244,000 of forfeitures, in the first quarter of 2025, reducing the employer contribution included in the contribution receivable as of December 31, 2024.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The Plan's financial statements have been prepared on the accrual basis of accounting and in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires Plan management to make estimates and assumptions that affect the amounts of net assets available for Plan benefits and changes therein. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan utilizes various investment instruments, including mutual funds and a collective fund. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note C for discussion of fair value measurements.

Interest income is recorded on the accrual basis. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Management fees and operating expenses charged to the Plan for investments in the mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Administrative Expenses

Certain administrative expenses of the Plan are paid by the Plan as provided in the Plan document.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

NOTE C - FAIR VALUE MEASUREMENTS

The Financial Accounting Standards Board has issued guidance that establishes a framework for measuring fair value. That framework requires the categorization of assets and liabilities into three levels based on the assumptions (inputs) used to price the assets or liabilities. Level 1 provides the most reliable measure of fair value; whereas Level 3 generally requires significant management judgment. The three levels of the fair value hierarchy are defined as follows:

Level 1 - Unadjusted quoted prices in active markets for identical assets and liabilities.

Level 2 - Observable inputs other than those included in Level 1, for example, quoted prices for similar assets or liabilities in active markets, quoted prices for identical assets or liabilities in inactive markets, or inputs other than quoted prices that are observable for the asset or liability.

Level 3 - Unobservable inputs reflecting management's own assumptions about the inputs used in pricing the asset or liability that are significant to the fair value measurement.

Fair value measurement is based on the lowest level of input that is significant to the fair value of the instrument.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual funds - The Plan's investments in shares of mutual funds are valued at the quoted net asset value (NAV) of shares held by the Plan at year-end, which is valued on an active market.

Collective trust funds - The collective trust funds are valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value for the collective fund. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. There are no restrictions or any unfunded commitments for the collective trust fund.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. Upon termination of the Plan, the participants' accounts shall become fully vested and non-forfeitable.

NOTE F - TAX STATUS

The IRS has determined and informed the Company by a letter dated February 8, 2018, that the Plan and related trust are designed in accordance with applicable requirements of the IRC. The Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS or other applicable taxing authorities. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE G - INFORMATION CERTIFIED BY THE TRUSTEE

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Charles Schwab Trust Company, the trustee of the Plan, has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments, at fair value and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net investment income and interest income on notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule H, line 4i - schedule of assets (held at end of year) as of December 31, 2024.

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.
