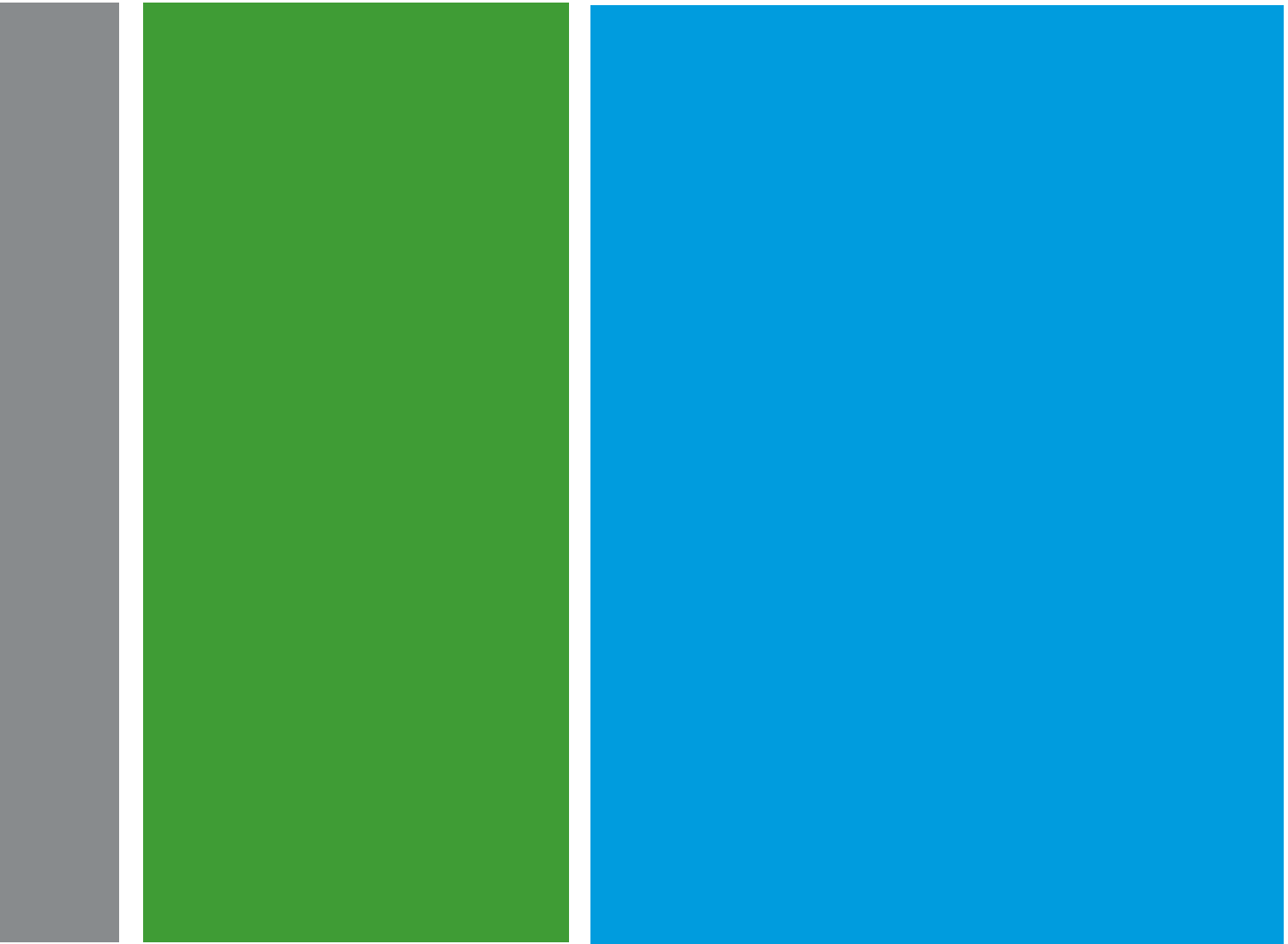

## INDEPENDENT AUDITORS' REPORT

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events considered in the aggregate that raise substantial doubt about GVS Puerto Rico LLC Retirement Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditors' Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of GVS Puerto Rico LLC Retirement Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events considered in the aggregate, that raise substantial doubt about GVS Puerto Rico LLC Retirement Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**Other Matter - Supplemental Schedules Required by ERISA**

The supplemental schedules of Schedule H, Line 4a – Schedule of Delinquent Participant Contributions for the year then ended December 31, 2024 and Schedule H, Line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024, are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- The form and content of the supplemental schedules, other than the information in the supplemental schedules that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- The information in the supplemental schedules related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### 1) Plan Description:

The following brief description of GVS Puerto Rico LLC Retirement Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan Agreement for a complete description of the Plan's provisions.

A) General – GVS Puerto Rico LLC Retirement Plan was established on August 1, 2012, as a cash or deferred profit sharing plan to provide benefits upon retirement, disability or death to participant employees or beneficiaries of GVS Puerto Rico, LLC (collectively the Employer and Plan Sponsor) (previously Haemonetics Puerto Rico LLC). Under the Plan, all employees, except for those employees in a unit of employees covered by a collective bargaining agreement in which retirement benefits were the subject of good faith bargaining, leased employees, temporary employees hired for the duration of a particular project and independent contractors, become automatically eligible to participate in the Plan on the enrollment date. The Plan allows for automatic enrollment for all participants that become eligible, unless they chose otherwise. The uniform percentage rate for automatic enrollment is 3% of participant compensation after 3 months from the date of hire.

The Plan is qualified under Section 1081.01 of the Puerto Rico Internal Revenue Code of 2011, as amended, (PRIRC) and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

B) Contributions – The Plan provides for contributions to be made by the Employer and by participants as follows:

- Employee pre-tax contributions – Pre-tax contributions may not exceed 75% of compensation. Pre-tax contributions are limited to \$15,000.
- Employee after-tax contributions – Voluntary after-tax contributions are permitted under the Plan. After-tax contributions may not exceed 10% of compensation paid to the employee.
- Employee catch-up contributions – A participant who has attained age 50 by the close of the Plan year, may elect to make catch-up contributions subject to the limit of \$1,500.
- Employer's contributions – The Employer may match pre-tax contributions in amounts, if any, at the Employer's discretion. Total annual contributions made by the Employer and participants are limited to the lesser of \$69,000 or the total compensation paid by the Employer to participant during the Plan year. The Plan does not permit employer matching after-tax contributions.
- Employer's profit sharing contributions – The Employer may make profit sharing contributions to the Plan in one or more installments for each Plan year at the Employer's discretion. Such amounts may be shared with participants employed on the last day of the Plan year which completed at least 1,000 hours of service for the Plan year. These allocation conditions are waived for terminated participants due to death, disability or normal retirement.

C) Participant elections – The Plan allows participants to direct their contributions into various investment options available under the Plan.

- D) Vesting – Contributions made by participants, rollover contributions, and employer matching contribution, plus or minus any earnings or losses, are 100% vested at all times. Employer’s profit sharing contributions and their earnings will vest as follows:

Years of Service	Vested Percentage
Less than 2 years	0%
2	20%
3	40%
4	60%
5	80%
6 or more	100%

A participant will become fully vested in his or her profit sharing contributions and their earnings upon the earlier of (i) reaching normal retirement age while still employed by the Employer, (ii) retirement at normal retirement age, (iii) disability, (iv) death while employed by the Employer, (v) termination of the Plan, or (vi) complete discontinuance of contribution from the Employer.

- E) Notes receivable from participants – Loans are available to all participants whose employment has not terminated. All loans are evidenced by a promissory note signed by the participant. Loans are secured by the balance in the participant’s account and bear interest ranging between 4.25% and 9.50% with maturities up to 2029. Interest rates are determined from the Wall Street Journal on the first day of each calendar quarter and is used for all loan requests for the quarter, until a new rate is requested. No participant’s loan shall exceed the lesser of 50% of the participant’s vested account balance or \$50,000. The minimum loan amount is \$1,000. The maximum term of a loan is 5 years, except if it is for the acquisition of the participant’s principal residence, in which the maximum period shall be 25 years. Only one loan outstanding at a time is permitted.
- F) Payments of benefits – On termination of service due to separation of employment, death, disability, or retirement, the distributions will be made in a single lump sum payment. In addition, any participant whose employment has not been terminated may be entitled to receive an in-service distribution. Withdrawals may be from accounts for Employee contributions and rollover contributions at any time. Participants must satisfy any of the following conditions: (i) attained age 59 ½, or (ii) incurred a financial hardship. Hardship distributions may be made to satisfy certain immediate and heavy financial needs as purchase of principal residence, major medical expenses, payment of tuition for post-secondary education for the Participant’s, spouse or children, payment to avoid eviction or to foreclosure, and funeral expenses of a member of the immediate family of a participant like the spouse, parents, children or dependents.
- G) Forfeitures – Forfeitures represents non-vested portions of contributions of the Employer on the day of the participant termination. Forfeitures should be used first to reduce the Plan’s administrative expenses and then to either reduce Employer profit sharing contributions or to re-allocate proportionally among remaining active participants. As of December 31, 2024 and 2023, there were no forfeited non-vested accounts.

## 2) Summary of Significant Accounting Policies:

The most significant accounting policies followed by the Plan are summarized below:

- A) Basis of accounting – The accompanying financial statements have been prepared on the accrual basis of accounting.

- B) Use of estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.
- C) Investment valuation and income recognition – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.  
  
Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan’s gains and losses on investments bought and sold as well as held during the year.
- D) Notes receivable from participants – Are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis.
- E) Contributions – Employer and participants’ contributions are recorded in the Plan year in which the Employer makes the payroll deductions.
- F) Payment of benefits – Benefits payments to participants are recorded when paid.
- G) Administrative expenses – Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Certain expenses as incurred in connection with the general administration are paid by the Plan and are recorded as deductions in the accompanying statement of changes in net assets available for benefits. Fees related to the administration of the notes receivable from participants are charged directly to the participant’s account and are presented as administrative expenses. Investment related expenses are included in net appreciation (depreciation) of investments.

### 3) Information Certified by BPAS Trust Company of Puerto Rico (BPAS) (custodian):

The following is a summary of the Plan’s asset information as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included throughout the Plan’s financial statements and ERISA-required supplemental schedules, obtained by management and agreed to or derived from information certified by BPAS, the custodian of the Plan.

The Plan Administrator has obtained certifications from the custodian that information provided to the Plan Administrator by the custodian related to the following assets is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor’s (DOL) Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan’s independent auditors not to perform any auditing procedures with respect to the following information, which appears throughout the financial statements and ERISA-required supplemental schedules:

### 4) Fair Value Measurements:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3).

The valuation techniques are based upon observable or unobservable inputs. Observable inputs reflect market data obtained from independent sources, while unobservable inputs reflect the Plan's market assumptions.

The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission (SEC). These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded. There have been no changes in the methodology used as of December 31, 2024 and 2023.

As of December 31, 2024 and 2023, investments in mutual funds are considered Level 1 type investments within the fair value hierarchy.

### 5) Tax Status:

The Plan is intended to be a tax qualified arrangement that complies with the provisions of ERISA and with the PRIRC. The Plan received a determination letter from the Puerto Rico Department of Treasury dated February 24, 2021, stating that the Plan is qualified with the PRIRC. The plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the PRIRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination of taxing authorities. The Plan Administrator evaluated the tax positions taken by the Plan and concluded that the Plan as of December 31, 2024 and 2023, had maintained its tax exempt status and had taken no uncertain tax positions that would require adjustments or disclosures to the financial statements. Therefore, no provision or liability for income taxes has been included in the accompanying financial statements.

### 6) Prohibited Transactions:

During 2024, 2023 and 2022 the Plan Sponsor inadvertently failed to deposit approximately \$93,721, \$96,835 and \$266,215, respectively of participant contributions and loan repayments within the required timeframe as stated by the United States Department of Labor regulations. During the year ending December 31, 2025, the Employer deposited lost earnings outside the Voluntary Fiduciary Correction Program in the amount of \$537 to correct the failures related to years ended December 31, 2023 and 2022. The correction was made from the Plan Sponsor's assets and not from assets of the Plan. The Employer intends to correct failures related to the year ended December 31, 2024 during 2025. The correction will be made from the Plan Sponsor's assets and not from assets of the Plan.

### 7) Risks and Uncertainties:

The Plan invests in various investment securities. The Plan's investments are exposed to various risks, such as interest rate fluctuations, market volatility and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the Plan's account balances and the amounts reported in the accompanying statements of net assets available for benefits.

### 8) Party-In-Interest Transactions:

GVS Puerto Rico LLC and BPAS are parties-in-interest as defined by ERISA. Additionally, the Plan extends notes to participants, that are considered parties-in-interest. Refer to Note 6 to disclosure of prohibited transactions between a party-in-interest. Other than the event described in Note 6, there were no prohibited party-in-interest investments or transactions as of December 31, 2024 and 2023, and for the year ended December 31, 2024.

### 9) Plan Termination:

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time or to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

### 10) Reconciliation of financial statements to Form 5500:

#### 11) Subsequent Events:

During the year ending December 31, 2025, GVS Puerto Rico LLC is winding down operations. During the period ended June 30, 2025, total distributions related to layoffs amounted to approximately \$1,763,300. The Board of Directors of the Plan Sponsor has not voted to terminate the Plan.

The Plan Administrator has evaluated subsequent events through October 15, 2025, the date on which the financial statements were available to be issued.
