### **Opinion**



(1) **DESCRIPTION OF PLAN**

The following description of the **Blend Pak Inc 401(k) Profit Sharing Plan and Trust** (the “Plan”) provides only general information. Participants should refer to the plan document and Summary Plan Description for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan established by Blend Pak Inc. (the “Company”), effective January 1, 2024, covering substantially all employees of the Company who have completed two consecutive months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

**Contributions**

Participants may make pre-tax and after-tax Roth elective salary deferrals up to 92% of total compensation, as defined in the plan document, subject to limitations imposed by Internal Revenue Code (“IRC”) regulations. Eligible participants are also permitted to make catch-up contributions in accordance with IRC regulations and rollover contributions representing distributions from other qualified plans. The plan also permits in-plan Roth rollovers for eligible participants.

Company salary deferral matching contributions are made annually equal to 100% of each participant’s deferrals, limited to 3% of eligible compensation. Company contributions may also include discretionary profit sharing and/or nonelective contributions as determined annually by the Company. The Company made no discretionary profit sharing or nonelective contributions during 2024. To be eligible to receive Company discretionary profit sharing contributions, participants must be employed on the last day of the plan year. Only non-highly compensated employees, as defined in the plan document, are eligible to receive Company discretionary nonelective contributions.

The Plan automatically withholds 3% of the employee’s pay on a pre-tax basis. Employees are permitted to opt out of the Plan’s automatic enrollment provisions by providing written notice to the plan administrator. Participants may also withdraw automatic enrollment salary deferral contributions, and earnings thereon, without penalty, within 90 days after the date the first automatic deferral is made.

Participants direct the investment of their contributions and the Company’s contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds as investment options for participants. Participants may change their investment elections at any time.

**Participant Accounts**

Each participant's account is credited with the participant's contributions, employer contributions, and an allocation of plan earnings, and charged with an allocation of plan losses and administrative expenses. Allocations are based on participant compensation, account balances or specific transactions, as defined in the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Vesting**

Participants are immediately 100% vested in their contributions and employer salary deferral matching, discretionary profit sharing and discretionary nonelective contributions, plus actual earnings thereon.

**Notes Receivable from Participants**

Participants may borrow from their accounts up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years, or longer terms for loans used to purchase a primary residence. The loans are secured by the remaining balance in the participant's account and bear interest at a rate of prime plus 1% on the loan origination date. Principal and interest are paid ratably through payroll deductions.

**Payment of Benefits**

On termination of service due to death, disability, retirement or other reasons, participants may elect to receive a lump sum amount equal to the value of their vested account balance, installment payments, non-recurring partial payments, or payments toward the purchase of an annuity contract. Withdrawals attributable to rollover contributions are available at any time. The Plan also provides for in-service distributions or deemed severance distributions for participants that have attained age 59½ or for financial hardships subject to Plan provisions. If a participant terminates employment and the participant's account balance does not exceed \$5,000, the funds will be distributed upon termination of employment in a lump sum amount, subject to automatic rollover provisions if the distribution exceeds \$1,000.

**Forfeited Accounts**

Forfeited nonvested accounts are used to reduce future employer contributions or pay plan expenses. There was no forfeited nonvested account balance at December 31, 2024, and no forfeitures were used to reduce employer contributions or pay plan expenses for the year ended December 31, 2024.

**Investment Valuation and Income Recognition**

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. **(4) RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Fees paid by the Plan to the trustees, service providers or affiliates of the trustees or service providers for the administration of the Plan are reflected in the statement of changes in net assets available for benefits. Such payments qualify as party-in-interest transactions which are exempt from the prohibited transaction rules. Administrative fees paid by the Plan to the service providers were \$5,809 for the year ended December 31, 2024.

**(5) PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

**(6) TAX STATUS**

The Plan is based on a pre-approved plan which has received a favorable opinion letter from the IRS dated August 31, 2020, that the pre-approved plan is designed in accordance with applicable sections of the IRC. The plan sponsor has not separately applied for a determination letter from the IRS. Although the Plan has been amended since receiving the opinion letter, the plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and therefore believe that the Plan is qualified and the related trust is tax exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.



(1) **DESCRIPTION OF PLAN**

The following description of the **Blend Pak Inc 401(k) Profit Sharing Plan and Trust** (the “Plan”) provides only general information. Participants should refer to the plan document and Summary Plan Description for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan established by Blend Pak Inc. (the “Company”), effective January 1, 2024, covering substantially all employees of the Company who have completed two consecutive months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

**Contributions**

Participants may make pre-tax and after-tax Roth elective salary deferrals up to 92% of total compensation, as defined in the plan document, subject to limitations imposed by Internal Revenue Code (“IRC”) regulations. Eligible participants are also permitted to make catch-up contributions in accordance with IRC regulations and rollover contributions representing distributions from other qualified plans. The plan also permits in-plan Roth rollovers for eligible participants.

Company salary deferral matching contributions are made annually equal to 100% of each participant’s deferrals, limited to 3% of eligible compensation. Company contributions may also include discretionary profit sharing and/or nonelective contributions as determined annually by the Company. The Company made no discretionary profit sharing or nonelective contributions during 2024. To be eligible to receive Company discretionary profit sharing contributions, participants must be employed on the last day of the plan year. Only non-highly compensated employees, as defined in the plan document, are eligible to receive Company discretionary nonelective contributions.

The Plan automatically withholds 3% of the employee’s pay on a pre-tax basis. Employees are permitted to opt out of the Plan’s automatic enrollment provisions by providing written notice to the plan administrator. Allocations are based on participant compensation, account balances or specific transactions, as defined in the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Vesting**

The three levels of the fair value hierarchy under FASB ASC Topic 820 are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include quoted prices for similar assets in active markets; quoted prices for identical or similar assets in inactive markets; inputs other than quoted prices that are observed for the asset; or inputs that are derived principally from or can be corroborated by observable market data by correlation or other means.
- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs are not available. Level 3 inputs are used only if Level 1 or Level 2 inputs are not available. There are no plan assets requiring the use of Level 3 inputs for the periods presented.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation techniques and related inputs used for assets measured at fair value at December 31, 2024.

**Mutual Funds**

The fair value of mutual funds is based on the quoted net asset value (“NAV”) of the shares as reported by the fund (Level 1 inputs). The mutual funds held by the Plan are open-end mutual funds registered with the United States Securities and Exchange Commission. The funds must publish their daily NAV and transact at that price. The mutual funds held by the Plan are considered to be actively traded.

Gains and losses included in changes in net assets available for benefits for the year ended December 31, 2024, are reported in net depreciation in fair value of investments.

**(4) RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Fees paid by the Plan to the trustees, service providers or affiliates of the trustees or service providers for the administration of the Plan are reflected in the statement of changes in net assets available for benefits. Such payments qualify as party-in-interest transactions which are exempt from the prohibited transaction rules. Administrative fees paid by the Plan to the service providers were \$5,809 for the year ended December 31, 2024.

**(5) PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

**(6) TAX STATUS**

The Plan is based on a pre-approved plan which has received a favorable opinion letter from the IRS dated August 31, 2020, that the pre-approved plan is designed in accordance with applicable sections of the IRC. The plan sponsor has not separately applied for a determination letter from the IRS. Although the Plan has been amended since receiving the opinion letter, the plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and therefore believe that the Plan is qualified and the related trust is tax exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

**(7) RISKS AND UNCERTAINTIES**

The Plan invests in mutual funds that are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with the investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
