We have performed audits of the financial statements of Desert de Oro Foods, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Note 1 – Plan Description

The following description of the Desert de Oro Foods, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

General:

The Plan is a defined contribution plan available to all employees of Desert de Oro Foods, Inc., and its participating employers (referred to as the Company or Plan Sponsor) and was originally effective February 1, 1997. The Plan has been amended throughout the years to comply with tax legislation and was most recently amended effective June 28, 2022. The Plan is intended to constitute a multiple employer plan subject to Section 413(c) of the Internal Revenue Code (IRC) for participants of any participating employer. The Plan excludes leased employees, non-resident aliens, and employees covered by a collective bargaining agreement. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Trustee is responsible for the oversight of the Plan. The Trustee and plan administrator determine the appropriateness of the Plan's investment offerings and monitor investment performance.

Eligibility:

Employees are eligible to participate in the deferral and safe harbor match components of the Plan upon reaching age 18 and completing twelve months of employment during which they are credited with at least 1,000 hours of service. Employees are eligible for discretionary profit sharing contributions if they meet the preceding requirements and if they are employed on the last day of the plan year, or terminate employment during the year and are credited with 500 hours of service during the plan year, or it is the year of their death, disability, or termination of employment after normal retirement age.

Contributions:

The Plan includes a salary deferral arrangement allowed under Section 401(k) of the IRC. Eligible participants are permitted to elect to have a percentage, limited by Plan provisions, of their compensation contributed as pre-tax 401(k) or Roth contributions to the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

The Company contributes a safe harbor contribution equal to 100% of the employee deferral that does not exceed 3% of compensation plus 50% of the employee deferral between 3% and 5%. In addition, the Company may contribute a discretionary profit sharing contribution. There were no discretionary profit sharing contributions for the year ended December 31, 2024.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant accounts:

Each participant's account is credited with the participant's contributions and any Company contributions. Realized and unrealized gains, losses, interest, and dividend income are adjusted based on participant account balances. Participants are charged with the allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, or participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Note 1 – Plan Description (Continued)

Vesting:

Participants are immediately vested in their contributions and the employer safe harbor contribution, plus actual earnings thereon. Vesting in the Company discretionary profit sharing contribution is based on years of continuous service. A participant is 20% vested after two years of service and an additional 20% for each year thereafter. A participant is 100% vested after six years of credited service. Additionally, participants become fully vested upon disability, death, or normal retirement as defined in the Plan document.

Notes receivable from participants:

Participants may borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance from their fund account. The notes are secured by the balance in the participant's account and bear interest at the prime rate (7.5% at December 31, 2024) plus 1% as of the date the note is executed. The note must be repaid over a period not to exceed five years unless the loan is used for the purchase of the participant's principal residence. Principal and interest are paid ratably through payroll deductions.

Payment of benefits:

Benefits begin at retirement age, termination of employment, total and permanent disability, or death of the participant. Distributions of benefits are made in one lump sum or as installments (only with respect to required minimum distributions) for vested balances more than \$5,000. The Plan allows for in-service distributions if a participant reaches age 59.5 and hardship distributions subject to Plan provisions. If a participant terminates employment and the participant's account balance does not exceed \$1,000, the plan administrator will authorize the benefit payment without the participant's consent. If the balance of the terminated participant's account is between \$1,000 and \$5,000, the plan administrator may authorize that the benefit payment be rolled into an individual retirement account in the participant's name.

Forfeitures:

Upon termination of employment, participants forfeit their non-vested discretionary profit sharing balances. Any forfeiture amounts derived from discretionary profit sharing contributions are allocated to participants eligible to share in allocations of profit sharing contributions or used to pay plan expenses. For the year ended December 31, 2024, a total of \$5,498 in non-vested employer contributions was forfeited by participants. As of December 31, 2024 and 2023, there were \$6,920 and \$1,370, respectively, in unallocated forfeitures. No forfeitures were utilized during the year ended December 31, 2024.

Note 2 – Summary of Significant Accounting Policies

A summary of the Plan's significant accounting policies follows:

Basis of accounting:

The financial statements of the Plan are prepared on the accrual basis of accounting.

Estimates:

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Note 2 – Summary of Significant Accounting Policies (Continued)

Investment valuation and income recognition:

The Plan's investments are reported at fair value (except for fully benefit responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Trustee determines the Plan's valuation policies utilizing information provided by the custodian. See *Note 4* for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's realized and unrealized gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants:

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent notes receivable are recorded as distributions on the basis of the terms of the Plan document.

Contributions receivable:

Contributions from participants and related matching contributions, if any, are recorded in the year when the contributions from participants are withheld from compensation.

Payment of benefits:

Benefits are recorded when paid.

Administrative expenses:

Administrative expenses of the Plan may be paid directly by the Company or from the assets of the Plan. The expenses that are paid from Plan assets will either be shared by all participants or charged directly to the account of the participant on whose sole behalf the expense is incurred. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent events:

Plan management has evaluated subsequent events through September 25, 2025, which is the date the financial statements were available to be issued.

Note 3 – Certification of Investment Information

Lincoln Financial Group (Lincoln), the custodian of the Plan, has supplied the plan administrator with a certification as to the completeness and accuracy of all investment information reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statement of changes in net assets available for benefits for the year ended December 31, 2024, and the supplemental schedule of assets (held at end of year) as of December 31, 2024.

Note 4 – Fair Value Measurement

Fair value measurements are based on a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under Accounting Standards Codification (ASC) 820 are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

- Level 2 Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:
 - Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability; or
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled separate accounts: Valued at the net asset value (NAV) or equivalent based on units of the pooled separate accounts. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is generally based on the fair value of the underlying investments held by the pooled separate account less its liabilities. There are no unfunded commitments or redemption restrictions associated with these investments.

Note 4 – Fair Value Measurement (Continued)

*In accordance with ASC 820-10, certain investments that are measured at fair value using the NAV per share (or its equivalent) practical expedient have not been classified in the fair value hierarchy. The fair value amounts presented in this table are intended to permit reconciliation of the fair value hierarchy to the fair value of the Plan's assets at the end of each respective year.

Note 5 – Group Annuity Contract

The Plan participates in the Lincoln Stable Value Account (Stable Value Account). The Stable Value Account is an insurance company issued general account backed group annuity contract. Investments in this contract are backed by a diversified portfolio of fixed income instruments, primarily intermediate-term public bonds, private placement bonds, and commercial mortgages with a duration of three to seven years.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by Lincoln, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may generally transfer any amount from the Stable Value Account, however, a participant may only transfer funds to the Stable Value Account after 90 days have elapsed since the date of their last transfer from the Stable Value Account. The Stable Value Account remains fully benefit-responsive upon contract termination, and discontinuance fees do not apply.

The contract is a group annuity insurance product issued by Lincoln and is backed by the full faith and creditworthiness of the issuer. There are no reserves against contract value for credit risk of the contract issuer or otherwise. Deposits made to the contract are deposited in Lincoln's general account. Payment obligations under the contract represent an insurance claim supported by all general account assets. The contract does not operate like a mutual fund, variable annuity product, or conventional fixed rate individual annuity product. Expenses related to the contract are calculated by Lincoln and incorporated into the contract's crediting rate. Past interest rates are not indicative of future interest rates.

The Stable Value Account has a portfolio investment rate design in which all deposits are credited with the same interest rate on a daily basis, with no set maturity. The effective guaranteed credited interest rate is set on a quarterly basis. The guaranteed interest rate shall not change during the period for which it is effective. No guaranteed rate may be less than 1%. The average crediting interest rate as of December 31, 2024 and 2023 was 2.77% and 2.54%, respectively.

Note 6 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market fluctuation and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 7 – Party-in-Interest and Related Party Transactions

Certain Plan investments are managed by Lincoln. Lincoln is the custodian as defined by the Plan and, therefore, the investment transactions qualify as party-in-interest transactions. For the year ended December 31, 2024, the Plan made direct payments to Lincoln of \$114,286 and \$9,750 for asset management services and loan processing fees, respectively. Additionally, indirect fees are paid to Lincoln based on investment account balances. These fees ranged from 0.04% to 1% of the investment account value. The fees decrease net appreciation in fair value of investments on the statement of changes in net assets available for benefits.

National Professional Planning Group, Inc. (NPPG) is the third party administrator. For the year ended December 31, 2024, the Plan recognized \$34,183 in administrative expenses to NPPG.

Note 8 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 9 – Tax Status

The Plan Sponsor has adopted a pre-approved plan provided by Pinnacle Financial Services (Pinnacle). Pinnacle obtained an opinion letter dated June 30, 2020, from the IRS pursuant to a requirement to restate pre-approved plan documents every six years in order to maintain the Plan's tax-qualified status. The pre-approved plan has been amended since receiving the opinion letter. However, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

The plan administrator has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 10 – Prohibited Transactions

During 2024, the Plan Sponsor inadvertently failed to deposit participant deferrals totaling \$91,777 within the required timeframe as stated by the Department of Labor (DOL). The DOL considers late deposits to be prohibited transactions. The Plan Sponsor is in the process of correcting these transactions by depositing lost earnings.

During 2023, the Plan Sponsor inadvertently failed to deposit participant deferrals totaling \$3,999 within the required timeframe as stated by the DOL. The DOL considers late deposits to be prohibited transactions. The Plan Sponsor is in the process of correcting these transactions by depositing lost earnings.

During 2022, the Plan Sponsor inadvertently failed to deposit participant deferrals totaling \$57,100 within the required timeframe as stated by the DOL. The DOL considers late deposits to be prohibited transactions. The Plan Sponsor corrected these transactions during 2024 by depositing lost earnings.
