## INDEPENDENT AUDITOR'S REPORT

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Individual FoodService Union Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Individual FoodService Union Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the accompanying financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- the information in the accompanying financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Individual FoodService Union Retirement Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Individual FoodService Union Retirement Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### NOTE 1. DESCRIPTION OF PLAN

The following description of the Individual FoodService (the “Company”) Union Retirement Plan (the “Plan”) provides general information. IFS Acquisition, LLC is the Plan Sponsor. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

**General:** The Plan is a defined contribution plan covering all union employees of the Company who have completed 720 hours of service. The Plan is subject to the provisions of ERISA. All Plan investments are self-directed by the Plan participants. The Plan currently offers several pooled separate accounts and an insurance investment contract as investment options for the participants. The trustee for the Plan’s investments is Empower Trust Company (“Empower”). Empower, who is also the recordkeeper, provides administrative services and insurance products to the Plan. The Company is the Plan’s sponsor and serves as the plan administrator.

**Contributions:** Each year, participants may contribute a percentage of pretax compensation as limited by the law. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. All contributions are subject to certain Internal Revenue Code (“IRC”) limitations. Participants may also contribute amounts representing rollover distributions from other qualified plans. The Company may make matching contributions and required minimum contributions. The Company is contributing to the Plan on an annual basis based on regular hours worked the prior year in accordance with the collective bargaining agreement, which amounted to \$414,268 and \$361,817 for the years ended December 31, 2024 and 2023, respectively. All contributions to the Plan, including any matching funds by the Company, are invested at the discretion of the participants.

**Participant accounts:** Each participant’s account is credited with the participant’s contribution and allocations of the Company’s contributions and Plan earnings. Allocations are based on participant earnings or account balances, as defined. Administrative expenses are allocated to participant’s accounts based on account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Vesting:** Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company’s contribution to the participants’ accounts is based on years of continuous service. Participant’s eligible to participate in the Plan prior to April 1, 2004, are immediately vested in the Company’s contribution and are 100% vested after four years of credited service thereafter.

**Notes receivable from participants:** Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant’s account and bear a reasonable interest rate commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest is paid ratably through payroll deductions. Interest rates on outstanding loans ranged from 5.25% to 10.5% at December 31, 2024 and 2023. These loans are subject to certain restrictions as defined by the plan document and applicable restrictions under the IRC. For participant loans that become delinquent, the amount of the unpaid loan principal plus any accrued interest will be treated as a deemed distribution. Deemed distributions are reported as a taxable distribution and remain part of the participant’s account balance until a distributable event occurs.

**Payment of benefits:** Upon termination of employment, a participant may withdraw his or her accumulated balances in the Plan. If a participant has reached the age of 59 ½, distributions may be made, at the participant’s election, from any account which are 100% vested without requiring the participant to terminate employment. Only lump sum cash distributions are permitted. Hardship withdrawals are allowed from the participant’s elective account only, consistent with ERISA requirements.

### NOTE 1. DESCRIPTION OF PLAN (Continued)

**Investment options:** The Plan currently offers pooled separate accounts and an investment contract with an insurance company as investment options for participants. These pooled separate account investments generally invest in a mix of stocks, bonds, cash equivalents, and potentially other asset classes, either directly or via underlying investments. The participants may change their investment options at any time.

**Forfeited accounts:** Forfeitures are based on the nonvested portion of the Company's contribution upon employee termination. During the 2024 Plan year, \$9,356 in forfeitures were allocated to participants. The balance of unallocated forfeitures available to offset future employer contributions and expenses amounted to \$7,707 and \$9,505 at December 31, 2024 and 2023, respectively. Forfeitures of nonvested accounts may first be used to pay any administrative expenses and any remaining forfeitures will be used to reduce any Company contributions.

### NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of accounting:** The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America. Accordingly, income is recognized when earned, and expenses are recorded when incurred.

**Use of estimates:** The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Notes receivable from participants:** Notes receivable from participants are measured at their unpaid balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

**Payment of benefits:** Distributions to the participants of the Plan are recorded when paid.

**Administrative expenses:** Certain expenses of the Plan are paid by the Company and are excluded from these financial statements. There is no guarantee that the Company will continue to pay such expenses. Administrative expenses paid by the Plan for the year ended December 31, 2024 totaled \$40,487.

**Investment valuation and income recognition:** Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements. Contributions are invested in unaffiliated pooled separate accounts and an insurance company general account, which is the Fixed Account Insurance General Account at Empower. The investments in all of pooled separate accounts are presented at fair value, with underlying investments based on the quoted market prices of the underlying securities within each fund at December 31, 2024 and 2023. The fair value of common stocks, corporate bonds, and U.S. Government securities are based on the closing price reported on the active market where the individual securities are traded. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as held at year end. Participant loans are valued at cost, which approximates fair value.

**Subsequent events:** The Plan Committee has evaluated subsequent events through October 15, 2025, the date the financial statements were available to be issued. There were no other subsequent events have arisen that would require disclosure in these financial statements.

### NOTE 3. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
Level 2	Inputs to the valuation methodology are observable other than level 1 prices, such as quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means.
Level 3	Inputs to the valuation measurement are unobservable, supported by the little or no market data, and are significant to the fair value of the assets and liabilities.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Pooled separate accounts:* Valued at the number of shares of the underlying fund multiplied by the closing net asset value per share quoted by that fund.

*Insurance general company account:* Valued at the number of shares of the underlying fund multiplied by the closing net asset value per share quoted by that fund.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### NOTE 4. POOLED SEPARATE ACCOUNTS

The Plan entered into pooled separate accounts (PSAs), which are proprietary to Empower and many invest exclusively in one underlying mutual fund traded on an established market. As such, the PSAs begin with a price determined by Empower, and the number of units issued are calculated to match the current fair market value of the underlying mutual fund holdings. This is known as unitizing the underlying assets. However, the rate of return of each will be consistent, taking into account any plan or participant expenses. These PSAs are fully benefit responsive. There are no unfunded commitments, the redemption frequency is daily and the redemption notice period is daily. The PSAs totaled \$4,358,034 and \$3,486,992 as of December 31, 2024 and 2023, respectively. The redemption frequency and redemption notice are daily with all PSAs and there are no unfunded commitments.

### NOTE 5. INSURANCE COMPANY GENERAL ACCOUNT

The Plan has entered into a benefit-responsive investment contract with Empower Trust Company (“Empower”). The Fixed Account investment choice is invested in the insurance company general account of Empower. The account is credited with earnings based upon interest rates set monthly and charged for participant withdrawals and administrative expenses. The contract is included in the financial statements at contract value as reported to the Plan by Empower. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer all or a portion of their investment at contract value.

As described in Note 2, because the Fixed Account is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the Empower contract. There are no reserves against contract value for credit risk of the contract issuer or otherwise. Contract value, which approximates the fair value of the investment contract, was \$2,291,143 and \$2,238,797 at December 31, 2024 and 2023, respectively.

The Plan’s ability to receive amounts due is dependent on the issuer’s ability to meet its financial obligations. The issuer’s ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan’s prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan’s investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

### NOTE 6. PARTY-IN-INTEREST TRANSACTIONS

Certain plan investments are made available by Empower Trust Company, LLC, who is the Trustee as defined by the Plan, and, therefore, these transactions qualify as party-in-interest transactions as defined by ERISA. Fees incurred by the Plan for investment servicing are included in net appreciation (depreciation) in fair value of investments and amounted to, as they are paid through revenue sharing, rather than direct payment.

During the years ended December 31, 2024 and 2023, the Plan made direct payments of \$40,487 and \$18,856, respectively, to third party servicers for recordkeeping, trustee, and investment advisory services, which were not covered by revenue sharing. Of these payments, certain fees of \$2,591 paid to Empower Annuity Insurance Co, the recordkeeper, are considered to be party-in interest transactions under ERISA. The Company pays directly any other fees related to the Plan's operations, other than investment management fees.

### NOTE 7. CERTIFIED INVESTMENT INFORMATION

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company, LLC, a qualified institution.

### NOTE 8. RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500

### NOTE 9. TAX STATUS

The Plan document is a pre-approved prototype plan that received a favorable opinion letter from the IRS dated June 30, 2020, which stated that the Plan, as then designed, was in accordance with applicable sections of the IRC. Although the plan has been amended since receiving the favorable opinion letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the federal or state tax authorities. The Plan's administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **NOTE 10. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100 percent vested in their accounts. Any unallocated assets of the Plan should be allocated to participant accounts and distributed in such a manner as the Company may determine.

### **NOTE 11. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
