### NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

#### NOTE A - PLAN DESCRIPTION

The following description of The SAVE Program for Employees of Viskase Companies, Inc. (the "Plan") provides only general information. Participants should refer to the Plan document, for a more complete description of the Plan's provisions.

##### **General**

The Plan is a defined contribution plan established to provide deferred compensation benefits to eligible employees. Under the Plan, all the employees of Viskase Companies, Inc. (the "Company") who have met the eligibility requirements may elect to participate in the Plan. Employees who are covered by a collective bargaining agreement will be eligible only if their participation is provided for in the agreement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA"). T. Rowe Price Trust Company ("T. Rowe Price" or "Trustee") serves as both the trustee and custodian.

##### **Eligibility**

Regular full-time employees become eligible to participate in the Plan upon employment.

##### **Contributions**

Covered employees may choose to make salary deferral contributions to the Plan of 1% to 75% of their regular pay ("Eligible Earnings") as a basic-deduction contribution on a pre-tax basis or Roth basis. Participants can also elect to classify all or a portion of their salary deferral contributions (up to 16%) as an after-tax deferral. The Plan includes an automatic enrollment feature whereby eligible employees are automatically enrolled in the Plan at 3%. Employees can elect to opt out of the automatic enrollment. Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions to the Plan. In addition, participants are permitted to transfer amounts representing distributions from other qualified plans to the Plan.

The Company will make a safe harbor matching contribution to all non-collective bargaining participants, equal to 100% of the participant's contribution up to 3%, and 50% of the participant's contributions that exceed 3% but do not exceed 5%. Participants covered under a collective bargaining agreement will receive Company matching contributions to the Plan that are equal to 50% of the participant's contributions up to 6% of Eligible Earnings. The Company may make a discretionary contribution known as the Company variable contribution based on the attainment of at least 100% of the annual earnings before interest, taxes, depreciation and amortization ("EBITDA") goals as established by the Board. There were no Company variable contributions for the year ended December 31, 2024.

Contributions are subject to certain Internal Revenue Code (IRC) limitations.

##### **Participant Accounts**

A separate account is established for each participant. The account is credited or charged, as applicable, with the participant's salary deferral contributions, the Company's contributions, the participant's share of investment earnings and losses, and the participant's distributions and certain administrative charges. Allocations are based on participant earnings or account balances, as defined. Participants direct the investment of their account into the various investment options offered by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the vested portion of the participant's account.

**NOTES TO FINANCIAL STATEMENTS - CONTINUED**

**December 31, 2024 and 2023**

***Vesting***

Participant salary deferral contributions plus the earnings thereon are fully vested. If a participant attains age 65 or becomes permanently and totally disabled, dies or is terminated by the Company for reasons other than cause, the full value of the Company contribution account is immediately vested.

A participant's vested interest in their Company safe harbor matching contributions is 100% at all times. A participant's vested interest in their Company matching contributions, Company variable contributions, and any true-up matching contributions is 0% until the participant has completed three years of service, at which time the participant becomes 100% vested.

***Forfeitures***

Forfeitures of a terminated participant are required to be held by the Plan pending the participant's possible return to employment and reinstatement in the Plan. If reinstatement does not occur by the end of the year following the year during which the participant terminated employment, such forfeitures are used to reduce subsequent Company contribution funding. As of December 31, 2024 and 2023, there were unused available forfeitures of \$1,536 and \$3,117, respectively. During 2024, \$28,020 of forfeitures were used to fund Company contributions and \$2,238 of forfeitures were used to offset plan expenses.

***Payment of Benefits***

On termination of service, participants with account balances in excess of \$5,000 may elect to either receive a single-sum amount or defer payment until the April 1 following the year the participant reaches age 72. Participants who terminate employment with account balances less than or equal to \$5,000 receive a single-sum payment. Participants may choose to make a direct rollover into another qualified plan or into an Individual Retirement Account ("IRA"). Spouse beneficiaries may make a direct rollover into an IRA. Non spouse beneficiaries may not make a direct rollover into an IRA. Participants may elect to receive installment payments under the Plan. Payment to any participant must begin no later than the April 1 following the year the participant reaches age 72, even if he or she has not retired. Effective January 1, 2023, the age was increased to 73 pursuant the Setting Every Community Up for Retirement Enhancement Acct ("SECURE 2.0 Act"). The Plan permits participants to make withdrawals while they are employed and permits hardship withdrawals of pre-tax contributions in accordance with IRC requirements. The Plan sets out the limits and priority of any withdrawal.

***Notes Receivable from Participants***

Participants may borrow from their vested fund accounts, a minimum of \$1,000 up to a maximum loan amount that is limited to the lesser of \$50,000 reduced by the highest outstanding loan balance in the previous 12 months or 50% of a participant's account balance. The loans are secured by the balance in the participant's account and bear interest at a fixed rate commensurate with the interest rate charged by area banking institutions for loans made under similar circumstances. The period for loan repayment cannot exceed five years from the date of the loan, unless the loan is for the purchase of a principal residence, in which case the repayment period cannot exceed 10 years. Principal and interest are paid ratably through payroll deductions. Interest rates on outstanding loans were 3.25% to 8.50% at December 31, 2024 and 2023.

**NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

***Basis of Accounting***

The financial statements of the Plan are prepared on the accrual basis of accounting.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("US GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant's loan to be in default, the participant's loan balance is reduced, and a benefit payment is recorded.

***Other Income***

T. Rowe Price Retirement Plan Services, Inc. ("TRP") receives pricing credits associated with certain investments in the Plan and allocates those pricing credits to participants in proportion to their account balances invested in those options.

***Payment of Benefits***

Benefits are recorded when paid.

***Expenses***

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments. The recordkeeper of the Plan charges a quarterly administrative fee that is charged directly to the participant accounts.

***Subsequent Events***

Effective September 28, 2025, the Plan was amended to change the safe harbor matching contribution to 100% of participants' contributions up to 3% and 60% of participants' contributions that exceed 3% but do not exceed 5%.

Plan management has evaluated subsequent events through October 15, 2025, the date the financial statements were available to be issued and has determined that there were no other subsequent events which would require recognition or disclosure in these financial statements.

**NOTE C - FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the Financial Accounting Standards Board Accounting Standards Codification 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

*Mutual funds* - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective trust funds* - A stable value fund valued at the NAV of units of the collective trust. The NAV is calculated by the fund based on net assets, which includes fully benefit-responsive investment contracts at contract value. This NAV represents the Plan's fair value since this is the amount at which the Plan transacts with the fund and is used as a practical expedient to estimate fair value.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with industry practices, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE D - STABLE VALUE FUND**

The Plan's investments include an investment in the T. Rowe Price Stable Value Fund (the "Fund"), a collective trust fund that is considered to be a stable value fund with underlying investments in fully benefit-responsive investment contracts. Fair value of the stable value fund is the NAV of the Fund. The Fund is an open-end commingled pool dedicated exclusively to the management of assets of defined contribution plans. The Fund's investment objective is to maximize current income consistent with the maintenance of principal and to provide for withdrawals for certain participant-initiated transactions under a retirement plan without penalty or adjustment. To achieve its investment objective, the Fund invests in underlying assets (typically fixed income securities or bond funds and may include insurance contracts) and enters into a "wrapper" contract issued by a third party. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. Withdrawals, other than for benefit payments and participant transfers to noncompeting investment options may be made up to one year after notification is received.

**NOTE E - INFORMATION PREPARED AND CERTIFIED BY THE TRUSTEE**

The Plan administrator has elected to have the audit performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The Plan administrator determined that the certification received from T. Rowe Price, the Trustee of the Plan, meets the requirements of ERISA Section 103(a)(3)(C). The Trustee certified that the following information included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments, at fair value and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income, interest income on notes receivable from participants, and other income, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule H, line 4i - schedule of assets (held at end of year) as of December 31, 2024.

**NOTE F - TRANSACTIONS WITH PARTIES-IN-INTEREST**

Certain Plan investments are held and managed by T. Rowe Price. T. Rowe Price is the Trustee for the Plan. Therefore, these transactions qualify as party-in-interest transactions that are exempt from the prohibited transaction rules. Notes receivable from participants also qualify as allowable party-in-interest transactions.

**NOTE G - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become fully vested in the Company contribution portion of their accounts.

**NOTE H - TAX STATUS**

The Internal Revenue Service ("IRS") has issued an opinion letter dated August 19, 2020 stating that the form of the T. Rowe Price Retirement Plan Services, Inc. volume submitter plan used by the Plan is

acceptable under section 401 of the IRC. The Plan has been amended since the opinion letter was issued; however, the Plan administrator believes that the Plan is designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

US GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS or other applicable taxing authorities. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE I - RISK AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is a least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
