## **1. Description of Plan**

The following description of the Sun, Inc. 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants may refer to the Plan document for a more complete description of the Plan’s provisions.

### **General**

Sun, Inc. (the “Company”) sponsors this defined contribution 401(k) plan to provide retirement benefits to substantially all its employees. The Plan also includes employees of Consolidated Mailing Services, LLC. Effective October 15, 2023, the Plan was amended and restated to maintain its exemption from Federal income taxes under Section 501(a) of the Internal Revenue Code (“IRC”), to comply with the requirements of the Employee Retirement Income Security Act of 1974 (“ERISA”), and to help achieve the business objectives of the Company. The Plan was amended to update allocation conditions surrounding non-elective contributions in the case of participant terminations.

### **Eligibility of Participants**

Full-time employees who are eighteen years of age and have completed one hour of service within their first ninety days of employment are eligible to participate in the Plan. For part-time employees, completion of one thousand hours of service in any Plan year grants eligibility to participate in the Plan.

### **Participant Accounts**

Each participant's account is credited with the participant's contributions, allocations of the Company's contributions, plan earnings or losses, and charged with an allocation of any administrative expenses paid by the Plan. Participants direct their contributions into various investment options offered by the Plan. Earnings or losses are allocated by account based on the ratio of a participant's account invested in a particular account to all participants' investments in that account.

### **Contributions**

Participants may contribute up to 100% of their eligible compensation, within the limits allowable under the law, to the Plan. Participants who have attained age fifty before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing rollover distributions from other qualified benefit plans. Participants are allowed to designate all or a portion of their contributions as Roth contributions. The Plan allows for discretionary matching contributions equal to a percentage of each participant's elective deferrals, the percentage to be determined each year by the Company.

**Contributions (continued)**

The Company made discretionary matching contributions to the Plan of approximately \$96,000 and \$62,000 during the years ended December 31, 2024 and 2023, respectively. Employer discretionary profit-sharing contributions may also be made to the Plan at the option of the Company. The Company did not make any discretionary profit-sharing contributions to the Plan during the years ended December 31, 2024 and 2023.

**Vesting**

Participants are immediately 100% vested in their elective contributions. Vesting in employer contributions is based on years of continuous service. Participants become 20% vested in employer contributions after two years of service, and become vested in an additional 20% of these contributions each year, becoming fully vested in employer contributions after six years of continuous service.

**Plan Termination**

Although it has not expressed any intent to do so, the Company has the right, under the Plan, to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Company contributions.

**Notes Receivable from Participants**

Under the terms of the Plan, participants may borrow from their accounts, subject to certain restrictions. Participants may borrow from their accounts a minimum of \$1,000 (\$500 through October 15, 2023) up to a maximum of the lesser of \$50,000 or 50% of their vested account balance. Notes receivable from participants are collateralized by the balance in the participant's account and bear interest at rates ranging from 4.25% to 9.50% as of December 31, 2024. Loan terms range from one to five years, except for loans made for the purchase of a primary residence which must be repaid within a period of no more than 10 years. The loan interest rate, determined quarterly, is set at 1% above the prime rate at the date of origination. Principal and interest are paid ratably through payroll deductions, and participants may have only one outstanding loan at a time.

**Payment of Benefits**

Upon termination of service due to death, disability, or retirement, a participant may, subject to certain conditions, elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over a specified period. If a participant's vested account balance does not exceed \$5,000, the Plan may automatically distribute the participant's vested account balance in a lump sum. Also, subject to certain conditions, a participant may receive hardship withdrawals from his or her balance in the Plan while employed. Participants who have attained 59½ years of age are permitted to withdraw all or part of their vested accounts as in-service distributions.

**Forfeited Accounts**

Forfeited employer matching and profit sharing contributions may be used at the discretion of the Plan administrator. There were no forfeited nonvested accounts at December 31, 2024 and 2023. No forfeited nonvested funds were used during the year ended December 31, 2024. Discretionary employer matching contributions of approximately \$10,000 were made during the year ended December 31, 2023 from forfeited nonvested accounts.

**Administrative Expenses**

Expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses paid by the Company are excluded from the accompanying financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

**2. Basis of Presentation and Summary of Significant Accounting Policies**

**Basis of Accounting**

The accompanying financial statements are prepared in accordance with accounting principles generally accepted in the United States ("US GAAP").

**Estimates**

The preparation of financial statements in conformity with US GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of changes in net assets during the reporting period. Actual results could differ from those estimates.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. If a participant does not make loan repayments and the Plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a distribution based on the terms of the Plan document.

**Investment Valuation and Income Recognition**

Investments in pooled separate accounts are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

The Plan's investments include the Guaranteed Interest Contract, a fully benefit-responsive guaranteed interest contract with Sentry Life Insurance Company ("Sentry"). Sentry maintains the contributions in a general account. Sentry is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed interest contract meets the criteria to be fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed interest contract. The guaranteed interest contract is presented on the face of the statements of net assets available for plan benefits at contract value. Contract value, as reported to the Plan by Sentry, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

**Investment Valuation and Income Recognition (continued)**

Certain events limit the Plan's ability to transact at contract value with Sentry. Such events include the following: (a) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the Plan sponsor or other Plan sponsor events that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transactions exemption under ERISA.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Risk and Uncertainties**

The Plan's investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of certain investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the accompanying 2024 statement of net assets available for plan benefits.

**Payment of Benefits**

Benefits are recorded when paid.

**3. Custodian Certifications**

Information disclosed in the accompanying financial statements as of and for the years ended December 31, 2024 and 2023, related to investments, notes receivable from participants, net appreciation in fair value of investments, and interest income on notes receivable from participants, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Sentry, the custodian of the Plan effective October 15, 2023, and John Hancock Life Insurance Company, the custodian of the Plan through October 14, 2023.

#### **4. Fair Value Measurements**

US GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs to the valuation methodology are unobservable and have the lowest priority. None of the Plan's investments as of December 31, 2024 and 2023 were measured using valuation techniques that were part of the US GAAP fair value hierarchy.

Pooled separate accounts are valued at net asset value ("NAV"). The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the pooled separate account less its liabilities. This practical expedient is not used when it is determined to be probable that the pooled separate account will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of any of the pooled separate accounts, the investment advisor reserves the right to temporarily delay withdrawal from the account in order to ensure that security liquidations will be carried out in an orderly business manner. All Plan assets reported at fair value are valued using NAV.

The methods used to measure fair values may produce amounts that may not be indicative of net realizable values or reflective of future fair values. Furthermore, although Plan management believes the valuation methods used are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair values of certain financial instruments could result in a different fair value measurement at the reporting date.

#### **5. Party-in-Interest Transactions**

All of the plan investments were managed by the Plan's custodians. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of investments, as they are paid through revenue sharing rather than a direct payment. The Plan made direct payments to the custodians totaling approximately \$6,000 and \$20,000 for the years ended December 31, 2024 and 2023, respectively, that were not covered by revenue sharing. These transactions qualify as party-in-interest transactions and are exempt from the prohibited transactions rules of ERISA.

## **6. Income Tax Status**

The Plan is a non-standardized prototype plan, provided by Sentry, designed to be in compliance with the applicable requirements of the IRC. The Internal Revenue Service (“IRS”) has determined by a letter dated June 30, 2020, that the prototype plan, as then designed, was in accordance with applicable sections of the IRC. Although the Plan has been amended since June 30, 2020, the Plan administrator believes that the Plan is currently designed and is being operated in compliance with the applicable requirements of the IRC and therefore, believes that the Plan is qualified and the related trust is tax-exempt.

During 2023, the Company inadvertently failed to deposit \$47,534 of participant deferrals within the timeframe required by the Department of Labor (“DOL”). During 2024, the Company inadvertently failed to deposit \$32,033 of participant deferrals within the timeframe required by the DOL. All delinquent contributions were deposited to the participant accounts in 2023 and 2024. Earnings on delinquent contributions from 2023 and prior were calculated and remitted in 2025. Earnings on delinquent contributions related to 2024 have not yet been calculated.

During 2023, operational errors were discovered related to the incorrect allocation of employer matching contributions to a participant’s account, and excess contributions from participants. Management fully corrected these operational issues in 2025.

Additional operational errors occurred in 2024. As of the date the financial statements were available to be issued, management has not fully quantified the impact of these errors but expects all corrections to be made during 2025 to preserve the Plan’s tax-exempt status.

It is uncertain what effect these operational errors may have on the Plan’s tax-exempt status, but the Plan administrator believes any Plan errors will be fully corrected and there is ultimately no threat to the Plan’s tax-exempt status. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

US GAAP requires the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. No such liabilities were identified at December 31, 2024 and 2023. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

## **7. Subsequent Events**

Management evaluated events and transactions after December 31, 2024 through October 14, 2025, the date the financial statements were available to be issued, for subsequent events. No events requiring disclosure were identified, except as discussed in Note 6.
