**Report of Independent Auditors**

To the Participants and Trustees of  
Minnesota and North Dakota Bricklayers  
and Allied Craftworkers Vacation Fund

**Opinion**

We have audited the financial statements of Minnesota and North Dakota Bricklayers and Allied Craftworkers Vacation Fund (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of Minnesota and North Dakota Bricklayers and Allied Craftworkers Vacation Fund as of December 31, 2024, and the changes in its net assets available for benefits for the year then ended, in accordance with accounting principles generally accepted in the United States of America.

**Basis for Opinion**

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditors' Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. **Other Matter - 2023 Financial Statements**

The financial statements of Minnesota and North Dakota Bricklayers and Allied Craftworkers Vacation Fund as of December 31, 2023, were audited by other auditors whose report dated September 24, 2024, expressed an unmodified opinion on those statements.

As part of our audit of the 2024 financial statements, we also audited the adjustments described in Note 9 that were applied to restate the financial statements as of January 1, 2024. In our opinion, such adjustments are appropriate and have been properly applied. We were not engaged to audit, review or apply any procedures to the 2023 financial statements of the Plan other than with respect to the adjustments, and accordingly, do not express an opinion or any other form of assurance on the 2023 financial statements as a whole.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditors' Responsibilities for the Audit of the Financial Statements***

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. # Minnesota and North Dakota Bricklayers and Allied Craftworkers Vacation Fund

## Notes to Financial Statements

December 31, 2024 and 2023

### Note 1. Description of the Plan

Minnesota and North Dakota Bricklayers and Allied Craftworkers Vacation Fund (the Plan) was established in 1964 as a result of collective bargaining agreements between the local union and the contractors' association. The Plan is a multiemployer defined contribution vacation (welfare) plan subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan is managed by a board of trustees consisting of an equal number of union and employer representatives.

The Plan covers members of the local union employed under the terms of collective bargaining agreements with participating employers. Participants become eligible when their employer begins to make contributions to the Plan on their behalf under the terms of any applicable collective bargaining agreement.

An individual account is established for each participant. Contributions received on the participant's behalf are credited to their account following the end of the calendar year in which they are received. No earnings or losses are credited to participants' accounts. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account. Distributions are made twice each year in the following manner: 70% paid on or after May 1 and 30% on December 1.

Participants are provided a debit card to access the amounts credited to their account. In addition, participants may request payment of union dues and fees from their account, or payments to Minnesota and North Dakota Bricklayers and Allied Craftworkers Apprenticeship Fund for costs and tuition.

Benefits unclaimed after two years are forfeited to the Plan. Participants' accounts may be re-credited upon subsequent claim, at the Trustees' discretion, and as allowed by the Plan. No forfeitures were incurred during the year ended December 31, 2024. Net assets available for benefits include \$489,330 and \$291,856 of unallocated reserves at December 31, 2024 and 2023, respectively. Unallocated amounts are used to pay Plan administrative expenses and, upon Trustee approval, allocated as income to participant accounts.

Subsequent to year end, the Plan was amended effective in April 2025, switching from debit cards to establishing individual accounts at financial institutions. Any remaining unused balances in the debit cards will be pulled from the debit card and sent to the financial institution under the participant's designated account. The schedule to distribute benefit amounts remains unchanged. Benefits are distributed via direct deposits. Participants have the ability to receive the benefit amount in a check in lieu of a direct deposit, subject to a \$50 fee.

Participants should refer to the summary plan description for more complete information.

## **Note 2. Summary of Significant Accounting Policies**

**Method of Accounting** - The accompanying financial statements have been prepared using the accrual basis of accounting.

**Contributions Receivable** - Employer contributions due and not paid at year end are recorded as contributions receivable. Contributions owed as a result of payroll compliance audits are recorded upon settlement with the employer. An allowance for doubtful accounts is considered unnecessary and is not provided.

**Investments** - Investments are reported at fair value. The fair value of a financial instrument is the amount that would be received to sell that asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (the exit price). Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Purchases and sales of investments are reflected on a trade-date basis.

Interest income is recorded on the accrual basis.

**Revenue Recognition** - Revenue derived from employer contributions is recognized in the period in which covered work is performed, based on the number of hours worked in covered employment and the contribution rates currently in effect, as set forth in the collective bargaining agreement. Employers are required to remit contributions monthly. The Plan carries out its purpose described in Note 1 primarily in Minnesota and North Dakota.

**Payment of Benefits** - Benefit payments to participants are recorded upon distribution. There were no benefits that were approved for payment that had not been paid at either December 31, 2024 or 2023.

**Expenses** - Certain investment related expenses are included in net appreciation in fair value of investments.

**Estimates** - The preparation of financial statements in accordance with generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures in the financial statements. Actual results could differ from those estimates.

**Subsequent Events** - Subsequent events have been evaluated through September 9, 2025, which is the date the financial statements were available to be issued.

## **Note 3. Priorities upon Termination**

It is the intent of the Trustees to continue the Plan in full force and effect; however, the right to discontinue the Plan is reserved to the Trustees. In the event of termination, the net assets of the Plan will be allocated to pay benefits in priorities as prescribed by ERISA and its related regulations. Termination shall not permit any part of the Plan assets to be used for or diverted to purposes other than the exclusive benefit of the participants. Whether or not a particular participant will receive full benefits should the Plan terminate at some future time will depend on the sufficiency of the Plan's net assets at that time and the priority of those benefits.

#### **Note 4. Tax Status**

The Plan obtained a notice of exemption dated December 22, 1970, in which the Internal Revenue Service stated that the trust established under the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the notice of exemption. The Plan's administrator and the Plan's legal counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code, and therefore believe that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require the Plan to evaluate tax positions taken and recognize a tax liability if the Plan has taken uncertain tax positions that more likely than not would not be sustained upon examination by tax authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **Note 5. Fair Value Measurements**

The *Fair Value Measurements and Disclosures* Topic of the Financial Accounting Standards Board Accounting Standards Codification established a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

##### Basis of Fair Value Measurement

Level 1	Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities
Level 2	Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly
Level 3	Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable

The Plan's investments in mutual funds are classified within Level 1 of the fair value measurements hierarchy.

The fair values of the mutual funds are determined by reference to the funds' underlying assets, which are principally marketable fixed income and equity securities. Shares held in mutual funds are traded on national securities exchanges and are valued at the net asset value as of the last business day of each period presented.

**Note 5. Fair Value Measurements (continued)**

Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits. The current economic environment has increased the degree of uncertainty.

The Plan has a significant portion of its assets invested in two mutual funds, a balanced fund and a short-term fixed income fund that represented approximately 58% and 39%, respectively, of the Plan's net assets available for benefits as of December 31, 2024. The balanced fund and short-term fixed income fund represented approximately 54% and 41%, respectively, of the Plan's net assets available for benefits as of December 31, 2023. It is reasonably possible that changes in the values of these investments could materially affect the participants' account balances and amounts reported in the statements of net assets available for benefits.

**Note 6. Concentration of Cash**

Cash consists of monies held in checking accounts without significant withdrawal restrictions. The Plan maintains cash balances with a financial institution deemed to be creditworthy. Balances are insured by the Federal Deposit Insurance Corporation up to \$250,000. At December 31, 2024, the Plan's cash balances exceeded federally insured limits by approximately \$929,000. Plan management believes its credit risk to be minimal.

**Note 7. Funding Policy**

The Plan is primarily funded by employer contributions as specified in the collective bargaining agreements. Hourly contribution rates ranged from \$0.30 to \$2.80 during the year ended December 31, 2024.

**Note 8. Related Organizations**

The Plan is related to a health and welfare plan, a pension plan, a defined contribution retirement plan, an apprenticeship fund, a non-profit service corporation and a local union, all of which are tax-exempt.

**Note 8. Related Organizations (continued)**

The service corporation was organized and established to serve in a fiduciary capacity as the servicing and collection agent for the related tax-exempt organizations. The service corporation maintains a receiving agency account. Contributions for the Plan and related organizations are received and deposited in the receiving agency account. Amounts owed are routinely transferred to the respective organizations. No amounts were due from the service corporation at either December 31, 2024 or 2023.

The Plan has an administrative services agreement with the related local union, under which participants may assign their vacation savings benefits or a portion thereof to the local union for payment of membership dues. Participants must provide written authorization to the Plan before such distributions are made. Included in benefits paid are authorized transfers of membership dues totaling \$415,657 from participant accounts during the year ended December 31, 2024.

**Note 9. Prior Period Restatement**

Certain amounts as of January 1, 2024, were restated to correct the following misstatements:
