INDEPENDENT AUDITOR'S REPORT

To the Management of TF Fitness OPCO LLC and Plan Participants of TF Fitness OPCO LLC, 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of TF Fitness OPCO LLC, 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of TF Fitness OPCO LLC, 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section –

Basis for Opinion

1. DESCRIPTION OF THE PLAN

The following description of the TF Fitness OPCO LLC, 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan sponsored by TF Fitness Opco, LLC (the “Company”) and was established effective January 1, 2012, to provide retirement benefits for eligible employees of the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

Plan Administration

During 2024 and 2023, Reliance Trust Company (“Reliance” or the “Trustee”) served as the trustee of the Plan’s investment assets, executing investment transactions at the direction of Plan participants, receiving contributions and investment income, paying administrative expenses, and making distributions to participants. ADP Retirement Services (“ADP RS”) maintains participant account information, performs annual compliance testing and prepares the Plan’s Form 5500. During 2024 and 2023, Millennium Trust Company served as the rollover individual retirement account (“IRA”) custodian, and Financial Engines Advisors, LLC provided investment advisory services.

Basic clerical and administrative functions of the Plan are performed by employees who are appointed by the board of directors of the Company. The Company serves as the Plan’s administrative committee and is the named fiduciary of the Plan. No employee or the Company receives compensation for services.

Eligibility

Employees become eligible to participate in the Plan after reaching age 18 and completing six months of service. For purposes of determining eligibility, one hour of service in a month is equivalent to one month of service. The Plan excludes employees who are nonresident aliens and residents of Puerto Rico.

Contributions

The Plan features an automatic enrollment provision with an 8% deferral of eligible compensation. If newly eligible employees have not submitted investment elections and have not opted-out of contributing or elected a different rate of deferral, automatic deferrals commence on the first of the month following satisfaction of the eligibility provisions. The initial automatic deferral amount will increase by 1% each February up to a maximum of 10%.

Each year, participants may contribute to their combined pre-tax and/or Roth after-tax accounts up to 80% of their eligible compensation, as defined by the Plan. Participants who have attained age 50, before the end of the plan year and make the maximum allowable deferral to the Plan, are eligible to make catch-up contributions. For the year ended December 31, 2024, the combined pre-tax deferral and Roth contribution limit is \$23,000, and the catch-up contribution limit is \$7,500.

At any time, employees may also contribute amounts representing rollover distributions from other qualified plans. Employees who make rollover contributions into the Plan before satisfying the eligibility requirements are treated as participants for all purposes other than making participant contributions. In-plan Roth rollover contributions are permitted.

The Plan does not permit employer contributions.

Investment Options

Participants direct the investment of their contributions into various investment options offered by the Plan. The investment options include mutual funds and common collective trust funds with various investment objectives. If participants do not elect specific investments, their contributions are invested in the Plan's qualified investment alternative funds, a target date retirement series.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of Plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings (losses), account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings (losses) thereon.

Notes Receivable from Participants

Participants are allowed to borrow from their accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The term of the note cannot exceed five years, except in the case of a loan used to acquire a participant's principal residence, for which the term cannot exceed 30 years.

The loans are secured by the balance in the participant's account and bear interest at the prime rate plus 2%. Notes receivable from participants, as of December 31, 2024, bear interest rates of 9.5% to 10.5%. Maturities as of December 31, 2024, are March 2025 through August 2029. Principal and interest is paid ratably through payroll deductions.

Benefit Payments

The normal retirement age is 65. On termination of service due to death, disability, or termination of employment, participants may receive the value of the participant's interest in his or her account. Participants may elect certain in-service withdrawals from their accounts, including qualified reservists distributions and other withdrawals after attaining age 59-1/2. In the event of hardship due to an immediate and heavy financial need, as defined by the Plan and as modified by recent legislation, a participant may request a hardship withdrawal.

Distributions under the Plan may be made in lump-sums, substantially equal installments, or partial withdrawals (\$500 minimum) in cash only. The Plan provides for involuntary cash-outs if a terminated participant makes no affirmative election to receive or roll over his or her account balance of \$5,000 or less. Involuntary cash-out balances of \$1,000 or less are automatically rolled over to an IRA for the benefit of the participant.

Recent Legislative Changes to Plan Provisions

Changes to Plan provisions have been or may be made due to the enactment in recent years of various laws. Some of the changes are required by law and some become effective only if adopted by the Plan. Changes which may affect participants relate to required minimum distributions, disaster-related distributions, repayment of Coronavirus-related distributions, distribution of lifetime income investments, and participation of long-term, part-time employees.

Plan Termination

As the result of being acquired, on January 7, 2025, the Company approved termination of the Plan effective February 28, 2025. Because the Plan does not permit employer contributions and participants are vested immediately in their contributions and rollover contributions and actual earnings thereon, all participants in the Plan were fully vested in their account balances at the date of the termination. Participant account balances were distributed during 2025 in accordance with participant requests. Participant account balances remaining after 60 days of the termination date were rolled into an IRA for the benefit of the participant at American Century Investments, the rollover IRA custodian. All remaining funds were disbursed from the Plan in August 2025.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The significant accounting policies employed in the preparation of the accompanying financial statements are as follows:

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Company determines the Plan's valuation policies utilizing information provided by the investment advisor and the trustee. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from Plan participants are recorded in the year in which the employee contributions are withheld from compensation.

Notes Receivable

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the Plan Administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent note receivable is recorded as a benefit payment based on the terms of the Plan document.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service ("IRS") are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 excess contributions and related earnings (losses) of \$785 to the applicable participants prior to March 15, 2025. There were no 2023 excess contributions required to be distributed.

Payment of Benefits

Benefit payments to participants are recorded when paid. At December 31, 2024, there were no benefits approved for payment but not paid.

Administrative Expenses of the Plan

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of benefit payments and notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

Recently Issued Accounting Pronouncements

Recently issued accounting standards that have been issued or proposed by the FASB or other standards-setting bodies which have not yet been adopted by the Plan are not expected to have a material impact on the Plan's financial position or results of activity.

3. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB Accounting Standards Codification ("ASC") 820 are described as follows:

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for the assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective trusts: Valued at the net asset value units of a bank collective trust. The net asset value, as provided by the trustee, is used as a practical expedient to estimate fair value. The net asset value is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

4. CERTIFIED INVESTMENTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, dividends, and participant loan interest for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company, the trustee of the Plan.

5. RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Plan participants may borrow from their accounts; therefore, notes receivable from participants qualify as party-in-interest transactions. Fees paid to ADP, Inc., a related party, include \$10,894 for recordkeeper fees. These party-in-interest and related party transactions are exempt under ERISA.

6. PLAN TERMINATION

The Company has reserved the right to terminate the Plan at the discretion of the governing body or to amend the Plan at any time and in any respect. However, no such action may deprive any participant or beneficiary under the Plan of any vested right. Participants are always 100 percent vested in their contribution accounts.

7. TAX STATUS

The Plan document is supported by the ADP, LLC favorable opinion letter dated October 6, 2020, from the Internal Revenue Service (“IRS”) stating that the form of the plan is acceptable under Internal Revenue Code 401.

The Plan Administrator believes the Plan, as adopted and amended, is designed and is being operated in compliance with the applicable provisions of the Code, and therefore believes that the Plan is qualified and the related trust is tax-exempt.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by applicable authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
