### Report on the Audit of the Financial Statements

#### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of AllCare Health 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of AllCare Health 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and the year ended December 31, 2024, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

#### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- the information in the accompanying financial statements related to assets held by and certified to by qualified institutions agree to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. ## AllCare Health 401(k) Plan Notes to Financial Statements

---

### Note 1 – Description of Plan

The following description of the AllCare Health 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan agreement, as amended, for a more complete description of Plan provisions.

**General** – The Plan is a 401(k) salary deferral and profit sharing plan covering substantially all employees of AllCare Management Services LLC (the Company) and is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Company is the Plan's sponsor and serves as Plan administrator. During the year ended December 31, 2024, the Plan changed its custodian from Charles Schwab Trust Bank to Reliance Trust Company. The transition occurred in January 2024 and involved the transfer of all Plan assets held by Charles Schwab Trust Bank to Reliance Trust Company.

**Eligibility** – Employees of the Company are eligible to participate in the Plan upon hire, with a minimum age requirement of 18. Participants must complete 1,000 hours of service during the 12 months following date of hire to be eligible to receive employer safe harbor and profit sharing contributions.

### Contributions

*Participant contributions* – Each year, participants may contribute between 1% to 90% of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated fund until elected otherwise by the participant.

*Employer safe harbor and employer matching contributions* – The Company makes non-elective safe harbor profit sharing contributions equal to 4% of the participant's eligible compensation. The Company may elect to make a discretionary matching contribution to the Plan. The Company elected to contribute 1% for the Plan year ended December 31, 2024. Employer contributions for the year ended December 31, 2024, were \$1,056,934.

Contributions are subject to regulatory limitations.

**Participant accounts** – Each participant's account is credited with the participant's contributions and Company matching contributions as well as allocations of the Company's safe harbor profit sharing contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of their contributions into various investment options offered by the Plan.

## AllCare Health 401(k) Plan Notes to Financial Statements

---

**Vesting** – Participants are immediately vested in their elective contributions and safe harbor profit sharing contributions. Vesting in the Company’s discretionary matching contributions is based on a three-year cliff vesting schedule. A participant is 100% vested after three years of credited service.

**Notes receivable from participants** – Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are issued by the Plan and secured by the balance in the participant’s account. All loans must be repaid within a period of five years, unless the loan is used to purchase a principal residence, in which case, the loan must be repaid within a reasonable period of time, not to exceed 15 years. Under the terms of the agreement, Plan loans bear the Prime rate of interest plus two percentage points and is fixed as of the date of the loan. Principal and interest is paid ratably through biweekly payroll deductions. As of December 31, 2024, the rates of interest on outstanding loans ranged from 5.25% to 10.50%, with various maturities through June 2035.

**Payment of benefits** – On termination of service due to death, disability, or retirement, a participant (or their beneficiary) may elect to receive either a lump sum amount equal to the value of the participant’s vested interest in his or her account, or annual installments. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. For terminated participants with vested account balances less than \$5,000, the vested benefit automatically will be rolled over into an IRA selected by the Plan administrator unless a lump sum distribution is requested by the participant.

**Forfeitures** – Forfeitures are the non-vested portion of a participant’s account that is lost upon termination of employment. Forfeitures are retained in the Plan and will first be used to pay plan administrative expenses, with any remaining amount used to reduce future Company contributions. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$10 and \$14,869, respectively. For the year ended December 31, 2024, Company matching contributions were reduced by \$42,707 from forfeited nonvested accounts.

### **Note 2 – Summary of Significant Accounting Policies**

**Basis of accounting** – The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP), using the accrual method of accounting.

**Use of estimates** – The preparation of financial statements in conformity with GAAP requires the use of estimates and assumptions that may affect certain amounts and disclosures. Accordingly, actual results could differ from those estimates.

## **AllCare Health 401(k) Plan Notes to Financial Statements**

**Investment valuation** – The investments are reported at fair value. The Plan’s custodians, Reliance Trust Company and Charles Schwab Trust Bank, certify the fair value of all investments. If available, quoted market prices are used to value investments.

Fair value is the price that would be received to sell an asset or paid to transfer a liability (the exit price) in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

**Income recognition** – Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. The net appreciation in fair value of investments consists of both the realized gains and losses and unrealized appreciation and depreciation of those investments.

**Contributions** – Contributions from participants and corresponding employer contributions are recorded in the year in which the employee contributions are withheld from compensation.

**Notes receivable from participants** – Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions upon the occurrence of a distributable event, based on the terms of the Plan agreement.

**Payment of benefits** – Benefits are recorded when paid.

**Expenses** – General Plan administrative expenses may be paid out of the forfeiture account or paid by the Company. Investment management, distribution, and loan transaction fees are paid by the Plan participants.

**Subsequent events** – Subsequent events are events or transactions that occur after the statement of net assets available for benefits date but before the financial statements are available to be issued. The Plan recognizes in the financial statements the effects of all subsequent events that provide additional evidence about conditions that existed at the date of the statement of net assets available for benefits, including the estimates inherent in the process of preparing the financial statements. The Plan’s financial statements do not recognize subsequent events that provide evidence about conditions that did not exist at the date of the statement of net assets available for benefits but arose after the statement of net assets available for benefits date and before the financial statements were available to be issued.

The Plan has evaluated subsequent events through October 15, 2025, which is the date the financial statements were available to be issued.

### **Note 3 – Fair Value Measurements**

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3).

The three levels of the fair value hierarchy are described as follows:

**Level 1** – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Registered investment companies (mutual funds)* – Valued at the daily closing price as reported by the fund. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission.

*Collective trust (stable value fund)* – Units held in stable value fund (SVF) are valued using the net asset value practical expedient (NAV practical expedient) of the SVF as reported by the SVF managers. The NAV practical expedient is based on the fair value of the underlying assets owned by the SVF, minus its liabilities, and then divided by the number of units outstanding. The NAV practical expedient of a collective investment is calculated based on a compilation of primarily observable market information.

The number of units of the trust that are outstanding at the calculation date is derived from observable purchase and redemption activity in the trust. The Plan invests in the following collective trust:

Goldman Sachs Stable Value Fund is a collective investment trust fund that holds accounts in the name of the Goldman Sachs Trust Company, N.A. The collective trust fund's investment objective is to earn current income and preserve capital and stability of principal. Additionally, the fund seeks to maintain a stable value of \$1.00 per unit. The fund invests in stable value investment contracts and in fixed income instruments with underlying stable value contracts as well as in money market instruments. The Stable Value Fund contract includes a 90-day restriction from direct transfers from the Stable Value Fund to other competing fund options.

### Note 4 – Tax Status

The Internal Revenue Service has determined and informed the Company by a letter dated October 6, 2020, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

In accordance with guidance on accounting for uncertainty in income taxes, management has evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **Note 5 – Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. It is reasonably possible, given the level of risk associated with investment securities, that changes in the values of the investments in the near term could materially affect a participant's account balance and the amounts reported in the statements of net assets available for benefits.

### **Note 6 – Certified Investment Information**

- Investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024.
- Net appreciation in fair value of investments, dividends and interest income on notes receivable from participants on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investments reflected on the schedule of assets (held at end of year) as of December 31, 2024.

The following information related to investments was obtained by management and agreed to or derived from information certified as complete and accurate by Charles Schwab Trust Bank to Reliance Trust, a qualified institution:

- Investments reflected on the accompanying statements of net assets available for benefits as of December 31, 2023.

### **Note 7 – Party-in-Interest Transactions**

Certain Plan investments are managed by Reliance Trust Company. Reliance Trust Company is the trustee of the Plan and, therefore, transactions with these entities qualify as exempt party-in-interest transactions.

### **Note 8 – Plan Termination**

Although it has not expressed any intention to do so, the Company has the right to terminate the Plan and discontinue its contributions at any time, subject to the provisions of ERISA. If the Plan is terminated, amounts allocated to a participant's account become fully vested.

### **Note 9 – Delinquent Participant Contributions**

Certain employee deferrals were not remitted to the Plan within the timeframe required by the Department of Labor. The Company is determining the amount of related lost earnings and is working on remitting these amounts to participants' accounts for 2022 deferrals of \$1,135,667 and 2023 deferrals of \$1,138,359, subsequent to year end.
