Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Total Plastic Solutions, LLC Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) audit. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state of federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section –

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Total Plastic Solutions, LLC Retirement Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.





Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Total Plastic Solutions, LLC Retirement Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Note 1 - Description of Plan

The following description of the Total Plastic Solutions, LLC Retirement Plan, (the “Plan”), provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan was established in September 1, 2019 as a single employer defined contribution plan to provide retirement benefits to eligible employees of Total Plastic Solutions, LLC (“the Company”). The Plan name changed effective August 1, 2023. The Plan was restated April 1, 2024 with the change in custodian. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Contributions

Each year, participants may contribute up to 60% of pre-tax annual compensation, as defined in the Plan, but not to exceed the amount allowable by law. The Plan provides for auto enrollment upon eligibility of 3%. ROTH after-tax, and catch-up contributions as well as qualified plan rollovers are allowed by the Plan. The Plan allows for a discretionary employer match and a discretionary nonelective employer contribution. The company discretionary matching contributions are determined on a pay-period basis. In 2024 and 2023, the match was made at a rate of 50% of each employee’s annual deferral, up to 4% of total compensation, as defined by the Plan. Both participants and employer contributions are subject to the nondiscrimination requirements of the Internal Revenue Code.

Participant accounts

Each participant’s account is credited with the participant’s contributions and allocations of (a) the Company’s contribution and (b) Plan earnings, and charged with an allocation of administrative expenses, where applicable. Allocations are based on participant earnings or account balances, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Investment options

Upon enrollment in the Plan, participants may direct the administrator of the Plan as to the investment of their account balances in accordance with guidelines established by the Plan.

Vesting

Participants are immediately vested in their contributions plus actual earnings and losses thereon. Vesting in the Company’s match contribution portion of their account is immediately 100%, as defined in the Plan document. Vesting in the Company’s non-elective contributions as well as actual earnings and losses thereon is also immediately 100%.

Payment of benefits

On termination of service due to death, disability, or retirement, participants or their designated beneficiaries are entitled to receive benefits. Distributions from the Plan may be deferred up until the normal retirement age. For termination of service due to other reason, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Age 59 ½ in-service withdrawals are allowed under the Plan.

Forfeited accounts

Forfeited balances of participants' non-vested accounts must be used to reduce administrative expenses and future Company contributions. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$5 and \$1,447, respectively. Forfeitures of \$-0- and \$-0- occurred during the years ended December 31, 2024 and 2023, respectively. During the years ended December 31, 2024 and 2023, employer contributions were reduced by \$-0- and \$-0-, respectively, from forfeited nonvested accounts. Forfeitures of \$1,446 and \$-0- were used to offset administrative expenses in 2024 and 2023, respectively.

Participant loans

Participants may borrow from their fund accounts up to a maximum equal to 50 percent of their vested account balance. Loan transactions are treated as a transfer to (from) the investment fund from (to) the participant's loan account. Loan terms range for various periods up to five years, except for loans made to acquire a principal residence. The loans are secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest are paid ratably through the employee's payroll withholding.

Note 2 - Summary of Significant Accounting Policies

Basis of accounting

The financial statements of the Plan are prepared on the accrual method of accounting.

Investment valuation and income recognition

The Plan's registered investments are stated at fair value. Fair value is based on quoted market prices in an active market as of the last day of the Plan year. The Plan's common collective trust is valued at contract value. Net realized and unrealized appreciation (depreciation) is recorded in the accompanying statement of changes in net assets available for benefits. Participant loans are stated at their outstanding balances, which approximate fair value. All Plan assets are held by an administered trust fund. Fidelity Investments, which is regulated by both state and federal agencies, maintains custody of the investments, and executes all investment transactions.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

As described under FASB ASC 962-325-35 "*Plan Accounting – Defined Contribution Pension Plans*", the Plan values all fully-benefit responsive contracts at contract value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the plan.

Participant loans receivable

Participant loans receivable are measured at their unpaid balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document. Interest income on participant loans receivable is recognized in the period in which it is earned and is recorded as interest income on the statements of changes in net assets available for benefits.

Payment of benefits

Benefits are recorded when paid.

Administrative expenses

Administrative expenses are paid in part by the Company and by the Plan. Certain transaction fees are paid by the Plan.

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan management to make estimates and assumptions that affect certain reported amounts of net assets available for benefits and changes therein and disclosures. Actual results could differ from those estimates and assumptions.

Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits

Note 3 – Fair value measurements

FASB ASC 820 Fair Value Measurements, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.
Level 2	Inputs to the valuation methodology include <ul style="list-style-type: none"> • quoted prices for similar assets or liabilities in active markets; • quoted prices for identical or similar assets or liabilities in inactive markets; • inputs other than quoted prices that are observable for the asset or liability; • inputs that are derived principally from or corroborated by observable market data by correlation or other means. <p>If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.</p>
Level 3	Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

An asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. The valuation methodology remained the same in 2024 and 2023.

Following is a description of the valuation methodologies used for assets measured at fair value:

Registered investment companies – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 4 – Investment in common collective trust

The Plan has a benefit-responsive investment contract in a common collective trust. The contract is included in the financial statements at contract value as reported to the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The guaranteed interest accounts at contract value are \$61,834 and \$181,244 as of December 31, 2024 and 2023.

Certain events limit the Plan's ability to transact at contract value. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under the Employee Retirement Income Security Act of 1974. The Plan administrator does not believe that any events that would limit the Plan's ability to transact a contract value with Plan participants are probable of occurring.

Note 5 – Information certified by the trustee

Certain information related to investments and notes receivable from participants in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by the trustee of the Plan. Fidelity Management Trust Company certified from January 1, 2024 to April 16, 2024 and as of December 31, 2023. ADP Retirement Trust Services (ADP RTS) certified from April 16, 2024 to December 31, 2024 and as of December 31, 2024.

Note 6 - Tax Status

The Plan obtained its latest determination letter on October 6, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter. However, the Plan administrator and the Plan’s tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Department of Labor. The plan administrator has analyzed the tax positions taken by the plan, and has concluded that as of December 31, 2024 and 2023, no uncertain positions are taken or are expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to December 31, 2021.

Note 7 - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of complete or partial Plan termination, the Trustees shall determine whether the assets of the Plan shall be liquidated and distributed or whether the assets shall continue to be held in trust and distributed in accordance with the terms of the Plan. Upon Plan termination, all participants become 100% vested in their account balance.

During the years ended December 31, 2024 and 2023, there were \$-0- and \$2,187 in excess employee deferrals to the plan. The excess contribution are required to be returned to the participants.

As of December 31, 2024 there were excess contributions from December 31, 2023 that had been distributed.

Note 9 – Related Party Transactions

The Plan's assets are invested in funds managed by ADP Retirement Trust Services. ADP Retirement Trust Services became the trustee on April 16, 2024 as defined by the Plan and, therefore, plan fees qualify as party-in-interest transactions. Fidelity Management Trust Company was the trustee during the first quarter of 2024 and during the year ended December 31, 2023 and, therefore, these transactions qualify as party-in-interest transactions. The Plan investments have internal expenses that compensate ADP and Fidelity. Fee paid by the Plan to ADP for investment management services and administration amount to approximately \$17,417 for the period April 16, 2024 to December 31, 2024. Fees paid by the Plan to Fidelity for investment management services and administration amounted to approximately \$4,309 and \$7,391 for the years ended December 31, 2024 and 2023, respectively.

The Plan sponsors, owners and key management are also participants in the Plan. Their account balances totaled approximately 0% and 0% of the net assets available for benefits as of December 31, 2024 and 2023, respectively.

Note 10 – Plan expense reimbursement arrangement

The Plan entered into a recordkeeping expense agreement with its new third party administrator. Under the arrangement, fee recapture amounts will be calculated monthly based on the formula specified in the agreement. If the calculations yields a surplus, the fee recapture amounts will be credited to the plan expense account quarterly. These amounts may be used by the Plan to pay direct expenses of the Plan or reallocated to participants. During the year ended December 31, 2024, the Plan received reimbursements of \$12,545 which were used to pay plan expenses. During the year ended December 31, 2023, the Plan did not receive reimbursements. As of December 31, 2024, the expense reimbursement account had a balance of \$10,659, which is held in the Vanguard Cash Reserve Money Market account.

Note 11 – Subsequent Events

The Plan has evaluated events occurring through October 9, 2025, the date the financial statements were made available to be issued.
