

NOTE 1 - PLAN DESCRIPTION

The following description of the Bayloff Stamped Products 401(k) Profit Sharing Plan and Trust (the "Plan") provides only general information. Participants should refer to the Plan Document or Summary Plan Description for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution 401(k) plan that provides retirement savings benefits to eligible employees of Bayloff Stamped Products Detroit and Bayloff Stamped Products Kinsman (collectively, the "Company") who have completed 30 days of service, are age 18 or older, and are not covered under a collective bargaining agreement. The Plan, which commenced effective January 1, 1992 is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") and the Internal Revenue Code ("IRC").

Contributions

The Plan provides for employee salary deferral contributions up to a maximum of 90 percent of annual compensation subject to the maximum tax-deferred limitations established by the Internal Revenue Code. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan. Participants can split their contributions between their pre-tax and/or after-tax accounts. The Plan includes automatic enrollment into the Plan at 4 percent with annual increases of 1 percent of a participant's salary deferral up to a maximum of 8 percent unless the participant elects otherwise in accordance with the plan document.

Certain participant contributions and loan repayments in 2024 were paid after the time frame required by the Department of Labor. The Company remitted these contributions in 2025. The lost earnings related to the late contributions and loan repayments are expected to be remitted in 2025.

The Plan provides for Company discretionary matching contributions to be made at the discretion of management. The Company contributed \$37,513, net of forfeitures, for the Plan year.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contributions and, (b) Plan earnings (losses), and charged with an allocation of administrative expenses, if not paid by the Company. Allocations are based on participant's compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investments of their account balances into various investment options offered by the Plan.

NOTE 1 - PLAN DESCRIPTION - (Continued)

Vesting

Participants are immediately 100 percent vested in their salary and rollover contributions and any income or loss thereon. Vesting in the Company's contribution portion of their accounts, plus actual earnings thereon, is based on years of service. Participants vest in discretionary contributions made by the Company 25 percent after each year of continuous service until they become fully vested after four years of credited service.

Forfeitures

Participants who terminate employment with the Company prior to full vesting forfeit the non-vested portion of their account. Forfeitures are used to reduce Company matching contributions or to pay administrative expenses of the Plan. Forfeitures of \$19,302 were used to offset Company matching contributions during the Plan year.

Benefit Payments

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or various installment annuities. For termination of services for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

In-Service Withdrawals

In-service withdrawals to employees are limited to post-age 59.5 withdrawals or hardship withdrawals. Employees must meet certain hardship criteria to qualify for a hardship withdrawal. Participants may request that all or a portion of their accounts be distributed in the case of financial hardship, as described in the Plan document.

Participant Notes Receivable

Participants may borrow from their accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes receivable are secured by the balance in the participant's account and bear interest at a market rate determined at the time the loan is requested to be processed. Principal and interest are paid ratably through payroll deductions.

Party-in-Interest Transactions

Certain plan assets were in investment funds managed by Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company (Principal Trust). Principal Trust was the custodian of the Plan until August 31, 2024, when the assets were transferred to ADP Retirement Trust Services, LLC; therefore, these transactions are considered as party-in-interest transactions as defined by ERISA. Any transactions involving these investments are on the open market at fair market value as outlined in Note 4. Consequently, such transactions are permitted under the provisions of the Plan and are exempt party-in-interest transactions under ERISA.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their account balances.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The Plan's financial statements are prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition

Investments held by a defined contribution plan are required to be reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Participant Notes Receivable

Participant notes receivable are recorded at their unpaid principal balance plus any accrued but unpaid interest. If a participant does not make loan payments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Benefit Payments

Benefit payments to participants are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Company and are, therefore excluded from these financial statements. Investment-related expenses are included in the net appreciation in fair value of investments. Fees for the administration of withdrawals are included in the administrative expenses and charged directly to the participant's account.

Excess Contributions Payable

Excess contributions payable consist of amounts payable to participants for contributions in excess of amounts allowed by the IRS. The Plan distributed the excess contributions for 2023 in January 2025, which was after the March 15, 2024 deadline. The Plan administrator anticipates completing corrective actions in 2025.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Date of Management's Review of Subsequent Events

Subsequent events were evaluated through October 15, 2025, which is the date the financial statements were available to be issued.

NOTE 3 - TAX STATUS

The Plan uses a preapproved prototype plan. The prototype plan has received favorable opinion letters dated October 6, 2020 from the Internal Revenue Service which states its terms are in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has not individually sought its own determination letter. Although the Plan may be subsequently amended and restated, the Plan administrator believes that the Plan will continue to operate in compliance with relevant regulations to maintain its qualified status.

The years 2021, 2022, and 2023 are open tax years relating to the possibility of audit by the federal taxing authorities.

NOTE 4 - CERTIFIED INFORMATION

Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company was the custodian of the Plan until August 31, 2024. Beginning September 1, 2024 ADP Retirement Trust Services, LLC became the custodian of the Plan. The custodians held the Plan's investments and participant notes receivable and executed all related transactions. The investment and participant notes receivable balances and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the custodians.

NOTE 5 - FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of market observables and have less priority than Level 1, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 3 inputs for the periods presented.

The following valuation methods methodologies have been used to value the Plan's investments:

Mutual Funds

Mutual funds are valued at quoted prices reported in active markets.

Common/Collective Trust Funds

The common/collective trust funds are valued at net asset value per share (NAV) or its equivalent of the funds, which is based on the fair value of the funds' underlying assets.

Pooled Separate Accounts

The pooled separate accounts are valued at net asset value per share or its equivalent of the funds, which is based on the fair value of the funds underlying net assets.

Guaranteed Interest Accounts

The guaranteed interest accounts are not considered benefit responsive and are presented at fair value. The fair value of the unallocated contract is based on the contract value adjusted for certain contractual provisions. Contract value represents investments at cost, plus accrued interest income, less amounts withdrawn to pay benefits.
