Management, having determined it is permissible in the circumstances, has elected to have the audits of Anchor Packaging Employees' 401(k) Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Basis For Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with auditing standards generally accepted in the United States of America. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTES TO FINANCIAL STATEMENTS December 31, 2024 And 2023

1. Description Of The Plan

The following description of the Anchor Packaging Employees' 401(k) Retirement Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution profit sharing plan sponsored by Anchor Packaging, LLC (the Company or Plan Sponsor) under the provisions of Section 401(a) of the Internal Revenue Code (the IRC), which includes a qualified deferral arrangement as described in Section 401(k) of the IRC, for the benefit of eligible employees of the Company. Each employee becomes eligible after completing 30 days of service and attaining age 21. Once eligible, employees enter the Plan on a monthly basis. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Administration Of The Plan

Reliance Trust Company (Reliance) is the Plan's Trustee. ADP Retirement Services (ADP) is the Plan's recordkeeper.

Contributions

Each year, participants may contribute to the Plan from 1% to 90% of their pretax annual compensation, as defined in the Plan Document, not to exceed the maximum allowed by IRC limitations. Participants may make nondeductible voluntary after-tax contributions up to 10% of compensation. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover contributions). Participants who have reached age 50 may make catch-up contributions, as defined in the IRC.

The Plan also provides for Company matching contributions and discretionary profit sharing contributions. Participants are eligible to receive a Company matching contribution after completing 30 days of service and attaining age 21.

The Company contributes safe harbor matching contributions equal to 100% of each participant's deferrals up to 3% of eligible compensation, plus 50% of each participant's deferrals between 3% and 5% of eligible compensation. Safe harbor matching contributions were \$1,353,566 and \$1,256,664 in 2024 and 2023, respectively.

The Board elected not to make any discretionary profit sharing contributions in 2024 or 2023.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's contributions and an allocation of the Plan's earnings (losses). The allocation of earnings (losses) is determined by the earnings (losses) of the participant's investment selection based on each participant's account balance, as defined in the Plan Document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their deferral contributions plus actual earnings (losses) thereon and Company safe harbor contributions. Participants are vested in their profit sharing contributions at a rate of 20% per year of service, becoming 100% vested after five years of service.

Forfeitures

Forfeitures of nonvested participant balances can be used to reduce Company matching contributions or pay administrative expenses of the Plan. Forfeitures available for future use amounted to \$11,858 and \$10,907 as of December 31, 2024 and 2023, respectively. During the Plan years ended December 31, 2024 and 2023, \$3,274 and \$14,998, respectively, in forfeited funds were used to reduce Company matching contributions.

Notes Receivable From Participants

Participants may borrow from their account a minimum of \$500, up to a maximum equal to the lesser of \$50,000 or 50% of the total value of the participant's vested account balance. Loans are secured by participants' vested account balances. Loans are for a period not exceeding 5 years, unless the purpose of the loan is to acquire a principal residence, in which the period shall not exceed 30 years. Interest rates on loans are set at local prevailing rates as determined by the Plan Administrator. Loans are due in regular installment payments which are remitted through payroll withholdings.

In-Service Withdrawals

Active participants who reach age 59-1/2 or experience a qualifying financial hardship may withdraw all or part of their vested accounts. Hardship withdrawals will be approved only if they conform to Plan provisions and established Internal Revenue Service (IRS) provisions.

Payment Of Benefits

Upon termination of service, death, disability or attainment of normal retirement age, a participant may elect distribution of their account as a single lump sum or a retirement annuity.

Investment Options

Upon enrollment in the Plan, a participant may direct contributions in a number of investment options offered by the Plan.

Administrative Expenses

Loan and other transaction and investment advisory fees are paid by the Plan. The Company pays remaining fees and administrative expenses, which include recordkeeping fees, professional fees and trust fees.

2. Summary Of Significant Accounting Policies

Basis Of Accounting

The financial statements of the Plan are presented on the accrual basis of accounting.

Estimates And Assumptions

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from net assets during the reporting period. Actual results could differ from those estimates.

Risks And Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Investment Valuation And Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or pay to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Interest income is recorded as earned on the accrual basis. Purchases and sales of securities are reflected on a trade-date basis. Dividends are recorded on the ex-dividend date.

The net change in fair value of investments in the accompanying statement of changes in net assets available for benefits includes realized gains/losses and unrealized gains/losses.

Contributions Receivable And Credit Loss Policy

Amounts due for contributions are stated at the amount that management expects to collect from outstanding balances less an allowance for expected credit losses. The expected credit losses amount reflects management's best estimate of amounts that will not be collected. This assessment considers historical experience, current conditions and, when appropriate, reasonable and supportable forecasts.

The Plan has concluded that no allowance for current expected credit losses was necessary at December 31, 2024 or 2023.

Notes Receivable From Participants

Notes receivable from participants are measured at the unpaid principal balance plus accrued but unpaid interest. Delinquent notes receivable are recorded as a distribution based upon the terms of the Plan Document.

Payment Of Benefits

Benefits are recorded when paid.

Subsequent Events

Management evaluates subsequent events through the date the financial statements are available for issue, which is the date of the Independent Auditors' Report.

4. Fair Value Measurements

The Plan utilizes an established framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under the standards are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

Registered Investment Companies

Valued at the daily closing price as reported by the fund. Registered investment company funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The registered investment company funds held by the Plan are deemed to be actively traded.

Common/Collective Trusts

Valued at the Net Asset Value (NAV) of units of a bank collective trust. The NAV, as provided by the trustees, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trusts, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure the securities liquidation will be carried out in an orderly business manner. There are no unfunded commitments relating to these investments.

The methods described above may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

6. Income Tax Status

The Plan uses a non-standard pre-approved plan sponsored by ADP, LLC. The pre-approved plan has received an opinion letter dated October 6, 2020 from the IRS that indicates that the pre-approved document is in compliance with applicable requirements of the IRC. The pre-approved document has been amended since receiving the opinion letter. The Company has not applied for a determination letter with respect to the Plan's qualification. However, the Plan Sponsor believes the Plan is designed and is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax exempt.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Party In Interest Transactions

During 2024 and 2023, ADP was paid \$15,675 and \$13,965, respectively, for administrative fees that qualify as allowable party in interest transactions.

CAPTRUST (formerly Ellwood Associates) is the investment advisor of the Plan. During 2024 and 2023, CAPTRUST was paid \$62,319 and \$54,555, respectively, for professional fees that qualify as allowable party in interest transactions.

Certain employees have outstanding loans with the Plan as of December 31, 2024 and 2023. These loans are considered party in interest transactions in accordance with the DOL guidelines.
