INDEPENDENT AUDITOR'S REPORT

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Kensington Senior Living, LLC 401(k) Plan ("the Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

1. Plan Description

The following description of the Kensington Senior Living, LLC 401(k) Plan (“the Plan”) provides only general information. Participants should refer to the Plan documents and any amendments thereto for a more complete description of the Plan’s provisions.

General

The Plan is a voluntary, defined contribution plan that is available to all eligible employees of Kensington Senior Living, LLC (“the Company”) who have attained the age of 18 as of the entry date, as defined by the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Contributions

Participants may elect to contribute a percentage of their compensation, not to exceed the statutory limit. Participants direct the investment of their funds into various mutual funds offered by the Plan.

The Company may match employee salary deferral contributions with a discretionary contribution of a percentage of Plan wages for the entire year, not to exceed the employee deferral contribution. In order to receive a discretionary match, eligible participants must have made contributions to the Plan during the year. There were no employer discretionary matching contributions for the year ended December 31, 2024.

Participant Accounts

Each participant’s account is credited with the participant’s contributions, including amounts rolled over from other qualified plans, as well as allocations of the Company’s matching contributions, if any, and Plan earnings and losses, less any charges, if applicable. Allocations are based on participant earnings, as defined. The benefit to which a participant is entitled is the amount that can be provided from the participant’s vested account.

Vesting

Participants are fully vested with respect to employee contributions and actual earnings and losses thereon. Participants are vested in employer contributions and actual earnings and losses thereon after completing three years of service. This includes voluntary and rollover contributions, employer contributions, and actual earnings and losses thereon.

1. Plan Description (continued)

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The notes are secured by the balance in a participant's account and bear interest at rates ranging from 5.25% to 10.50%, which is commensurate with local prevailing rates as determined by the Plan Administrator. Loan terms range from one to five years or up to 10 years for the purchase of a primary residence. Repayments of principal and interest are made through payroll deductions, starting with the first payroll period after the loan settles.

Payment of Benefits

Upon termination of service due to death, permanent disability, or retirement, a participant may receive a lump-sum amount equal to the value of the participant's vested interest in his or her account, installment payments, a lifetime annuity, a minimum distribution option, or a qualified joint or survivor annuity.

Upon termination of service, if the vested value of a participant's account is less than \$1,000 (\$5,000 if on or after age 65), his or her account will be distributed in a single lump-sum payment. If the vested value of a participant's account exceeds \$5,000, he or she may elect to receive either a lump-sum amount, substantially equal payments for a specified term, the entire distribution paid in a direct rollover to another qualified plan, or a combination of the above.

Forfeitures

Forfeited accounts are used to reduce future contributions by the Company. There were no forfeited nonvested accounts as of December 31, 2024 and 2023.

2. Summary of Significant Accounting Policies

Basis of Accounting

The Plan's financial statements and supplementary schedule are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from estimated amounts.

Investment Valuation and Income Recognition

Investments are reported at fair value. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recognized principally on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date, i.e., the date by which one needs to own a stock to receive the declared dividend. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Notes Receivable from Participants

Notes receivable from participants are measured as unpaid principal balances plus any accrued interest. Delinquent or defaulted notes are considered withdrawals, and therefore are reclassified as distributions in accordance with the terms of the Plan document. Delinquent loans are those for which any scheduled repayment remains unpaid at the end of the period specified in the loan procedures and any loans for which there is an outstanding principal balance existing after the last scheduled repayment date.

Payment of Benefits

Benefits are recorded when paid.

Administrative Costs

Except for loan origination fees associated with notes receivable from participants, all (or substantially all) expenses of maintaining the Plan are paid by the Company.

Subsequent Events

In preparing these financial statements, the Plan Administrator has evaluated events and transactions for potential recognition or disclosure through October 14, 2025, the date the financial statements were available to be issued.

3. Fair Value Measurements

The Plan follows Financial Accounting Standards Board Accounting Standards Codification 820, *Fair Value Measurements and Disclosures*, for its financial assets. This standard establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. Fair value measurement standards require an entity to maximize the use of observable inputs (such as quoted prices in active markets) and minimize the use of unobservable inputs (such as appraisals or other valuation techniques) to determine fair value. The categorization of a financial instrument within the hierarchy is based upon the pricing transparency of the instrument and does not necessarily correspond to the entity's perceived risk of that instrument.

The inputs used in measuring fair value are categorized into three levels. Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and liabilities and have the highest priority. Level 2 is based upon observable inputs other than quoted market prices, and Level 3 is based on unobservable inputs. There were no Level 3 inputs at December 31, 2024 and 2023. Transfers between levels in the fair value hierarchy are recognized at the end of the reporting period.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following section describes the valuation methodologies the Plan uses to measure its assets at fair value.

- *Mutual funds*: Valued at the daily closing process as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net assets value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

- *Common collective trusts:* Investments in common collective trusts are valued at NAV per unit as a practical expedient and, accordingly, are not classified in the fair value hierarchy.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to reduce or discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA.

5. Income Tax Status

Effective January 1, 2010, the Plan adopted a prototype plan sponsored by Automatic Data Processing. The prototype plan has received an opinion letter from the Internal Revenue Service (IRS) as to the prototype plan's qualified status. The prototype plan opinion letter has been relied upon by this Plan. The Plan Administrator believes that the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

6. Party-in-Interest Transactions

The custodian of the Plan is Reliance Trust Company, which holds the Plan's assets and performs recordkeeping and administrative functions. The Plan also invests in units of collective investment trusts issued by Great Gray Trust Company, LLC. Both Reliance Trust Company and Great Gray Trust Company, LLC are considered parties in interest under ERISA. Transactions involving these entities qualify as party-in-interest transactions, which are permissible under ERISA and the related regulations. Fees paid by the Plan for the investment management services are included in net appreciation (depreciation) in fair value of investments.

7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate and market fluctuations, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
