Emphasis of Matter — Transfer of Assets and Partial Plan Termination

As discussed in Note 9 to the financial statements, during the year ended December 31, 2024, the Plan transferred approximately \$14,352,674 of net assets to Links Healthcare Group LLC 401(k) Profit Sharing Plan and Trust, another qualified retirement plan, in connection with the sale of a portion of the Plan sponsor's business. As a result of this transaction, a partial plan termination occurred, and all affected participants became fully vested in their account balances in accordance with Internal Revenue Code Section 411(d)(3). Our opinion is not modified with respect to this matter.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

1. DESCRIPTION OF THE PLAN

The Premier B.H., Inc. 401(k) Plan (“the Plan”) is a qualified retirement plan under the appropriate provisions of the Internal Revenue Code (IRC.) A general description of the Plan follows. For a more complete description, participants should refer to the Summary Plan Description or the Plan Document, which are available from the Plan administrator.

General

The Plan is a defined contribution plan covering all full-time employees of Premier B.H., Inc. and its affiliates (“the Company”) who have attained age 18. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974.

Contributions

Participants may defer up to 90% of their qualified annual compensation to the Plan on a pre-tax or after-tax Roth basis, limited to a maximum annual amount as set by the Internal Revenue Code (“IRC”). Participants who have attained age 50 before the end of the Plan year are eligible to make “catch up” contributions. 3% of each eligible employee’s compensation will be automatically withheld and contributed to the Plan unless employees elect to either not participate in the Plan, or contribute a different amount. This automatic deferral will increase by 1% at each anniversary date to a maximum of 6% of eligible compensation.

Participant contributions will be matched by the Company using the formula 30% of contributing participants’ deferrals not to exceed 5% of compensation per each payroll period. The Company’s matching contributions to the Plan totaled \$83,337 for the year ended December 31, 2024.

Participant Accounts

Each participant’s account is credited with the participant’s contribution and allocations of the Company’s contribution and plan earnings, and is charged with administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants immediately vest in their tax deferred contributions plus actual earnings thereon. Participants become 100% vested in the Company’s contributions and earnings thereon in the case of retirement, death or disability. Otherwise, vesting in the Company’s matching contributions plus actual earnings thereon is according to the following schedule:

Forfeitures

When certain terminations of participation occur in the Plan, the non-vested portion of the participant's account is forfeited, as defined by the Plan. Forfeitures may be used to offset administrative expenses and offset the Company's matching contributions. During the year ended December 31, 2024, \$35,073 was used to offset employer matching contributions. The total amount for forfeited non-vested accounts for the years ended December 31, 2024 and 2023 were \$299,066 and \$442,898, respectively

Distribution of Benefits

Participants may receive distributions from their accounts at retirement (age 65), upon termination of employment for any reason, or upon death or disability. Distributions under the Plan may be made in lump sums or installment payments.

Participants may also request a withdrawal upon attaining age 59½ and upon demonstration to the plan administrator that the participant is suffering from "hardship", as defined by the plan document. Participants may withdraw from their rollover account at any time.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested balance. The loans are secured by the balance in the participant's account. Loans must bear an interest rate of Prime Rate + 1%. All loans must be repaid within 5 years, unless it is for the purchase of a primary residence, in which case the loan may be paid back within 30 years. No more than 1 loan may be outstanding at any time. The trustee of the Plan notifies the Company of past due or delinquent loans. If a note receivable becomes uncollectible, it is Plan policy to deem the defaulted loan a distribution, which according to the Plan document may be taxable to the participant. Principal and interest is generally paid through payroll deductions each pay period.

2. SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accounting records of the Plan are maintained on the accrual basis of accounting except as noted below regarding benefit payments. The accuracy of these financial statements,

notes to financial statements and the supplemental schedule of assets (held at end of year) are the responsibility of the Plan's management.

Use of Estimates

The preparation of financial statements in conformity with United States generally accepted accounting principles requires Plan management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates. Significant estimates include the fair market value of investments.

Investment Valuation and Income Recognition

The Plan has invested in registered investment companies. These investments consist of a common collective trust and mutual funds and are recorded at fair market value as published in market listings and represent more than 5% of net assets. See Note 11 for further fair value disclosures. During 2024, the Plan's investments in registered investment companies (including gains and losses on investments bought and sold, as well as investments held at the end of the year) appreciated in value by \$506,594.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred.

Expenses of the Plan

The Plan paid all remaining investment and administrative fees for the year ended December 31, 2024. This amount is reported as an administrative expense on the statement of changes in net assets available for benefits.

Payment of Benefits

Benefits paid to participants are recorded when paid as required by U.S. generally accepted accounting principles for qualified retirement plans.

3. RELATED-PARTY AND PARTY IN INTEREST TRANSACTIONS

Section 3(14) of ERISA defines a party in interest to include, among others, fiduciaries or employees of the Plan, any person who provides services to the Plan or an employer whose employees are covered by the Plan. Accordingly, loans to participants are considered party in interest transactions.

4. TAX STATUS

The Company adopted a restated pre-approved plan document of ADP, Inc. and the Internal Revenue Service ("IRS") had determined and informed the sponsor of the pre-approved plan document by a letter dated October 6, 2020 that the pre-approved plan document is designed in accordance with applicable sections of the IRC and the Plan is qualified and the related trust is tax-exempt. The Plan has been restated since receiving the determination letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that for the year ending December 31, 2024 there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements.

5. CERTIFIED INVESTMENTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments, net appreciation (depreciation) in fair value of investments and interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company, the trustee of the Plan.

6. PLAN TERMINATION

Although the Plan was established with the intention that it will continue indefinitely, the Company retains the right to discontinue its contributions at any time or to terminate the Plan, subject to ERISA provisions. In the event of a plan termination, all participants will become 100% vested in their accounts.

7. SUBSEQUENT EVENTS

The Company has evaluated the Plan for subsequent events through October 15, 2025, the date in which these financial statements were available to be issued. As of this date, there have been no significant events that occurred for which the Company has deemed such disclosure necessary.

8. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

9. TRANSFER OF ASSETS AND PARTIAL PLAN TERMINATION

During the year ended December 31, 2024, the Plan transferred approximately \$14,352,674 of net assets to Links Healthcare Group LLC 401(k) Profit Sharing Plan and Trust, another qualified retirement plan, in connection with the sale of a portion of the Plan sponsor's business. As a result of this transaction, a partial plan termination occurred, and all affected participants became fully vested in their account balances in accordance with IRC Section 411(d)(3). The transfer was executed in accordance with the terms of the Plan and the requirements of ERISA.

10. OPERATIONAL CORRECTIONS

During 2024, certain operational errors were identified, including missed participant deferrals and employer matching contributions on certain pay periods and incorrect application of vesting provisions related to a partial plan termination. Management has estimated that corrective contributions of approximately \$45,638 will be required. The estimate does not currently include lost earnings, which will be determined and contributed at a later date.

11. FAIR VALUE MEASUREMENTS

FASB Accounting Standards Codification (ASC) 820 establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

If the asset or liability has a specified (contractual) term the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for the Plan's assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at fair value as published in market listings.

Common Collective Trusts: Values at the net asset value of its units of a collective trust.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan uses fair value measurements to record fair value adjustments to certain assets and to determine fair value disclosures. The valuation technique used in measuring fair value of investments is determined by the Plan administrator and this appears to be consistent with valuation techniques used in the industry.

Concentrations of Investments

The Plan's investments include certain funds that individually represent 5% or more of the Plan's net assets available for benefits. The following investments exceeded this threshold:

- MFS Total Return Fund – \$1,462,110 (30% of net assets)
- Fidelity Freedom Index 2015 Fund – \$638,636 (13% of net assets)
- Investco Stable Asset Fund - \$485,707 (10% of net assets)

- State Street Equity 500 Index Fund – \$360,949 (7% of net assets)
