NOTE 1 - DESCRIPTION OF THE PLAN

The following brief description of the Pillsbury Winthrop Shaw Pittman LLP Retirement Savings Plan No. 2 (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for more specific provisions.

A. General

The Plan is a defined contribution plan established in 2004 to provide retirement benefits to all partners, authorized management employees and staff members located in the East Coast offices of Pillsbury Winthrop Shaw Pittman LLP (the “Firm”). The plan administrator believes the Plan is designed and operated in compliance with applicable requirements of the Internal Revenue Code (the “Code”) and provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

B. Administration

The Firm appointed an Administrative Committee (the “Committee”) to manage the operation and administration of the Plan. Assets of the Plan are held in a master trust together with the assets of Pillsbury Winthrop Shaw Pittman LLP Retirement Savings Plan No. 1 (“Plan No. 1”), a related plan administered by the Committee. The plans are individual account plans in which each participant directs the investment of his or her account. Accordingly, the Plan holds a specifically identifiable interest in assets maintained in the master trust. The Committee designated Fidelity Management Trust Company (“Fidelity”) to serve as trustee.

C. Eligibility

Partners and authorized management employees hired prior to April 1, 2005 and staff who are employed primarily in one or more of the Firm’s East Coast offices are eligible for the Plan. Participation is automatic for eligible members of the Firm who are age 21 or older. Counsels (a special designation under the Plan) are not eligible for Firm profit sharing contributions.

D. Profit Sharing Contributions

Annual profit sharing contributions are made on behalf of each eligible participant based on participants’ eligible compensation as follows:

- 5% of compensation is allocated to the account of each non-lawyer participant.
- 50% of the maximum annual addition permitted under Section 415 of the Code, less the annual elective deferral limit, less the maximum matching contribution that can be made under Firm plans, is allocated to partners and authorized management employees.
- 8.83% of compensation is allocated to Senior Administrators up to a maximum of \$15,000.
- 5% to 10% of eligible compensation is allocated to former participants in the Winthrop Stimson Putnam & Roberts Staff Retirement Plan who were employed on December 31, 2001 preceding its merger into a Firm plan.

Firm members must be eligible on December 31 in order to share in profit sharing contributions for the year. Elective contributions are not permitted under the Plan.

E. Participant Accounts

Each participant's account is credited with an allocation of Firm contributions and the participant's share of master trust investment income or losses and expenses. Participants may direct their investments among a core group of investment funds offered under the Plan, or they may elect to establish a self-directed brokerage account in which they may invest in any investment security approved by the Committee.

Contributions allocated to participants who decline to make an investment election are invested in the Fidelity Institutional Asset Management ("FIAM") Target Date Commingled Pool appropriate for an individual's age and projected date of retirement.

F. Vesting and Forfeitures

Participants are immediately 100% vested in their accounts.

G. Notes Receivable from Participants

The Plan allows participants to borrow not less than \$1,000 up to the lesser of \$50,000 or 50% of their vested account balance. A loan is secured by a participant's account balance, bears a fixed rate of interest based on prevailing market rates at loan inception, and must be repaid to the Plan in five years unless the loan is used for the purchase of a principal residence in which case the maximum repayment period may be extended to a maximum of 15 years. Principal and interest are paid ratably through payroll deductions. Notes receivable from participants at December 31, 2024 carry interest rates ranging from 4.75% to 10.00% with various maturities through July 2039.

Notes receivable are measured at their unpaid principal balance plus accrued interest. Delinquent notes are recorded as a distribution based on the terms of the Plan document.

H. Payment of Benefits

Upon termination of service, death, disability or retirement, a participant or beneficiary may maintain his or her account in the Plan or elect to receive benefits in a lump sum. Hardship distributions are permitted under limited circumstances. Benefits are recorded when paid.

I. Expenses

Core fund management fees and operating expenses are charged directly to the fund and are thereby factored into each fund as a reduction in investment return. Certain fees incurred by participants with self-directed brokerage accounts are charged directly to the account holder. The Firm pays substantially all other costs of administering the Plan.

J. Plan Termination

Although it has not expressed any intent to do so, the Firm has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to provisions of ERISA. The accounts of participants affected by a partial or complete termination of the Plan are non-forfeitable and will be determined as of the termination date.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

B. Investment Valuation and Income Recognition

Plan investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of investments are recorded on the trade-date basis. Dividends are recorded on the ex-dividend date. Interest is recorded on the accrual basis. Net appreciation of investments includes gains and losses on investments bought and sold as well as held during the year.

C. Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect reported amounts and disclosures. Actual results may differ from those estimates.

D. Risks and Uncertainties

Plan investments are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with investments, it is at least reasonably possible that changes in equity markets, interest rates or other factors in the near term would materially affect participant accounts and amounts reported in these financial statements.

E. Subsequent Events

Management has evaluated subsequent events through October 13, 2025, the date on which the financial statements were available to be issued. There are no subsequent events that require recognition or additional disclosure in the financial statements.

NOTE 3 - INCOME TAX STATUS

The Plan received its most recent favorable determination letter on March 12, 2018, in which the Internal Revenue Service stated that the Plan is designed in compliance with the applicable requirements of the Code. The Firm believes the Plan is operated in accordance with and continues to qualify under the applicable requirements of the Code and related state statutes, and the trust, which forms a part of the Plan, is exempt from federal income and state franchise taxes.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 4 - PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by affiliates of the trustee. Purchases and sales of these investments and payment of direct and indirect fees by the Plan to service providers are considered party-in-interest transactions under ERISA regulations. Such transactions are permitted under provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

NOTE 5 - FINANCIAL INFORMATION CERTIFIED BY TRUSTEE

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule including investments held at December 31, 2024 and 2023, and net appreciation of investments, interest and dividends for the year ended December 31, 2024, was obtained or derived from information provided to the plan administrator and certified as complete and accurate by Fidelity Management Trust Company, the trustee.

NOTE 6 - FAIR VALUE MEASUREMENTS

Accounting guidance establishes a hierarchy that prioritizes valuation inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market. Under the fair value hierarchy Level 1 inputs are quoted prices for identical securities in an active market. Level 2 inputs are quoted prices for similar instruments and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data. Level 3 inputs are generally unobservable and typically reflect management's estimates of assumptions that market participants would use in pricing the asset or liability.

Shares of mutual funds are valued at the closing market prices of shares held by the Master Trust at year-end. Other investments are comprised of securities maintained in self-directed brokerage accounts and consist principally of mutual funds and common stocks which are valued at the closing price reported on the active market on which the securities are traded.

Although the plan administrator believes these valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value could result in a different fair value measurement at the reporting date.
