Note 1. Description of Plan

The following is a brief description of Vision Partners LLC 401(k) Profit Sharing Plan (the “Plan”) and is provided for general information purposes only. Participants should refer to the plan documents for more complete information.

General

The Plan was established effective October 1, 2018 and was amended and restated effective January 1, 2021. The Plan is a defined contribution plan covering substantially all employees of Vision Partners LLC and its controlled affiliates (collectively, the “Company”) who have completed six months of service and attained age twenty-one. Empower Trust Company, LLC (“Empower”) serves as a trustee for the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

In May 2024, the Plan was merged with assets transferred from Mid America Eye Center, P.A. Employees’ Profit Sharing Plan. In June 2024, the Plan merged with assets transferred from Retina Associates of St. Louis, Inc. Profit Sharing Plan. In December 2024, the Plan merged assets transferred from Hummel Eye 401(k) Retirement Plan. Assets transferred into the plan totaled approximately \$6,600,000.

Contributions

Participants may elect to make deferral contributions up to 100% of eligible compensation, as defined by the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans and certain individual retirement accounts. Contributions are subject to certain limitations.

The Company makes safe harbor match contributions equal to 100% of the first 3% of compensation and then 50% of the next 2% of compensation that a participant contributes to the Plan. The Company may also, at its discretion, make non-elective contributions. No such non-elective contributions were made for the year ended December 31, 2024.

Investment Options

Participants direct the investment of their accounts into various investment options offered by the Plan. The Plan offers mutual funds, a stable value collective trust fund, and self-directed brokerage accounts as investment options.

Participant Accounts

Participant accounts are credited with the participant’s contributions, an allocation of the Company’s contributions and plan earnings, and is charged with benefit payments, plan losses, transaction fees related to notes receivable from participants and distributions, and an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

All participants are immediately vested in their deferral and rollover contributions to the Plan as well as Company safe harbor contributions, plus actual earnings thereon. Vesting in discretionary non-elective Company contributions is based on years of service, as defined, with participants becoming fully vested after six years of credited service, or immediately upon retirement, at death, or upon total and permanent disability.

Notes Receivable from Participants

Participants may borrow from their account a minimum of \$1,000 with the maximum equal to the lesser of \$50,000 or 50% of their vested account balance. A participant may not have more than one loan outstanding at any time. The loans are secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates as determined by the plan administrator. At December 31, 2024, outstanding loans bore an interest rate of 3.25% to 9.50%. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

On termination of service, death, disability, or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum or installment options as provided by the Plan. Hardship distributions are permitted upon demonstration of financial hardship. All fully vested balances are available for distribution after the participant reaches the age of 59½.

Forfeitures

At December 31, 2024 and 2023, forfeited nonvested accounts totaled approximately \$78,000 and \$84,000 respectively. These amounts may be used to reduce future Company contributions or pay plan expenses. During 2024, \$32,000 in forfeitures were used to reduce employer matching contributions.

Note 2. Summary of Significant Accounting Policies

Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with GAAP.

Notes Receivable from Participants

Notes receivable from participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account. If a participant does not make loan repayments, and the Plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document. As of December 31, 2024 and 2023, no allowances have been recorded for uncollectible notes receivable.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Contributions

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

Benefits Paid to Participants

Benefits are recorded when paid.

Administrative Expenses

The Plan's administrative expenses are paid by either the Plan or the Company, as provided by the plan document. Certain administrative functions are performed by employees of the Company. No such employee receives compensation from the Plan. Expenses relating to specific participant transactions are charged directly to the participant's account.

Subsequent Events

Management has evaluated subsequent events through October 15, 2025, which is the date the financial statements were available to be issued.

In May 2025, the Plan was merged with assets transferred from Discover Vision Center 401(k) Plan. The amount of assets transferred into the Plan totaled approximately \$32,000,000.

Note 3. Fair Value Measurements

Fair value, as defined under GAAP, is an exit price representing the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. GAAP establishes a three-tier fair value hierarchy which prioritizes the inputs used in measuring fair value. These tiers include:

- Level 1** Observable inputs such as quoted prices in active markets.
- Level 2** Inputs other than quoted prices in active markets that are either directly or indirectly observable.
- Level 3** Unobservable inputs about which little or no market data exists, therefore requiring an entity to develop its own assumptions.

Assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. The Plan's assessment of the significance of a particular input to the fair value measurement requires judgment, and may affect the valuation of fair value assets and liabilities and their placement within the fair value hierarchy levels.

There have been no changes in the methodologies used at December 31, 2024 and 2023. The following is a description of the valuation methodologies used for assets measured at fair value:

Mutual Funds

Mutual funds are publicly traded investments and are valued daily at the closing price reported on the active market on which the funds are traded.

Self-Directed Brokerage Accounts

These investments include portfolios of cash equivalents and publicly traded equity securities that are valued daily at the closing price reported on the active markets on which the securities are traded.

Common Collective Trusts

These investments are valued based on the reported net asset value (“NAV”) of the collective fund as a practical expedient to estimate fair value. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the stable value collective trust fund, the issuer reserves the right to require 12-months’ notification in order to ensure that securities liquidations will be carried out in an orderly business manner. There are no unfunded commitments related to the fund. The common collective trust fund is not required to be classified within a level on the fair value hierarchy.

Note 5. Party-in-Interest Transactions

Certain plan investments are funds managed by Empower and its affiliates. Empower is the trustee as defined by the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund. Fees paid to the trustee by the Plan for administrative services totaled approximately \$137,000 for the year ended December 31, 2024.

Note 6. Tax Status

The Plan has not obtained a determination letter from the IRS stating that the Plan was in compliance with the applicable requirement of the IRC. The Plan is relying on the IRS approval of the prototype plan that it is utilizing. The IRS has determined and informed the document sponsor by a letter dated December 7, 2020 that the prototype plan document was designed in accordance with applicable sections of the IRC. The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the plan administrator believes that the Plan was qualified and the related trust was tax exempt as of the financial statement date.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7. Risks and Uncertainties

Certain self-directed accounts may include interest-bearing cash deposits which exceed the Federal Deposit Insurance Corporation (FDIC) limit of \$250,000.

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' accounts balances and the amounts reported in the statements of net assets available for benefits.

Note 8. Nonexempt Transactions

Defined contribution plans are required to remit employee contributions to the Plan as soon as they can be reasonably segregated from the employer's general assets, but no later than the 15th business day of the month following the month in which the participant contributions are withheld by the employer. While the Company remitted all employee contributions to the Plan, contributions of \$11,336 were not remitted within the required time period for the year ended December 31, 2024.

Note 9. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.
