## INDEPENDENT AUDITOR'S REPORT

To the Board of Trustees and Plan Participants

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

***Other Matter - Supplemental Schedules Required by ERISA***

The supplemental Schedule of Assets (Held at End of Year) as of December 31, 2024 and Schedule of Delinquent Contributions at December 31, 2024 are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including its form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

- the form and content of the supplemental schedules, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

## NOTES TO FINANCIAL STATEMENTS

### Ohio Anesthesia Group, Inc. 401(k) Profit Sharing Plan and Trust

#### 1 Description of Plan

The following summary description of Ohio Anesthesia Group, Inc. 401(k) Profit Sharing Plan and Trust (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

##### *General:*

The Plan, which was most recently restated effective January 1, 2022, is a defined contribution 401(k) retirement plan which was formed for the purpose of providing retirement benefits to employees of Ohio Anesthesia Group, Inc. (the “Company”). Employees, who are not classified as occasional employees or locum tenens employees, become eligible to participate in the Plan on their date of hire, as defined. Plan entry for Company safe harbor matching contributions and discretionary profit sharing contributions occurs on the first day of January or July coinciding with or following the date an employee completes one year of service, as defined. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Board of Trustees is responsible for oversight of the Plan including determining the appropriateness of the Plan’s investment offerings and monitoring investment performance.

Effective January 1, 2024, the Plan was amended to add Sentrii RCM as a participating employer. Effective December 30, 2024, Southwest Anesthesiology Group, Inc. and Stark County Anesthesia, Inc. exited from Ohio Anesthesia Group, Inc. Those participants were able to elect to withdraw their account balances.

Effective January 1, 2025, the Plan sponsor, Ohio Anesthesia Group, Inc., was replaced by Sentrii RCM and the name of the Plan was changed to Sentrii RCM 401(k) Profit Sharing Plan.

##### *Contributions:*

Each year, participants may elect to contribute up to the maximum amount allowed by law of their pre-tax annual compensation, or make Roth contributions, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollover contributions).

Safe harbor matching contributions equal to 100% of the first 3% and 50% of the next 2% of compensation that an eligible participant contributed to the Plan were made for 2024 and 2023. Effective January 1, 2025, Safe Harbor matching contributions were removed from the Plan.

At the discretion of the Company’s Board of Trustees, additional discretionary profit sharing contributions may be authorized for the related year. These contributions are funded in the year subsequent to their authorization. Allocations of the Company’s profit sharing contribution are given only to eligible participants, as defined above, who completed at least 1 hour of service during the Plan year, and are based on participants’ compensation for the Plan year relating to the contribution. Profit sharing contributions authorized for 2024 and 2023 were \$1,070,382 and \$977,615, respectively.

Employee and safe harbor matching contributions are determined and recorded at the time compensation is paid. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

## NOTES TO FINANCIAL STATEMENTS

#### 1 Description of Plan, Continued

##### *Participants' Accounts:*

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contributions and (b) Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### *Participant-Directed Investment Options:*

Upon enrollment in the Plan, a participant may direct the investment of their contributions into any of several investment options with varying degrees of risk and volatility, allowing participants to allocate their investments in accordance with their own risk tolerances and time horizons. Participants may change their investment options at any time. In addition, participants have the option of a self-directed brokerage account that allows participants to invest in any publicly traded security.

##### *Vesting:*

Participants are immediately vested in their contributions and Company safe harbor matching contributions plus actual earnings thereon. Vesting in the Company's discretionary profit sharing contributions is based on years of service. A participant is 100% vested after 3 years of credited service.

##### *Forfeited Accounts:*

Forfeitures due to termination by a participant before they are 100% vested are used to pay administrative expenses or to reduce future Company contributions. Forfeited nonvested accounts totaled \$44,985 and \$13,030 as of December 31, 2024 and 2023.

##### *Notes Receivable from Participants:*

Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. Such loans bear interest at a reasonable rate commensurate with current interest rates charged for loans made under similar circumstances by persons in the business of lending money as determined at inception by the plan administrator. Principal and interest is usually paid ratably through payroll deductions but can also be paid directly by the participants to the Custodian.

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

##### *Other Plan Provisions:*

Normal retirement age is 65, however, a participant may elect early retirement on or after age 55.

#### **1 Description of Plan, Continued**

##### ***Payment of Benefits:***

Upon termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over a future period. Participants may elect to receive an in-service distribution upon reaching age 59½ and obtaining at least five years of service. Distributions of a participant's 401(k) account balance may be authorized at any time by the Plan Administrator under certain hardship conditions.

#### **2 Summary of Significant Accounting Policies**

##### ***Basis of Accounting:***

The Plan's transactions are reported on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

##### ***Valuation of Investments:***

Marketable securities are reported at fair market value as of the balance sheet date. Fair market values represent quoted market prices or, if quoted market prices are not available, estimated fair values as determined by the Plan's investment holder. Value of the investment in the AUL Stable Value Account is based on the value of the underlying assets held in the insurance company's general account. Loans are valued at cost which approximates fair value. The Board of Trustees determines the Plan's valuation policies utilizing information provided by the Trustee. See Note 4 for discussion of fair value investments.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

##### ***Use of Estimates:***

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenue and expenses during the reporting period. Actual results could differ from those estimates.

##### ***Payment of Benefits:***

Benefits are recorded when paid.

### 2 Summary of Significant Accounting Policies, Continued

#### *Administrative Fees:*

Certain expenses are paid by the Company and are excluded from these financial statements. Expenses of maintaining the Plan, including participant recordkeeping and certain fees related to distributions and the administration of notes receivable from participants, are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

#### *Plan Termination:*

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

#### *Risks and Uncertainties:*

The Plan includes investments in various types of securities and fixed contracts with varying degrees of risk, such as interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the Statement of Net Assets Available for Plan Benefits.

#### *Subsequent Events:*

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through October 14, 2025, which is the date the financial statements were available to be issued.

### 3 Tax Status

The Plan adopted a non-standardized pre-approved profit sharing plan. On June 30, 2020, the Internal Revenue Service (IRS) issued an opinion letter stating that the form of the pre-approved plan used by the Plan is acceptable under Section 401 of the Internal Revenue Code ("IRC"). The Plan has not received a determination letter specific to the Plan itself. However, the Plan Administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken uncertain tax positions that more-likely-than-not would not be sustained upon examination by applicable taxing authorities. The Plan administrator has analyzed tax positions taken by the Plan and has concluded that, as of December 31, 2024 there are no uncertain tax positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions. However, currently no audits for any tax periods are in progress.

#### 4 Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under Topic 820 are described as follows:

Level 1: Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2: Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- \* Quoted prices for similar assets or liabilities in active markets
- \* Quoted prices for identical or similar assets or liabilities in inactive markets
- \* Inputs other than quoted prices that are observable for the asset or liability
- \* Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs that are unobservable inputs for the asset or liability.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

##### ***Mutual Funds:***

The fair value of the mutual funds are based on quoted market prices.

##### ***Unallocated Insurance Contract (AUL Stable Value Account):***

The fair value of the unallocated insurance contract is based on the value of the underlying assets, which are held in the insurance company's general account. The fair value is expressed in units. The unallocated insurance contract is not fully benefit responsive and is classified in the Level 3 category of the valuation hierarchy. Participant transactions may occur daily, there are no liquidity provisions and there are no restrictions on redemptions.

##### ***Self-Directed Brokerage Account:***

Accounts primarily consist of mutual funds and common stocks that are valued on the basis of readily determinable market prices.

**8 Prohibited Transactions**
