As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that are regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings and certain internal control related matters that we identified during the audit.

Other Matter - Supplemental Schedule Required by ERISA

The supplemental schedule of assets (held at end of year) as of December 31, 2024 is presented for the purpose of additional analysis and is not a required part of the financial statements, but is supplementary information required by the DOL’s Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with U.S. GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL’s Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 1 - DESCRIPTION OF PLAN

The following description of the HarbisonWalker International 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions, which is available from the Plan administrator.

General - The Plan is a defined contribution plan sponsored by HarbisonWalker International, Inc. (HWI) (Company) to cover all employees of the Company except for those covered by a collective bargaining agreement. The Plan is structured to incorporate the provisions available under Section 401(k) of the Internal Revenue Code (IRC), which allows participant contributions to be excluded from federal and state income taxation within certain prescribed limits. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Through December 31, 2024, T. Rowe Trust Company was the Plan's trustee and recordkeeper. Effective January 1, 2025, Transamerica Retirement Solutions became the sole trustee and recordkeeper of the Plan.

Participation and Eligibility - Employees, except for those covered by a collective bargaining agreement, are eligible to participate in the Plan upon employment. Leased employees, nonresident aliens who do not have United States source income and employees who are residents of Puerto Rico are also excluded. There are no age or service requirements in order to be eligible to participate in the Plan.

The Plan includes a provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation, and their contributions are invested in the Vanguard Balanced Index Inst Fund until changed by the participant. The deferral percentage automatically increases by 1% each year, up to a maximum of 10% of eligible compensation.

Contributions - Each year, participants may contribute up to 50% of their pretax annual compensation, as defined in the Plan and subject to IRC limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions subject to IRC limitations. The Plan allows rollover contributions from other qualified plans for eligible employees.

The Company matches 150% of the first 2% of eligible compensation contributed by a participant and 100% of the next 4%. Participants direct their contributions, actual earnings thereon and any contributions made on their behalf into various investment options offered by the Plan.

Participant Accounts - Each participant's account is credited with the participant's contributions, the Company's matching contributions and allocations of Plan earnings, and is charged with an allocation of administrative expenses. Plan earnings are allocated based on the participant's share of net earnings or losses of his/her respective elected investment options. Allocations of administrative expenses are based on the participant's account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participant contributions and qualified matching contributions, plus actual earnings thereon, vest immediately. Company regular matching contributions and related earnings vest based on years of service. Participants vest 25% after one year of service, 50% after two years, 75% after three and are 100% vested after four years of service.

Notes Receivable From Participants - Loans may not exceed the lesser of \$50,000 reduced by the excess of the highest outstanding balance of loans during the one-year period ending on the day before the loan is made, over the outstanding balance of loans from the Plan on the date the loan is made, or 50% of the participant's account balance. Loans are secured by the balance in the participant's account, bear interest at the prime rate plus 1% and must be repaid within five years through payroll deductions unless the loan is utilized for a principal residence, in which case the loan must be repaid within 10 years. In accordance with Plan provisions, deemed defaulted loans are treated as distributions.

Payment of Benefits - Distribution of account balances may be made upon retirement, disability, death, termination or, under certain circumstances, in the event of financial hardship. Service withdrawals are permitted once the participant reaches the age of 59½. In the case of retirement, death or termination, the participant or beneficiary may elect to transfer the qualifying portion of his or her account balance to an individual retirement account or, if applicable, another eligible employer plan. Distributions under the Plan are payable in lump-sum or installment amounts. Terminated participants whose vested balance is less than \$7,000 are subject to a mandatory single-sum payment or direct rollover.

Administration - The Plan is administered by the HWI Retirement Administration Committee (Committee) and the HWI Retirement Investment Committee (Investment Committee) of the Company. The Committee oversees the administration of the Plan, including determining administrative actions and interpreting and applying the Plan's provisions. It has the right to settle claims on debts and to defend any claims arising from the operation of the Plan. The Investment Committee oversees the investments of the Plan through the investment consultant and reviews the investments of the Plan quarterly with the investment consultant.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A summary of significant accounting policies consistently applied by the Plan administrator in the preparation of the accompanying financial statements follows:

Basis of Accounting - The accompanying financial statements have been prepared on the accrual basis of accounting.

Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition - Investments are reported at fair value (except for fully benefit-responsive investment contracts), which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants - Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be a distribution, the participant loan balance is reduced and a benefit payment is recorded.

Administrative Expenses - Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. The fees were not material for the year ended December 31, 2024. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments.

Payment of Benefits - Benefits are recorded when paid.

Subsequent Events - Management evaluated subsequent events for the Plan through October 15, 2025, the date the financial statements were available to be issued.

NOTE 3 - FAIR VALUE MEASUREMENT

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy under the Financial Accounting Standards Board Accounting Standards Codification Topic 820 are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology that are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual funds are public investment vehicles valued using the net asset value (NAV) provided by the administrator of the fund on the last day of the Plan's year-end using a quoted price in an active market and are classified within Level 1 of the fair value hierarchy.

The Plan has a collective investment trust (CIT). CITs are public investment vehicles valued using the NAV provided by the trustee on the last day of the Plan's year-end. NAV is based on the value of underlying investments, primarily high-quality fixed-income investments, minus liabilities, then divided by the number of shares outstanding. The objective of the CIT is to preserve principal while generating earnings at rates competitive over time with short-term high-quality fixed-income investments while maintaining sufficient liquidity to provide participant-directed withdrawals at their proportionate share of contract value. Participant-directed redemptions have no restrictions; however, the Plan is required to provide at least a 12-month written notice to redeem some or all of its shares in the fund. There were no unfunded commitments in regards to the CITs as of December 31, 2024 and 2023.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Further, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 4 - CERTIFIED FINANCIAL INFORMATION (UNAUDITED)

The Plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, T. Rowe Price Trust Company (trustee), a qualified institution, has certified that the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statement of net assets available for benefits as of December 31, 2023.
- Interest and dividend income, net appreciation in fair value of investments and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

At the request of the Plan administrator, the Plan's independent auditor did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

As of December 31, 2024, approximately \$124,645,000 and \$2,650,000 of investments and notes receivable from participants, respectively, have not been certified by the respective trustee.

NOTE 5 - TAX STATUS

The underlying volume submitter plan has received an advisory letter from the Internal Revenue Service dated August 19, 2020, stating that the form of the Plan is qualified under Section 401 of the IRC and, therefore, the related trust is tax-exempt. Although the Plan has been amended since receiving the advisory letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by a taxing authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes that the Plan is no longer subject to income tax examinations for the years prior to 2021.

NOTE 6 - RELATED PARTIES AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments in mutual funds and the collective investment trust are managed by a trustee of the Plan. Fees paid by the Plan to the trustee for recordkeeping services were not significant for the year ended December 31, 2024. These transactions qualify as party-in-interest transactions. These transactions are not, however, considered prohibited transactions under section 408(b) of the ERISA regulations. Certain administrative functions are performed by officers or employees of the Company at no cost to the Plan.

NOTE 7 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

NOTE 8 - RISKS AND UNCERTAINTIES

The Plan invests in securities that are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the risks will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.
