Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of National Hot Rod Association 401(k) Salary Savings Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

1. DESCRIPTION OF PLAN

The following description of National Hot Rod Association 401(k) Salary Savings Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established under the provisions of Section 401(a) of the Internal Revenue Code (IRC), which includes a qualified cash or deferred arrangement as described in Section 401(k) of the IRC for the benefit of eligible employees of the National Hot Rod Association (the Employer). Effective July 22, 2024, all employees, except those covered by a collective bargaining agreement and nonresident aliens, are eligible to participate in the Plan starting on the first day of the calendar month after completing one month of service. This amendment supersedes the previous eligibility criteria which required completion of a year of service, which is defined as a 12-consecutive month period with at least 1,000 hours of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may elect to contribute a certain amount of their pre-tax compensation as salary deferrals to the Plan. Participants who have attained age 50 before the plan year-end are also able to make additional catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans. The Employer is required to make a safe harbor matching contribution equal to 100% of the first 4% of a participant's eligible compensation contributed to the Plan as pre-tax contributions. There were no discretionary profit sharing contributions for the year ended December 31, 2024.

Participant Accounts

Participants direct the investment of their contributions into investment options, consisting of various investments, offered by the Plan. Each participant's account is credited with the participant's contributions, and an allocation of (a) the Employer's contributions, and (b) the Plan's earnings and administrative expenses. Allocations are based on participant compensation, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. All participants are 100% vested in their participant accounts.

Notes Receivable from Participants

Participants may borrow from their individual participant accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Loans must be repaid within five years, except in the case of the purchase of a primary residence. Loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates. At December 31, 2024, interest rates ranged from 3.25% to 8.50%. Principal and interest are normally paid ratably through payroll deductions.

1. DESCRIPTION OF PLAN (Continued)

Forfeited Accounts

Forfeited accounts include the non-vested portion of the Company's contributions, including any realized earnings thereon, previously allocated to former participants in the Plan. Forfeited balances may be used to reduce future employer contributions or to pay administrative expenses based on the plan sponsor's discretion. At December 31, 2024 and 2023, there were forfeited balances of \$5. There were no forfeitures used to pay plan contributions or expenses in 2024.

Payments of Benefits

On termination of service, a participant may elect to receive either a lump sum distribution equal to the value of the participant's vested interest in his or her account, or a distribution in installments. In-service withdrawals are allowed under certain conditions.

Plan Termination

Although it has not expressed any intent to do so, the Employer is under no obligation or liability to continue its contributions and may discontinue such contributions or terminate the Plan subject to the provisions of ERISA.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared using the accrual method of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes in those assets and liabilities, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for disclosures regarding fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest and dividends are recorded when payable and as received. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. Management fees and operating expenses charged to the Plan for investments in the mutual funds, money market funds and common/collective trusts are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expense are reflected as a reduction of investment income for such investments.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Notes Receivable from Participants

Notes receivable from participants are stated at the unpaid principal balance. Interest income associated with the notes receivable is recorded as earned as per the related loan amortization schedules. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a distribution is recorded based on terms of the Plan Document.

Payment of Benefits

Benefits are recorded when paid or upon distribution.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Employer, at its option, and are excluded from these financial statements. Fees related to specific participant transactions, such as for participant loans, are charged directly to the participant's account and are included in administrative expenses. For the year ended December 31, 2024, the Plan received \$295 credits which can be used to offset the administrative expenses for the year. The net affect of administrative expenses and revenue credits is reported as administrative expenses in the Statement of Changes in the Net Assets Available for Benefits. The balance of the revenue credit account was \$529 as of December 31, 2024.

3. FINANCIAL INFORMATION CERTIFIED BY THE TRUSTEE

Certain information related to investments and notes receivable from participants reflected in the accompanying financial statements and supplemental schedule, which include investments and notes receivable from participants at December 31, 2024 and 2023, and net appreciation in fair value of investments, dividends and capital gains and loss from investments, and interest income from notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Fidelity Management Trust Company, the trustee of the Plan, in accordance with Section 2520.103-5(c) of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy with the related inputs to the valuation methodology are described as follows:

Level 1 - Quoted prices (unadjusted) in active markets for identical assets that the Plan has the ability to access.

Level 2 - Significant other observable (directly or indirectly) inputs, including quoted prices for similar assets in active markets or in inactive markets and other market observable inputs such as interest rate, credit risks, etc.

Level 3 - Significant unobservable inputs, including the Plan's own assumptions in determining the fair value of investments.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds

Mutual funds are valued at their quoted market prices.

Money Market Funds

Money market funds are valued at the daily closing net asset value of the respective fund.

Common/collective Trust Funds

The Plan's investments in common/collective trust funds are valued at net asset value (NAV) of the fund provider by the issuer based on the fair value of the underlying investments. The NAV is used as a practical expedient to estimate fair value.

(1) Trust units may be redeemed on a daily basis to meet benefit payments and other participant initiated withdrawals permitted by the Plan. Trust units are generally issued and redeemed only on a valuation date and at the net asset value per unit computed on that date. There were no unfunded commitments and there is no required redemption notice period.

5. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain plan investments are shares of mutual funds managed by Fidelity Management and Research Company, who is an affiliate of the trustee. Fees incurred by the Plan for investment management services are included in net appreciation in fair value of investments. In addition as noted in Note 2, certain administrative expenses related to certain participant transactions are paid directly to the trustee and totaled \$23,981 for the year ended December 31, 2024. The trustee may also give revenue credits to the Plan administrative expense during the year. These transactions, including notes receivable from participants, qualify as allowable party-in-interest transactions for which there are statutory exemptions.

6. INCOME TAX STATUS

The underlying standardized prototype plan has received an opinion letter from the Internal Revenue Service in June 30, 2020, stating that the written form of the underlying prototype document is qualified under section 401(a) of the IRC, and that any employer adopting this form of the plan will be considered to have a plan qualified under section 401(a) of IRC. Therefore, the related trust is exempt from taxation. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan Administrator believes that the Plan is designed and currently being operated in compliance with the Plan terms and the applicable requirements of the IRC, and therefore believe that the Plan is qualified and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the taxing authorities. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values on investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
