Opinion

We have audited the accompanying financial statements of Hydraulic Controls, Inc. Employee Stock Ownership Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), which comprise the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, and the related Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits of Hydraulic Controls, Inc. Employee Stock Ownership Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits for the year ended December 31, 2024, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion



- 1. Description of the Plan** The following description of the Hydraulic Controls, Inc. Employee Stock Ownership Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering substantially all employees of Hydraulic Controls, Inc. (the "Company") who have attained age 21 and completed one year of service of 1,000 hours, except for employees covered by a collective bargaining agreement, independent contractors, leased employees, and nonresident aliens. Each eligible employee shall become a participant on the January 1 or July 1 coincident with or next following the date eligibility requirements are met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

The Plan is leveraged employee stock ownership plan (ESOP) and is designed to comply with Internal Revenue Code Section 4975(e)(7).

As discussed in Note 5, the Plan entered into a loan agreement with the Company to repurchase shares held by terminated participants. The borrowings are collateralized by the unallocated shares acquired. The financial statements of the Plan as of December 31, 2024 and 2023, and for the year ended December 31, 2024, present separately the assets and liabilities and changes therein pertaining to the accounts of employees with vested rights in allocated Company stock (allocated), and Company stock not yet allocated to employees (unallocated).

Contributions: Employer discretionary contributions to the Plan are determined by the Board of Directors, and must be in an amount sufficient to satisfy the payment schedule under the note agreement. Contributions to the Plan shall be made in cash or, if there is no nonexempt prohibited transaction, in such property as is acceptable to the trustee. Participants must complete 1,000 hours of service and be employed on the last day of the Plan year to be eligible to receive an allocation of employer contributions, unless termination was due to retirement, disability, or death. The Plan does not permit contributions from participants. Contributions are subject to certain limitations.

Participant accounts: Each participant's account is credited with the allocation of Company discretionary contributions, if applicable, investment earnings and losses, forfeitures of terminated participants' non-vested accounts, and charged with an allocation of administrative expenses. Allocations of employer contributions and forfeitures are based on participant compensation, as defined by the Plan document. Allocations of investment earnings and losses and administrative expenses are based on the account balances, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Payment of benefits: Benefits are payable upon retirement at age 65, disability, death, or termination of employment. Benefits are payable in lump sums or substantially equal installment payments not to exceed five years. If termination was due to death, disability, or retirement, payments will begin not later than the end of the Plan year following the year in which termination occurred. If termination was as a result of any other reason, benefit payments will commence as soon as possible after the close of the fifth plan year following termination. If the value of a terminated participant's account does not exceed \$10,000, the participant's vested benefit may be paid as soon as administratively feasible on or after the December 31 coinciding with or next following termination of employment. The Plan was amended effective January 1, 2022, to allow for participant's that terminated on or before December 31, 2017 to request a special lump sum distribution of their entire vested account between October 31, 2022 and November 30, 2022.

Vesting: Vesting in the Company discretionary contributions is based on years of continuous service of at least 1,000 hours per year. A participant is 20 percent vested after two years of service are completed, and vests an additional 20 percent per year until full vesting after six years.

Forfeited accounts: Forfeitures of terminated non-vested accounts are allocated to remaining participants on an annual basis as of the last day of the Plan year. Participants must complete 1,000 hours of service and be employed on the last day of the Plan year to be eligible to receive an allocation of the forfeitures. For the year ended December 31, 2024, 423 forfeited shares were reallocated to eligible participants.

Diversification: Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company stock into investments that are more diversified. Participants who are at least age 55 with at least 10 years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may diversify up to 25 percent of the number of shares allocated to his or her account, less any shares previously diversified. In the sixth year the percentage changes to 50 percent.

Voting rights: Participants will be entitled to exercise voting rights attributable to the shares of Company stock allocated to their accounts in the Plan with respect to certain major corporate matters, such as mergers, consolidations, sale of all assets, or the liquidation of the Company. The Plan Trustee votes on all other corporate matters.

Put option: Under federal income tax regulations, any Company stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no active market. The put price is representative of the fair value of the stock. The Company can pay for the purchase with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

Administrative expenses: Certain expenses of maintaining the Plan are paid by the Company.

2. Significant accounting policies

Basis of accounting: The financial statements of the Plan are prepared under the accrual method of accounting.

Investment valuation and income recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of benefits: Benefits are recorded when paid.

Allocations: The financial statements of the Plan represent separately the assets and liabilities and changes therein pertaining to (a) the accounts of employees with rights in allocated stock ("allocated") and (b) stock not yet allocated to employees ("unallocated"), including shares that are committed to be released. Shares are released from collateral and become allocated generally in the period in which debt service is actually paid.

Use of estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Subsequent events: The Plan has evaluated subsequent events for disclosure in these financial statements through October 15, 2025, which is the date the financial statements were available to be issued.

In addition to the Company stock, the Plan also has nonparticipant-directed investments in a money market fund. At December 31, 2024, the Plan holds a money market fund with a total cost of \$100,054 and fair value of \$100,054. At December 31, 2023 the Plan held a money market fund with a total cost of \$95,130 and fair value of \$95,130.

4. Fair value measurements

The Plan reports its assets at fair value based on a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1. Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2. Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, and inputs that are derived from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3. Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Money market funds are reported at cost, which approximates fair value.

The Plan's investment in shares of the Company's common stock is reported at its fair value as determined by an independent appraiser retained for the purpose by the Plan's trustee. The independent fair value appraisal is dependent upon historical and forecasted operations of the Company as represented by management, and general industry and market conditions affecting the Company's business. The fair value appraisal was determined using a combination of the income and market approaches. Within the income approach the discounted cash flow method was used. Within the market approach earnings multiples derived from private company transactions and guideline public companies method were used.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

6. **Risks and uncertainties** The Plan's investments consist primarily of the Company's common stock, which is exposed to various risks, including interest rate, market and credit risks, as well as valuation assumptions based on earnings and cash flows. Due to the level of risk associated with the investment in the common stock and to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in the value of the common stock will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.
7. **Plan termination** Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.
8. **Related party and party-in-interest transactions** The Plan allows for transactions with certain parties who may perform services or have fiduciary responsibilities to the Plan. Such parties are parties-in-interest under ERISA. The Company paid certain administrative expenses of the Plan, including recordkeeping and audit fees. The Plan holds Company common stock and has related debt payable to the Company. These transactions qualify as party-in-interest transactions which a statutory exemption exists.
9. **Tax status** The Internal Revenue Service ("IRS") has determined and informed the Plan administrator by letter dated February 20, 2015, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). The Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan has been amended since receiving the determination letter. However, the Plan administrator believes that the Plan is currently designed, and being operated, in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
