To the Trustees of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Clear Global Solutions LLC 401(k) Profit Sharing Plan and Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

NOTE 1 – Description of Plan

The following description of the Clear Global Solutions LLC 401(k) Profit Sharing Plan and Trust (“Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

A. Nature of the Plan

The Plan provides a defined contribution plan with elective deferral 401(k) and Roth 401(k) features covering eligible employees of Clear Global Solutions LLC (Company) over the age of 18. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The trustee of the Plan is Mid Atlantic Trust Company.

The Plan’s federal identification number is 46-3185597 and the Plan number is 002.

B. Contributions

Each year, participants may contribute up to 92% of pretax annual compensation subject to the maximum deferral amount allowed by the IRS. Participants who will attain age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds. The Company safe harbor match is a discretionary match. Safe harbor matching contributions were 100% of the first 3% of participant base compensation contributed and 50% thereafter up to 5% of participant base compensation contributed to the Plan for the year ended December 31, 2024. The Company contributed \$106,758 as employer safe harbor matching contributions for the year ended December 31, 2024.

C. Participant Accounts and Rollovers

Each participant’s account is credited with the participant’s contribution and an allocation of (a) the Company’s contribution, (b) Plan earnings, losses, and (c) forfeitures of terminated participant’s nonvested accounts. Allocations of Plan earnings and losses are based on participant earnings or account balances, as defined, and allocations of Company contributions are based on participants’ compensation, as provided in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. The Plan permits the transfer of funds from other qualified plans to a participant’s separate rollover account.

D. Forfeitures

If a participant terminates employment, any non-vested Company contributions are forfeited when the participant incurs five consecutive 1 year breaks in service, or when the participant receives a distribution of their entire vested balance, whichever occurs first. The forfeited amounts can be used to reduce Company matching contributions, Company profit sharing contributions, or pay Plan expenses. For the year ended December 31, 2024, Plan expenses were reduced by \$-0- from forfeited non-vested accounts. At December 31, 2024, forfeited, non-vested accounts totaled \$-0-.

E. Investment Options

Upon enrollment in the Plan, a participant may invest their account balances (including all Company contributions allocated to them) in 1% increments in a variety of mutual funds. Participants may change their investment options at such times established by the Plan Administrator in a uniform and nondiscriminatory manner.

F. Vesting

Participants are immediately vested in their elective deferral contributions and rollover contributions plus actual earnings thereon. Vesting in the Company's matching contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. Participants become vested in the matching contribution and discretionary profit-sharing contribution in accordance with the following schedule:

G. Payments of Benefits

Upon termination of service due to death, disability, or retirement (age 65), a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. In addition, an in-service withdrawal of funds can be made for any reason after attainment of at least age 59 ½ years, provided certain conditions are met. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Mandatory distributions are required for all terminated employees with balances less than \$1,000.

H. Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to 50% of their vested account balance. Loan transactions are treated as a transfer from (to) the investment fund and to (from) the loan fund. Loan terms cannot exceed 4.5 years unless the loan qualifies as a home loan for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at rates that range from 8.75% to 9.00% which are based on the prevailing interest rate charged on similar commercial loans under like circumstances by persons in the business of lending. Principal and interest are paid through payroll deductions.

NOTE 2 – Summary of Significant Accounting Policies

A summary of the Plan’s significant accounting policies consistently applied in the preparation of the accompanying financial statements are as follows.

A. Method of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting. Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the plan.

B. Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

B. Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based on the terms of the plan document.

C. Investment Valuation and Income Recognition

Investments are reported at fair value, except for fully benefit-responsive contracts, which are reported at contract value. The fair value of the registered investment companies is based on the fair value of their underlying assets as reported to the Plan by Mid Atlantic Trust Company.

Purchases and sales of securities are recorded on a trade-date basis. Interest and dividend income is recorded on the accrual basis. Net appreciation and depreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

D. Payment of Benefits

Benefits are recorded when paid.

E. Administrative Expenses

Paychex Retirement Services, Inc. is the third-party administrator, and Mid Atlantic Trust Company is the custodian and trustee of the Plan. The custodian is responsible for investing and safekeeping all of the Plan assets. Costs of administering the Plan are paid by the Company and the Plan.

F. Subsequent Events

For the year ended December 31, 2024, the Company has evaluated subsequent events for potential recognition and disclosure through October 3, 2025, the date the financial statements were available for issuance.

In accordance with Subtopic 820-10, certain investments that were measured at net asset value per share (or its equivalent) have not been classified in the fair value hierarchy. The fair value amounts presented in this table are intended to permit reconciliation of the fair value hierarchy to the line items presented in the Statement of Net Assets Available for Benefits.

Financial Accounting Standards Board Accounting Standards Codification (FASB ASC) 820-10, Fair Value Measurements, establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 1 inputs were available to the Plan, so Level 2 and 3 inputs were not used.

Mutual funds are valued at the net asset value of the shares held by the Plan at year end as determined by quoted market prices.

NOTE 4 – Custodian’s Certification and Investments

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments held at year end, and net appreciation in fair value of investments, interest and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Mid Atlantic Trust Company (the custodian of the Plan).

NOTE 5 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. If the Plan is terminated, the Plan Agreement including all rights, titles, powers, duties, discretions and immunities imposed upon or reserved to the Trustee and the Company will continue in effect until all assets have been distributed by the Trustee as directed by the Company. Each Plan participant's amounts credited to their accounts will become 100% vested in the event the Plan is terminated.

NOTE 6 – Tax Status

The Plan has received a favorable determination from the Internal Revenue Service, which qualifies it for tax-exempt status. The Plan obtained its latest determination letter on August 30, 2020 in which the Internal Revenue Service stated that the Plan was in compliance with applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examinations by the US Federal authorities. Plan management determined there were no items to be recognized as of December 31, 2024. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 – Party-In-Interest Transactions

Parties-in-interest are defined under the Department of Labor's (DOL) Rules and Regulations as any fiduciary of the Plan, and party rendering services to the Plan, the Company, and certain others. Certain Plan investments are shares of mutual fund accounts managed by Mid Atlantic Trust Company. As such, transactions conducted with Mid Atlantic and the Company qualify as party-in-interest transactions.

NOTE 8 – Supplemental Schedule

Disclosures required by regulations include separate schedules of: (1) assets (held at end of year) and assets (acquired and disposed of within the year), (2) loans in default or uncollectible, (3) leases in default or uncollectible, (4) reportable transactions, (5) nonexempt transactions with parties in interest and (6) delinquent participant contributions.

Schedules 2, 3, 4, 5, and 6 are not included herein as they are not applicable to this Plan as of or for the year ended December 31, 2024.

NOTE 9 – Risks and Uncertainties
