*Opinion*

We have audited the financial statements of the Lee Enterprises Welfare Benefit Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), which comprise the statements of net assets available for benefits and of benefit obligations as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits and of changes in benefit obligations for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits and accumulated plan benefits of the Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits and its accumulated plan benefits for the years then ended in accordance with accounting principles generally accepted in the United States of America.

*Basis for Opinion*

#### Note 1 - Description of the Plan

The following description of the Lee Enterprises Welfare Benefit Plan (the "Plan") is provided for general information purposes only and is sponsored by Lee Enterprises, Inc. (the "Company" or "Plan Sponsor"). Participants should refer to the Plan agreement for complete information of the Plan's provisions.

##### **General**

The Plan constitutes an employee welfare benefit plan under the applicable section of the Employee Retirement Income Security Act of 1974 ("ERISA") and is extended to substantially all active eligible employees and their eligible dependents. The Plan Sponsor has designated the Plan to pay the medical claims of its participants. Eligible employees may elect medical services through their preferred provider organizations participating in the Plan, or any medical organization of their choice. Claim payments are based on each participant's coverage election.

The Plan had an interest in the Pulitzer Inc. Employee Benefits Trust ("Master Trust") which covers benefits of only certain covered participants. This interest was fully exhausted during 2020.

##### **Contributions**

The Plan is contributory, funded by both participant and employer contributions. Employee contributions are based upon rates determined by the Plan Sponsor and the claims processor. Any and all remaining participant claims and administrative fees are paid by the Company, which has committed to make payments to the Plan as needed to pay any remaining benefits and expenses related to the Plan.

##### **Stop loss coverage**

The Company has entered into a stop loss insurance arrangement in an effort to limit its exposure for self-insured benefits (individual participant claims over a specific dollar amount, as well as its aggregate exposure for all claims).

##### **Self-insured benefits**

All Plan benefits are self-insured. The claims are processed by the Plan's third-party claims processor under an administrative services only ("ASO") arrangement. The claims processor pays claims directly to or on behalf of participants and is then reimbursed by contributions from the Company. Despite the Plan's utilization of third-party claims processors, ultimate responsibility for payments to providers and participants is retained by the Plan.

The Plan utilizes a pharmacy benefit manager ("PBM") which periodically makes refunds to the Plan based on the Plan's actual utilization pattern of specific drugs.

#### Note 2 - Summary of significant accounting policies

##### **Basis of accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

##### **Use of estimates**

The preparation of the Plan's financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires the Plan administrator to make estimates and assumptions that affect certain reported amounts of net assets available for benefits and of benefit obligations, and changes in net assets available for benefits and of changes in benefit obligations during the reporting periods and, when applicable, disclosures of contingent

assets and liabilities at the date of the financial statements. Accordingly, actual results could differ from those estimates.

#### **Payments of benefits**

Claim payments are recorded when paid by the third-party claims processor as claims paid in the accompanying statements of changes in net assets available for benefits. Amounts due to claims processors that have yet to be reimbursed by the Plan are recorded as payable to claims administrators in the accompanying statements of net assets available for benefits.

#### **Administrative expenses**

The Plan pays administrative expenses that consist primarily of administrative fees paid to third-party claims administrators, the trustee, and actuary. These expenses are reported on the statements of changes in net assets available for benefits as administrative expenses. All other administrative expenses, such as professional fees, are paid by the Company on behalf of the Plan.

#### **Claims incurred but not reported**

Plan obligations at December 31 for claims incurred but not reported are estimated by the Plan's actuary in accordance with accepted actuarial principles based on claims data provided by the Plan's third-party claims administrators. These amounts are paid by the Plan only if claims are submitted and approved for payment.

#### **Stop loss**

Premiums for stop loss insurance are included in administrative expenses in the accompanying statements of changes in net assets available for benefits. Stop loss refunds included in claims paid, net of reimbursements in the accompanying statements of changes in net assets available for benefits totaled \$0 and \$2,761 for the years ended December 31, 2024 and 2023, respectively. As of December 31, 2024 and 2023, there was no stop loss due from the insurance provider.

#### **Refunds**

Refunds due from the Plan's PBM are recorded when earned. Refunds due as of the financial statement date have been reported as a receivable, with the offset being netted against claims paid. Pharmacy rebates totaling \$2,385,204 and \$2,523,240 have been netted with claims paid in the accompanying statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, respectively. As of December 31, 2024 and 2023, refunds of \$620,828 and \$1,209,869, respectively, are due from the providers.

The Plan's allowance for credit losses represents its estimate of current and expected credit losses related to its refunds from providers. Ongoing credit evaluations are performed and potential losses from uncollectible accounts are written off against revenue when they are estimated to be uncollectible. The Plan has determined that there was no allowance for credit losses as of December 31, 2024 and 2023, respectively, and had no write-offs or recoveries for the years then ended.

#### **Subsequent events**

The Plan has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued.

### **Note 3 - Master Trust**

In prior years, a portion of the Plan's investments were in the Master Trust, which was established for the investment of assets of the Plan and other Company sponsored health and welfare plans.

Each participating health and welfare plan has an undivided interest in the Master Trust. The assets of the Master Trust are held by State Street Bank & Trust Company.

The value of the Plan's interest in the Master Trust is based on the beginning of year value of the Plan's interest in the trust plus allocated investment income less Company reimbursements and allocated administrative expenses. In prior years, the Plan had exhausted all of its share of the Master Trust and, as a result, had no balance at December 31, 2024 and 2023.

#### **Note 4 - Income tax status**

The Voluntary Employees' Beneficiary Association ("VEBA") trust funding certain benefits of the Plan received an exemption letter from the Internal Revenue Service ("IRS") dated June 13, 1990, stating that the trust is tax-exempt under the provisions of Section 501(c)9 of the Internal Revenue Code ("IRC"). However, as a result of the Plan's funding policy, from time to time the trust may be subject to income taxes. No federal or state income taxes have been recorded for unrelated business taxable income. In addition, the Plan and the trust are required to operate in conformity with the IRC to maintain the tax-exempt status of the trust. The Plan administrator believes that the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if it has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **Note 5 - Plan termination**

Although it has not expressed any intention to do so, the Company has the right under the Plan to modify the benefits provided to, and contributions required of, participants to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants. No assets of the Plan may revert to the Company or be used for purposes other than for the exclusive benefit of the Plan's participants.

#### **Note 6 - Transactions with party-in-interest and related parties**

As described in Notes 1 and 2, the Plan has several arrangements with service providers. These transactions are party-in-interest transactions under ERISA.

Certain stop loss reimbursements mentioned in Note 2 were for claims sourced by the Plan Sponsor. The amount of refunds outstanding from the insurance provider that were originally sourced by the Plan Sponsor are presented in due from Plan Sponsor on the accompanying statements of net assets available for benefits. As of December 31, 2024 and 2023, there were no stop loss refunds due from the Plan Sponsor.

Refunds mentioned in Note 2 are for claims sourced by the Plan Sponsor. As such, any outstanding amounts due from the providers are presented as due to Plan Sponsor on the accompanying statements of net assets available for benefits. As of December 31, 2024 and 2023, refunds due to the Plan Sponsor were \$620,828 and \$1,209,869, respectively.

#### Note 7 - Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.



