Opinion

We have audited the financial statements of Clínica de Salud del Valle de Salinas Employee Group Health Benefit Trust Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and plan benefit obligations as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits and in benefit obligations for the years then ended, and the related notes to the financial statements.

NOTES TO FINANCIAL STATEMENTS

1. PLAN DESCRIPTION

The following description of the Clinica de Salud del Valle de Salinas Employee Group Health Benefit Trust Plan (the "Plan") is provided for general information only. Participants should refer to the Plan agreement for a complete description of all Plan provisions.

General

The Plan is a self-funded health and welfare benefit plan sponsored by Clinica de Salud del Valle de Salinas (the "Sponsor" or "Employer") to provide health benefits including medical, dental, and vision coverage. The Plan is intended to comply with the Employee Retirement Income Security Act of 1974 (ERISA), as amended, and is classified as a welfare benefit plan under ERISA. The Plan became effective on November 1, 2020.

Eligibility

All employees of the Employer working an average of 30 hours per week or more are eligible to participate. Eligible dependents of employees may also participate in the Plan.

Plan Benefits

The Plan provides medical, dental, and vision benefits to eligible employees and their eligible dependents. Benefits are administered by third-party administrators (TPAs) under service agreements.

Funding Policy

The Plan is funded by both employer and employee contributions based on the provisions of the Plan. The employer contributes amounts determined based on the Plan's projected cash requirements. Contributions received from members are used to cover Plan costs and are expended immediately.

Termination

Although the Sponsor has not expressed any intention to do so, it has the right under the Plan to modify the benefits provided to active employees, to discontinue its contributions at any time, and to terminate the Plan subject to the provisions set forth in ERISA.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Benefit Obligations

The Plan's total benefit obligation is an estimate consisting of amounts payable to health providers for services rendered prior to the end of the year and claims incurred but not reported. The Plan's liabilities are based on information provided by third-party administrators.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, claims incurred but not reported, claims payable, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Stop-loss Arrangements

The Plan enters into stop-loss arrangements with insurance companies. Under such arrangements, the Plan's obligation is capped at a fixed amount per participant. For the plan year, the Plan paid no more than \$85,000 per individual participant through October 31, 2024. Effective November 1, 2024, the Plan changed stop-loss carriers and the individual stop-loss limit increased to \$110,000 per participant. The insurance company assumes all risk beyond the stated limit. Total stop-loss recoveries netted against benefit payments were \$396,562 and \$469,964 for December 31, 2024 and 2023, respectively.

Cash

The Plan considers all highly liquid investments with maturities of three months or less to be cash equivalents. As of December 31, 2024 and 2023, the Plan maintained cash balances in non-interest-bearing accounts for payment of claims and administrative expenses.

Administrative expenses

Administrative expenses include third-party administrator fees and other administrative costs. These expenses are paid from Plan assets and/or employer contributions.

3. TAX STATUS

The trust established under the Plan to hold the Plan's assets qualifies as employer sponsored as permitted pursuant to the regulations. The Plan's management believes the trust, as amended, continues to qualify and is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require the Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan's management has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

4. PARTY-IN-INTEREST TRANSACTIONS

Fees paid during the years ended December 31, 2024 and 2023 for administration of the Plan and other services rendered by parties-in-interest were for the amount of \$175,002 and \$122,696 based on customary and reasonable rates for such services.

5. CONTINGENCIES

The Plan sometimes becomes involved in various claims and subject to certain contingencies in the normal course of business. The Plan's management believes that these claims are without merits and intends to vigorously defend any claims which may be asserted.

6. SUBSEQUENT EVENTS

Subsequent events have been evaluated through October 10, 2025, which is the date the financial statements were available to be issued.
