Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (“investment information”) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA (“qualified institution”).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors’ Responsibilities for the Audit of the Financial Statements section:

Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

NOTE 1 – DESCRIPTION OF THE PLAN

The following description of the GSW Sports LLC 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General – The Plan is a defined contribution plan which was established on January 1, 1987 to provide retirement benefits for employees of GSW Sports LLC and certain affiliated companies. Participating employers of the Plan include GSW Sports LLC and its affiliates: Golden State Warriors LLC, SC Warriors LLC, GSW Arena LLC, Warriors Community Foundation, GSW Real Estate LLC, GSW Master Retail LLC, GSW Real Estate Office Corp., ECOP Tower I Owner LLC, Event Center Office Partners LLC, GSW Arena Holdings LLC, GSW Sports Ventures LLC, and GSW eSports LLC (collectively, the “Company”).

The Plan covers all eligible employees who are not leased employees, union employees, players, contractors, interns (paid or unpaid), employees eligible to participate in the Restated National Basketball Association Saving Plan for Coaches and Trainers, nonresident aliens with no U.S. income, or employees who are employed by an affiliated employer which has not adopted this Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended, and certain provisions of the Internal Revenue Code (“IRC”). Employees become eligible to participate immediately upon their hire date and upon reaching 15 years of age.

The Plan is administered by the Retirement Plan Committee. The Retirement Plan Committee has overall responsibility for the operation and administration of the Plan. The Retirement Plan Committee determines the appropriateness of the Plan’s investment offerings, monitors investment performance and reports to the Plan’s management. The Plan provides for a plan administrator who is responsible for keeping accurate and complete records with regard to the Plan’s operations, informing participants of changes or amendments to the Plan, ensuring that the Plan conforms to the law and to government regulations, and providing participants with any reports and documents required by law. The Plan has appointed Fidelity Management Trust Company as its trustee (“Fidelity”, “FMTC” or the “trustee”) and Fidelity Workplace Services LLC (“FWS”) as its record-keeper.

Participant Contributions – Participants may make pre-tax and post-tax (Roth) contributions to the Plan. A participant’s combined annual pre-tax and Roth contributions to the Plan may not exceed 75% of the participant’s annual compensation, limited to \$23,000 for the year ended December 31, 2024. Additionally, participants who have attained 50 years of age before the end of the Plan year are eligible to make catch up contributions of up to \$7,500 for 2024. Participants may also make “rollover” contributions representing distributions from other qualified retirement plans.

Once an employee satisfies the eligibility requirements to participate in the Plan, and if he or she does not make a deferral election within a reasonable period of time after he or she is hired, rehired or reclassified, or affirmatively opts out, 4% of the employee’s eligible compensation automatically will be deferred and contributed to the Plan and that amount shall be deemed the employee’s deferral election. Furthermore, participants with a deferral rate greater than zero will automatically have their deferral increased annually by 1% until a deferral rate of 12% is reached, unless the participant has otherwise established a periodic deferral increase or has elected to forego such an increase. An employee may terminate their participation in the Plan at any time pursuant to the Plan’s notification requirements.

NOTE 1 – DESCRIPTION OF THE PLAN (Continued)

Employer Contributions – The Company has the option to make matching contributions equal to a discretionary percentage, to be determined by the Company, of the participant’s elective deferral. The Company may also make an annual discretionary profit sharing contribution at the option of the Company’s board of directors, subject to limitations imposed by applicable provisions of the IRC. The Company may change this formula at any time. For the year ended December 31, 2024, the Company elected to make matching contributions equal to 50% of each participant’s contribution up to the first 6% of the participant’s eligible compensation, with a maximum matching contribution of \$2,000 per year. Part time, temporary, and seasonal employees whose regularly scheduled service is less than 1,000 hours for the year are excluded from employer matching contributions, unless the excluded employee completes 1,000 hours of service and is employed for one year.

Participant Accounts – The Plan maintains an account for each participant which is credited with the participant’s contributions and Company matching contributions, if any, as well as allocations of profit sharing contributions, if any, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting – Participants are immediately vested in their voluntary contributions and rollover contributions plus actual earnings thereon. Vesting in the Company’s discretionary profit sharing and matching contributions, if any, and earnings thereon is based on the number of years of service as presented in the following schedule:

2	67%
3 or more	100%

Investment Options – Upon enrollment in the Plan, a participant may direct the investment of their account balance into various funds offered by the Plan. Each investment option has its own investment strategy, which can be obtained through the prospectus of the respective fund. Participants may change their investment options at any time.

Notes Receivable from Participants – Participants may borrow from their vested account balance provided they meet the Plan’s eligibility requirements. The minimum loan amount is \$1,000 and the maximum amount is the lesser of one-half of the participant’s vested account balance or \$50,000. The term of the loan may not exceed five years, except for loans used to finance the purchase of a primary residence, for which longer repayment terms are permitted. The loans are secured by the balance in the participant’s account. Principal and interest are paid ratably through payroll deductions and loans are due immediately upon termination of employment. Interest rates are determined by the plan administrator, based on the prime rate as published in the Wall Street Journal plus 1%, and remain fixed throughout the life of the loan.

Payment of Benefits – Upon termination of service, death, disability or retirement, a participant may elect to receive a distribution in the form of a lump-sum payment, installment payments, or a combination of lump-sum and installment payments. If a terminated participant's account balance is between \$1,000 and \$7,000, and no instructions have been received from such participant, the amount will be rolled over to an individual retirement account as designated by the Plan administrator. Vested account balances of less than \$1,000 are automatically cashed out as a single lump-sum distribution. Normal retirement age is 65 years. A participant may also elect to receive a pre-retirement distribution if the participant is 100% vested in the amount being distributed and has reached 59½ years of age. A participant may also request a hardship withdrawal in certain circumstances. Minimum required distributions generally must begin by April 1 of the calendar year following the later of the year the participant reaches age 73 or the year in which the participant terminates employment.

Forfeited Accounts – The non-vested portion of a terminated participant's account balance is forfeited. Forfeited accounts are applied to reduce employer contributions and fund administrative expenses. As of December 31, 2024 and 2023, forfeited non-vested accounts amount to \$324,358 and \$69,595, respectively. During the year ended December 31, 2024, forfeitures of \$1,582 were used to pay administrative expenses and forfeitures of \$37,113 were used to fund employer contributions.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting – The Plan's financial statements are prepared on the accrual basis of accounting, in conformity with accounting principles generally accepted in the United States of America.

Use of Estimates – The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amount of assets, liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of changes in net assets available for benefits during the reporting period. Actual results may differ from those estimates.

Investment Valuation and Income Recognition – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Retirement Plan Committee determines the Plan's valuation policies utilizing information provided by Fidelity and the Plan's investment advisors. See Note 3 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants – Notes receivable from participants represent loans that are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses when they are incurred.

Contribution – Contributions are recorded in the Plan year which coincides with the payroll pay date.

Payments of Benefits – Benefits are recorded when paid.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Administrative Expenses – Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and distributions are charged directly to the participant’s account and are included in administrative expenses. Investment related expenses are included in net appreciation or depreciation of the fair value of investments.

Concentrations – As of both December 31, 2024 and 2023, four investments accounted for approximately 46% of total investments. Additionally, investments held in target date funds accounted for 64% and 65% of total investments as of December 31, 2024 and 2023.

NOTE 3 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques are required to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used by the Plan for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE 3 – FAIR VALUE MEASUREMENTS (Continued)

Collective Trust Fund: Valued at the NAV of units of a common collective trust fund. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require twelve months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

These valuation methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan's management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 4 – INFORMATION CERTIFIED BY THE TRUSTEE

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Workplace Services LLC (“FWS”), the recordkeeper of the Plan, as an agent for Fidelity Management Trust Company (“FMTC”), the trustee, has certified to the completeness and accuracy of all investments and the notes receivable from participants reflected on the accompanying Statements of Net Assets Available for Benefits and in Note 3, as of December 31, 2024 and 2023, and the supplemental Schedule H, line 4i: Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment income and interest income on notes receivable from participants reflected in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024.

The Plan’s independent public accountants did not perform auditing procedures with respect to this information except for comparing such information to the related information included in the financial statements and supplemental schedule.

NOTE 5 – TAX STATUS

The Company has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the IRC. Although, the Plan has been amended since adopting the pre-approved plan document, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the tax authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in process.

NOTE 6 – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan assets are managed by an affiliate of FMTC. FMTC serves as the trustee of the Plan. Therefore, these transactions with its affiliate qualify as party-in-interest transactions.

Fees paid by the Plan for investment management services are included in net appreciation or depreciation in fair value of investments, as they are paid through revenue sharing, rather than a direct payment. FMTC provided certain administrative services to the Plan pursuant to a service agreement between the Company and FMTC. FMTC also received revenue from certain investment service providers for services FMTC provides to the funds. This revenue is used to offset certain amounts owed to FMTC for its administrative services to the Plan. If the revenue received by FMTC from such investment service providers exceeds the amount owed under the service agreement, FMTC remits the excess to the Plan. FMTC assigned all rights, duties and obligations under the service agreement to FWS. The Plan or Plan sponsor are permitted to make payments to FMTC for administration expenses not covered by revenue sharing.

NOTE 7 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

NOTE 8 – RISKS AND UNCERTAINTIES

The Plan provides for various investment options in any combination from among the funds offered through the Plan. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

NOTE 9 – OPERATIONAL ISSUES

During the years ended December 31, 2024, 2023 and 2022, there were unintentional delays by the Company in remitting certain employee contributions and loan repayments amounting to \$3,438,357, \$1,553,377 and \$168,066, respectively, to the Plan within the period prescribed by Department of Labor regulations. The Company made necessary corrections for the 2024, 2023 and 2022 late contributions in 2025.

During the years ended December 31, 2024, 2023 and 2022, management of the Plan discovered that there were certain discrepancies in the application of eligible compensation and auto-enrolling eligible employees. Plan management made amendments to the Plan effective January 1, 2025, to clarify the definition of eligible compensation. For the period prior to January 1, 2025, Plan management is currently researching any additional corrective action, including a retro-plan amendment. Plan management believes any potential corrective action amount will be insignificant to the financial statements.

NOTE 10 – SUBSEQUENT EVENTS

Effective January 1, 2025, the Plan was amended and restated with substantially the same provisions. The amended adoption agreement changed the sponsoring employer from GSW Sports LLC to Golden State Group LLC and changed the Plan name from GSW Sports LLC 401(k) Plan to Golden State Group LLC 401(k) Plan. In addition, nine adopting employers, who did not have employees, were removed from the Plan and four adopting employers were added to the Plan. In addition, effective January 1, 2025, the Company has elected to make safe harbor matching contributions equal to 100% of the first 3% of a participant's eligible compensation and 50% of the next 2% of a participant's eligible compensation.

Effective January 1, 2025, plan management made amendments to the Plan to clarify the definition of eligible compensation.

The Plan's management has evaluated subsequent events through October 15, 2025, the date the financial statements were available to be issued.
