We have performed audits of the financial statements of S4 Capital 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). ### 1. Description of the Plan

The following description of the S4 Capital 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan documents, as amended, for a more complete description of the Plan's provisions.

#### *General*

The Plan is a tax qualified defined contribution plan which provides for retirement benefits and covers all eligible employees of MightyHive, Inc., and certain participating employers who are affiliates (the Company or the Plan Sponsor). Employees are eligible to participate in the Plan immediately upon date of hire. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Effective January 1, 2024, XX Artists LLC, Proof, LLC, and Citrusbyte, LLC dba TheoremOne LLC. become adopting employers of the plan.

#### *Trustee and Administration of the Plan*

The Company and certain members of management who are the plan fiduciaries also act as the plan administrator, and as such are responsible for oversight of the Plan, including determining the appropriateness of the Plan's investment offerings and monitoring investment performance.

Charles Schwab Trust Bank (Schwab) is the trustee of the Plan, and the recordkeeping administrative services are performed by Schwab Retirement Plan Services, Inc, an affiliate of Schwab. The Trustee has authority to hold, manage, and protect the assets of the Plan in accordance with the provisions of the Plan.

#### *Contributions*

Each year, participants may elect to contribute a portion of their eligible pre-tax compensation, as defined in the Plan Document, up to the maximum allowable under the Internal Revenue Code (IRC). Participants age 50 or older before the close of the calendar year may also elect to make additional pre-tax catch-up contributions to the Plan, not to exceed the amount allowable under current income tax regulations. Participants are also allowed to make Roth contributions to the Plan. Participants may contribute amounts representing distributions from other qualified plans which are reflected as rollover contributions in the statement of changes in net assets available for benefits. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan Sponsor contributes non-elective Safe Harbor contributions at 3% of eligible compensation. The contribution is determined at each payroll period. In addition, each year, the Plan Sponsor may elect to contribute ACP Safe Harbor Matching Contributions, based upon the percentage of compensation that a participant contributes to the Plan. During the year ended December 31, 2024, the Plan Sponsor contributed \$8,165,572 in non-elective Safe Harbor contributions.

#### *Participant Accounts*

Each participant's account is credited with the participant's contributions, the Company's contributions, and Plan earnings. Participant accounts are charged with an allocation of

administrative expenses that are paid by the Plan, as applicable. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### ***Notes Receivable from Participants***

In accordance with the provisions of the Plan, participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance. Loan transactions are treated as transfers between participant-directed investments and notes receivable from participants.

Loan terms range from one to five years or up to ten years for the purchase of a primary residence. The loans are collateralized by the participant's vested balance in the Plan and bear interest at the prime rate plus 1%. Principal and interest is paid ratably through payroll deductions.

Also, each participant may not have more than one loan outstanding at any time.

### ***Vesting***

Participants are vested immediately in their voluntary contributions and both non-elective and discretionary Safe Harbor contributions plus actual earnings thereon.

### ***Payment of Benefits***

On termination of service due to death, disability or retirement, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account.

Immediate lump-sum distributions may be made to terminated participants if the participant's vested account balance is \$1,000 or less. For terminated participants with vested balances greater than \$1,000, but less than \$7,000, their vested balance may be automatically rolled into an IRA unless otherwise elected. A participant with an account balance in excess of \$7,000 may request to receive a lump sum payment, a partial payment, or rollover the account to an Individual Retirement Account (IRA) or another qualified plan.

Participants over age 59½ are also entitled to receive a distribution of all or any portion of their vested account balance. Under certain circumstances, a participant may qualify for a hardship distribution.

## **2. Summary of Accounting Policies**

### ***Basis of Accounting***

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

### ***Use of Estimates***

The preparation of financial statements in accordance with GAAP requires Plan management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes

therein, and disclosure of contingent assets and liabilities. Actual results could differ materially from those estimates.

### ***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan administrator determines the Plan's valuation policies utilizing information provided by the trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### ***Contributions Receivable***

Participant contributions and any related non-elective Safe Harbor matching contributions are recognized in the period during which the Company makes the respective payroll deduction from the participant's compensation. ACP Safe Harbor Matching contributions are recorded in the relevant period in accordance with the terms in the Plan document.

### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus accrued unpaid interest. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

### ***Payment of Benefits***

Benefits are recorded when paid.

### ***Administrative Expenses***

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to distributions from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

### ***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.

### 3. Certified Investment Information

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule H, Line 4i - Schedule of Assets (Held at End of Year) related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Schwab, a qualified institution.

### 4. Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820, are described as follows:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds* - Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. Mutual funds held by the Plan are deemed to be actively traded.

*Common Collective Trust (CCT)* - Common/collective trusts are valued at the NAV of units held. The NAV, as provided by the trustee of the CCT, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the CCT less its liabilities. This practical expedient is not used when it is determined to be probable that the CCTs will sell for an amount different than the reported NAV. The CCT provides for daily redemptions by the Plan at reported NAV with no advance notice. There are no unfunded commitments related to these investments. They are direct filing entities.

The preceding methods described may produce a fair value calculation which may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

## **5. Tax Status**

During 2021, the Plan adopted the defined contribution pre-approved plan and trust sponsored by Schwab, and the Internal Revenue Service (IRS) informed Schwab by an opinion letter dated September 21, 2020, that the pre-approved plan upon which the Plan is based is designed in accordance with the provisions of the IRC. The Plan has since been amended; however, in the opinion of the Plan's administrator, the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and thus qualifies the Plan and related trust for tax-exempt status.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## Notes to Financial Statements

---

On July 31, 2025, the Plan Sponsor received a final closing report from the Department of Labor (DOL) indicating no further findings and concluding its investigation initiated in 2023 pursuant to Section 504 of the Employee Retirement Income Security Act of 1974 (ERISA), 29 U.S.C. Section 1134.

### 6. Related Party and Party-in-Interest Transactions

The Plan pays certain fees to Schwab for administrative services. The Plan also issues loans to participants which are secured by the vested balance of the participants' accounts. Such transactions qualify as party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

### 7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would remain 100% vested in any employer contributions.

### 8. Non-Exempt Transactions

During the 2023 and 2022 Plan years, certain participant contributions were not remitted to the Plan within the period prescribed by DOL regulations. The contributions were funded to the Plan during the respective years. The lost earnings related to such contributions was remitted to the Plan during the 2024 Plan year.

### 9. Transfer from Other Qualified Plans

On January 2, 2024, TheoremOne LLC 401(k) and Profit Sharing Plan merged into the Plan with assets of approximately \$9,356,200 and assets of approximately \$1,432,800 attributable to the employees of Proof LLC was transferred from TriNet 401k plan, a multiple employer plan sponsored by TriNet HR III Inc. On February 22, 2024, XX Artists 401(k) Plan merged into the Plan with assets of approximately \$3,079,000. The net asset of all plans totaled approximately \$13,868,000, which included approximately \$85,000 of notes receivable from participants.

### 10. Subsequent Events

Management has evaluated subsequent events through October 15, 2025, the date the financial statements were available to be issued. There were no events or transactions discovered during the evaluation that require recognition or disclosure in the financial statements, except as noted below.

Effective February 4, 2025, Formula consultants Inc. employee plan and on May 1, 2025, 4 mile analytics (Trinet 401k plan), a multiple employer plan sponsored by TriNet HR III Inc. merged into the Plan with assets of approximately \$7,187,000 and \$703,000 respectively.
