Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### **NOTE 1: DESCRIPTION OF PLAN**

The following description of the JTS Financial Services, LLC 401(k) Profit Sharing Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan, which was established January 1, 2012, is a defined contribution retirement plan maintained for the benefit of eligible employees of JTS Financial Services, LLC (the Employer, Plan Sponsor and Plan Administrator) and certain other affiliated companies. Collectively, JTS Financial Services, LLC and its affiliated companies are hereinafter referred to as the "Employers". Prior to December 11, 2024, an employee was generally eligible to participate in the Plan at the next entry date after attaining age twenty-one and completing one year of service. Beginning December 11, 2024, employees may participate in the plan at the next entry date after attaining age twenty-one and completing six months of service.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Prior to December 11, 2024, the Employer utilized the services of John Hancock Life Insurance Company (John Hancock), a third-party administrator, to process investment transactions and maintain participant account balances. John Hancock was also the Plan's asset custodian and investment manager. Effective December 11, 2024, the Employer began utilizing the services of Fidelity Management Trust Company (Fidelity) to process participant transactions and maintain participant account balances. Fidelity also serves as the Plan's asset custodian and investment manager. In addition, the Plan Administrator has an agreement with Definiti, LLC (the recordkeeper) to assist them with compliance monitoring, regulatory filing, participant recordkeeping and Plan reporting. The owner of the Plan Sponsor is the Plan's Trustee.

The Plan Trustee is responsible for oversight of the Plan and is responsible for determining the appropriateness of the Plan's investment offerings and monitoring investment performance based on information provided by the custodian.

Certain duties related to the administration of the Plan are performed by employees of the Plan Sponsor; however, the Plan Sponsor does not charge the Plan for the estimated cost of such services. Expenses paid by the Plan Sponsor on behalf of the Plan totaled approximately \$5,500 for the year ended December 31, 2024.

#### **Plan Amendment**

Effective February 1, 2024, the Plan was amended to add an automatic enrollment provision and to allow for participant loans.

Effective December 11, 2024, the Plan was amended to adopt the Pre-Approved Defined Contribution Plan of Fidelity.

### **Contributions**

Participants may contribute up to 100% of annual compensation, as defined in the Plan agreement, not to exceed limitations imposed by the Internal Revenue Service (IRS). Participants may also make rollovers into the Plan consisting of amounts distributed from other qualified defined benefit or defined contribution plans. Beginning February 1, 2024, the Plan includes an automatic enrollment provision which provides that employees who have met the eligibility requirements will be automatically enrolled at a salary deferral rate of 5% of eligible compensation, unless the employee elects otherwise.

The Employers will make a safe harbor matching contribution to eligible employees equal to 100% of the participant's first 3% of compensation deferred and 50% of participant's deferred compensation between 3% and 5%. The Employers may also make an additional discretionary matching contribution to eligible participants not to exceed 6% of deferred compensation. In addition, the Employers may also make a nonelective contribution to those employees who have completed at least 1,000 hours of service during the Plan year and are employed on the last day of the Plan year. Employer contributions are also subject to limitations imposed by the IRS.

### **Participant Accounts**

Each participant's account is credited with the participant's contribution, the Employer's matching contributions and allocations of Employer nonelective contributions and Plan earnings, net of certain administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### **Vesting**

Participants are fully vested at all times in their own contributions and Employer safe harbor contributions plus earnings thereon. Vesting is based on years of service as defined in the Plan agreement. A participant is one hundred percent vested in Employer additional matching and nonelective contributions upon retirement, permanent disability or death. If a participant terminates employment for any other reason, he or she will vest in contributions made by the Employer, plus earnings thereon, according to the following schedule:

### **Investment Options**

From January 1, 2024 through December 11, 2024, participants could direct the investment of their accounts among the various investment options offered under the Plan's group annuity contract with John Hancock Life Insurance Company, including a variety of pooled separate accounts structured for different levels of risk tolerance and time horizons. Beginning December 11, 2024, the participants may direct the investment of their accounts among the various mutual funds offered by the Plan. The Plan also offers participants the option to invest their funds in self-directed brokerage accounts. Participants may change their investment options at any time.

### **Notes Receivable from Participants**

Participants may borrow from their accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loans may be extended for periods not to exceed five years, except when loan proceeds are used for the purchase of the borrower's primary residence, in which case the loan may be extended to ten years. The loans are secured by the participant's account and bear interest at rates ranging from 8.75% to 9.50%, which is commensurate with local prevailing rates at the time funds are borrowed as determined by the Plan Administrator. Principal and interest are paid through payroll deductions.

### **Forfeitures**

The non-vested portion of a participant's account to which the participant is not entitled upon termination is deemed a forfeiture. As allowed under the Plan agreement, forfeitures are used to pay administrative expenses, reduce any Employer contributions or allocated as additional Employer contributions. At December 31, 2024 and 2023, the balance of forfeited accounts totaled approximately \$1,400 and \$1,900, respectively. During the year ended December 31, 2024, forfeitures totaling \$1,935 were used to reduce the Employer's contribution.

### **Payment of Benefits**

Upon termination of service due to death, disability or retirement, a participant (or designated beneficiary) may elect to receive an amount equal to the value accumulated in his or her account in a lump-sum amount or as a direct rollover to another plan. For terminations of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. In-service distributions after a participant's attainment of age 59-½ are permitted as specified in the Plan agreement.

### **Termination of the Plan**

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

### ***NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES***

#### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

#### **Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly fashion between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the custodian. See Note 4 for further discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade date basis. Interest income is recorded on the accrual basis. Net appreciation or depreciation includes realized and unrealized gains and losses on investments bought and sold, as well as those held during the year.

#### **Payments of Benefits**

Benefits are recorded when paid. There are no amounts allocated to withdrawing participants that have not been paid at December 31, 2024 and 2023.

#### **Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

### ***NOTE 3: INFORMATION PREPARED AND CERTIFIED BY PLAN CUSTODIANS***

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, all information pertaining to the Plan's investments, notes receivable from participants and related activity reflected in the financial statements and supplemental schedule was certified by John Hancock Life Insurance Company, the Plan's custodian, for the period from January 1, 2024 through December 11, 2024, and by Fidelity Management Trust Company, the custodian, as of December 31, 2024, and for the period December 11, 2024 through December 31, 2024. This information was not subject to audit procedures except for comparing it to the related information included in the financial statements and supplemental schedule.

The following information included in the accompanying 2024 financial statements, related notes and supplemental schedule was obtained from data that has been prepared and certified to as complete and accurate by the Plan's custodians.

### **NOTE 4: FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described as follows:

- Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.
- Level 2      Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets
  - Quoted prices for identical or similar assets or liabilities in inactive markets
  - Inputs other than quoted prices that are observable for the asset or liability
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Self-directed Brokerage Accounts

Assets held in the self-directed brokerage accounts consist of private equity investments that are not readily determinable market prices. The fair value of private equity investments are determined based on the latest price or valuation date reported to the custodian.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Pooled Separate Accounts

The pooled separate accounts are valued at net asset value (NAV) of units held. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liability. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another.

Plan management evaluates the significance of transfers between levels based upon the nature of the financial instrument and size of the transfer relative to total net assets available for benefits.

During the year ended December 31, 2024, there were no purchases of Level 3 investments or transfers of assets into or out of Level 3.

### ***NOTE 5: TAX STATUS***

Effective December 11, 2024, the Plan executed an adoption agreement for the Fidelity Management and Research Company, LLC Profit Sharing/401(k) Pre-Approved Plan (the Prototype). As an adopter of the Prototype, the Plan is not subject to tax under present income tax law.

The Prototype obtained its latest opinion letter on June 30, 2020, in which the IRS stated that the Prototype, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan Administrator believes that the Plan is currently designed and being operated in compliance with applicable requirements of the Internal Revenue Code.

Accounting standards require the Plan Sponsor to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Sponsor has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require the recognition of a liability or disclosure in the financial statements. The Plan may be subject to audit by the IRS; however, there are currently no audits for any tax periods in progress.

### ***NOTE 6: RISKS AND UNCERTAINTIES***

The Plan's investments are exposed to various risks such as interest rate, market and credit risks. In addition, certain investment options may invest in foreign securities. There are certain additional risks involved when investing in foreign securities that are not present with investments in domestic securities. These risks may involve foreign currency exchange rate fluctuations, adverse political and economic developments and the possible prevention of currency exchange due to foreign governmental laws or restrictions. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the Plan's financial statements.

### ***NOTE 7: SUBSEQUENT EVENTS***

Management has evaluated subsequent events through October 13, 2025, the date that the financial statements were available to be issued.
