## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator  
**Nuvance Health 403(b) Plan**

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2024 Financial Statements**

We have performed an audit of the financial statements of Nuvance Health 403(b) Plan, (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

### NOTE 1 – DESCRIPTION OF THE PLAN

#### *PLAN DESCRIPTION*

The Nuvance Health 403(b) Plan (the “Plan”) was established effective July 1, 1986. Nuvance Health (“Nuvance”, “Employer” or the “Company”) is the sponsor of the Plan. The following brief description of the Plan is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions. The Nuvance Health Benefits Committee is responsible for oversight of the Plan, determines the appropriateness of the Plan’s investment offerings, and monitors investment performance.

On February 28, 2024, Nuvance Health entered into an affiliation agreement with Northwell Health, Inc. (“Northwell”), pursuant to which Northwell or an affiliated entity would become the active parent and sole corporate member of Nuvance Health. This transaction was subject to the receipt of regulatory approvals and the satisfaction of closing conditions. Effective May 1, 2025, the parties closed the transaction and Northwell, Inc. (which is the ultimate sole corporate member of Northwell) became the sole corporate member of Northwell Health System, Inc., which became the parent entity of Nuvance Health. The impact of this transaction on the Plan, if any, has not yet been determined.

#### *GENERAL*

The Plan is a defined contribution profit sharing plan covering all employees of Nuvance and its affiliates who are not students providing services described in Internal Revenue Code (“IRC”) Section 3121(b)(10) and who are not eligible under another 401(k) plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

#### *CONTRIBUTIONS*

Each year, participants may contribute up to 100% of pretax annual compensation, not to exceed the Internal Revenue Service (“IRS”) limit, as defined in the Plan agreement. Employer contributions are no longer permitted in the Plan.

#### *REVENUE CREDIT ACCOUNT*

The Plan has a revenue credit account, which is funded by the Custodian. Revenue credit accounts are used to pay administrative expenses. For the year ended December 31, 2024, there were revenue sharing contributions of \$77,669 and paid \$91,788 in administrative expenses. Revenue credits available for future use totaled \$10,767 and \$23,739 as of December 31, 2024 and 2023, respectively.

#### *VESTING*

Participants are immediately vested in their contributions plus actual earnings thereon.

#### *NOTES RECEIVABLE FROM PARTICIPANTS*

Participants may borrow from their accounts up to a maximum equal to the lesser of \$50,000 or 50 percent of the present value of their non-forfeitable accrued benefit. Note terms range from 1 to 5 years or, for a reasonable period in excess of 5 years when the note proceeds are used for the purchase of a primary residence. Plan provisions require that notes shall be adequately secured, bear a reasonable rate of interest, and that payments of principal and interest should be made at least quarterly. The interest rates were 4.25% - 9.74% on outstanding loans at December 31, 2024. Principal and interest is paid ratably through payroll deductions.

#### *PAYMENT OF BENEFITS*

Upon termination of service due to death, disability, retirement, or for other reasons, a participant may receive a lump-sum amount equal to the vested value of the participant's account. If a terminated participant's vested balance is less than or equal to \$7,000, the amount may be automatically distributed in the form of rollover to an individual retirement account designated by the Company.

#### *HARDSHIP WITHDRAWALS*

The Plan allows for hardship withdrawals in accordance with the IRS regulations as specified within the Plan agreement.

#### *PLAN TERMINATION*

Although it has not expressed any intention to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts. The assets available after the payment of any Plan expenses shall be distributed to the participants in accordance with the value of their accounts as of the date of termination.

#### *PARTICIPANT ACCOUNTS*

Participants direct employee contributions in investment options offered by the Plan. Each participant's account is credited with the participant contributions and an allocation of Plan earnings and is charged with an allocation of Plan expenses. The allocations are based on participant earnings or account balances, as defined.

### NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### *BASIS OF ACCOUNTING*

The financial statements of the Plan are prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

#### *INVESTMENT VALUATION AND INCOME RECOGNITION*

Investments, except for the investment contract and fixed income accounts described below, are stated at fair value, as determined by management based on information provided by Fidelity Management Trust Company ("Fidelity"), Transamerica Financial Life Insurance Company, Inc. ("TFLIC"), Lincoln Life and Annuity Company of New York ("Lincoln"), Metropolitan Life Insurance Company ("MetLife"), Brighthouse Life Insurance Company ("Brighthouse"), Mutual of America Life Insurance Company ("MOA"), American General Life Insurance Company ("AGLIC"), Voya Retirement Insurance and Annuity Company ("Voya"), and Empower Retirement LLC ("Empower"), collectively the Trustees. Fair value is the price that would be received to sell an asset or paid to transfer a liability (an exit price) in the principal most advantageous market for the asset or liability in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion of fair value measurements.

The Plan invests in a fully-benefit responsive investment contract through Principal and fixed income accounts through TFLIC, Lincoln, MetLife, Brighthouse, MOA, Voya, and Empower. The contract and fixed income accounts are included in the financial statements at contract value, as reported to the Plan by the Trustees. Contract value represents contributions made under contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

#### *INVESTMENT VALUATION AND INCOME RECOGNITION (CONTINUED)*

Unrealized gains/(losses) from the guaranteed investment contract and fixed income accounts are not included in the statements of changes in net assets available for benefits as the contract and fixed income accounts are recorded at contract value for purposes of net assets available for benefits.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments include the Plan's gains and losses on investments bought and sold as well as held during the year.

#### *USE OF ESTIMATES*

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect certain amounts reported in the financial statements and accompanying notes. Accordingly, actual results could differ from those estimates.

#### *RISKS AND UNCERTAINTIES*

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### *ADMINISTRATIVE EXPENSES*

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

#### *NOTES RECEIVABLE FROM PARTICIPANTS*

Notes receivable from participants are stated at their outstanding balances, plus accrued and unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

#### *PAYMENT OF BENEFITS*

Benefits are recorded when paid.

#### *RECLASSIFICATION*

Certain comparative figures have been reclassified to conform with the current year's presentation. These reclassifications were made to improve the clarity and consistency of the financial statements and had no impact on previously reported net assets available for benefits.

#### *RECENT ACCOUNTING STANDARDS*

The SECURE 2.0 Act of 2022 was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, becoming effective in 2023 and beyond. Plan management adopted mandatory provisions effective for the year ended December 31, 2024, and continues to evaluate the impact of the adoption and implementation of this legislation on the Plan. The application of SECURE 2.0 Act of 2022 did not have a material effect on the Plan's financial statements.

#### *SUBSEQUENT EVENTS*

Events subsequent to December 31, 2024 have been evaluated through October 15, 2025, representing the date that the financial statements were available to be issued.

There were no subsequent events, other than the disclosures in Notes 1 and 8, that have been identified requiring recognition or disclosure in these financial statements.

#### NOTE 3 – INFORMATION CERTIFIED BY THE PLAN’S TRUSTEES

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, dividends and interest and interest income on notes receivable from participants for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by the Trustees. This information has not been audited by the Plan’s independent auditors.

#### NOTE 4 – FAIR VALUE MEASUREMENTS

The Plan establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820, *Fair Value Measurement*, are described as follows:

Level 1: Quoted prices in active markets for identical assets or liabilities.

Level 2: Observable inputs other than quoted prices included in Level 1, such as quoted prices for markets that are not active or other inputs that are observable or can be corroborated by observable market data.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities. This includes certain pricing models, discounted cash flow methodologies and similar techniques that use significant unobservable inputs.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

#### NOTE 4 – FAIR VALUE MEASUREMENTS (CONTINUED)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds and self-directed investments:* Valued at the daily closing price as reported by the fund. Mutual funds and self-directed investments held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds and self-directed investments held by the Plan are deemed to be actively traded.

*Cash and cash equivalents:* Consist of cash and interest-bearing deposits with maturities of three months or less. Fair value is based on cost plus accrued interest.

*Pooled Separate Accounts:* Valued at participant unit value of share held by the Plan at year end.

#### NOTE 5 – INVESTMENT CONTRACT AND FIXED INCOME ACCOUNTS

The Plan has a guaranteed investment contract with Principal who maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Principal is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

There are no reserves against contract value for credit risk of Principal or otherwise. The crediting interest rate is based on a formula agreed upon with Principal, but may not be less than 1 percent. The interest rate credited to participants reflects the amortization of realized and unrealized gains and losses in the underlying investment contracts over the duration of the entire portfolio and may not reflect the actual returns achieved in the portfolio. From time to time, the crediting rate may be significantly greater or less than current market interest rates. Such interest rates are reviewed on a semi-annual basis for resetting. Generally, there are not any events that could limit the ability of the Plan to execute transactions at contract value within 90 days.

The guaranteed investment contract does not permit Principal to terminate the agreement prior to the scheduled maturity date.

The Plan's ability to receive amounts due is dependent on Principal's ability to meet its financial obligations. Principal's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. These events may be different under each contract. Such events include:

1. amendments to the Plan documents (including complete or partial Plan termination or merger with another plan);
2. changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions;
3. bankruptcy of the Company or other Company events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan;
4. the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA; or,
5. premature termination of the contract.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with Principal that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. These events may be different under each contract. Such events include:

1. an uncured violation of the Plan's investment guidelines;
2. a breach of material obligation under the contract;
3. a material misrepresentation; or,
4. a material amendment to the agreement without the consent of Principal.

The Plan invests in Insurance Fixed Accounts (the "accounts"), which are benefit-responsive investment contracts with TFLIC, Lincoln, MOA, Brighthouse, Voya, Empower, and MetLife. TFLIC, Lincoln, MOA, Brighthouse, Voya, Empower, and MetLife maintain the contributions in a general account (the "Fixed Fund"). The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Contract value represents deposits made to the Fixed Fund, plus interest credited under the terms of the accounts, less any withdrawals. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The interest crediting rate is determined annually and is primarily based on the current yield to maturity of the underlying investments, plus or minus amortization of the difference between the market value and the contract value of the underlying investments over the duration of the underlying investments at the time of computation. The accounts adjust the crediting interest rate on an annual basis.

Under the terms of the accounts, participants are generally permitted to make benefit distributions at contract value. However, participant elected withdrawals may be subject to a withdrawal charge if made for any reason other than the following: (1) disability, (2) death, (3) severance from employment, (4) hardship, (5) loans, (6) minimum required distributions, (7) lifetime installment payments or (8) at contract suspension, election of the 5 annual installment payment option.

Participants are generally permitted to make transfers at contract value from the Fixed Fund to non-competing funds made available under the participant's accounts. Such transfers are subject to a 90-day equity wash provision. Any amounts transferred from the Fixed Fund to non-competing funds will be subject to a 5% withdrawal charge if subsequently transferred to a competing fund or withdrawn within 90 days, except if the withdrawal is due to one of the above permitted reasons.

#### NOTE 6 – INCOME TAX STATUS

The Plan has been designed to qualify under Section 403(b) of the IRC. The terms of the Plan have been prepared to conform with the sample language provided by the IRS. The Plan is required to operate in conformity with the IRC to maintain the tax-exempt status for plan participants under Section 403(b). The plan administrator believes that the Plan has been designed to comply with and is operating in accordance with the applicable requirements of the IRC and, therefore, believes the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more-likely-than not would not be sustained upon examination by the applicable taxing authorities. The Plan did not take any uncertain tax positions as of December 31, 2024 and 2023. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods pending or in progress.

#### NOTE 7 – PARTY-IN-INTEREST TRANSACTIONS

During the years ended December 31, 2024 and 2023, Plan investments were managed by the Trustees, and therefore, these transactions qualify as party-in-interest transactions. The Plan allows participants to take loans against their account balances, which also qualify as exempt party-in-interest transactions. The Plan paid the Trustees certain expenses related to administrative and investment services which qualify as party-in-interest transactions.

Additionally, certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. These transactions are party-in-interest transactions under ERISA.

Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of investments, as they are paid through a revenue credit account, rather than a direct payment. The Custodian receives revenue from investment fund service providers for services the Custodian provides to the funds. This revenue is used to offset certain amounts owed to the Custodian for its administrative services to the Plan. If the revenue received by the Custodian from such investment fund service providers exceeds the amount owed for its services, the Custodian remits the excess to the Plan's trust on a quarterly basis. The Plan or plan sponsor may make a payment to the Custodian for administrative expenses not covered by revenue credits.

#### NOTE 8 – DELINQUENT CONTRIBUTIONS

For the year ended December 31, 2021, the Plan identified employee deferrals in the amount of \$2,736,830 that were not remitted timely to the Plan, in accordance with the Department of Labor's (DOL) Rules and Regulation 29 CFR 2510.3-102. These delinquent contributions along with lost earnings totaling \$5,896 were transmitted to the Plan during 2024.

For the year ended December 31, 2022, the Plan identified employee deferrals in the amount of \$38,629 that were not remitted timely to the Plan, in accordance with the DOL's Rules and Regulation 29 CFR 2510.3-102. These delinquent contributions along with lost earnings totaling \$1,264 were transmitted to the Plan during 2024.

For the year ended December 31, 2023, the Plan identified employee deferrals in the amount of \$78,403 that were not remitted timely to the Plan, in accordance with the Department of Labor's Rules and Regulation 29 CFR 2510.3-102. These delinquent contributions along with lost earnings totaling \$577 were transmitted to the Plan during 2024.

The Company filed a VFCP application on May 21, 2025 and is awaiting determination from the DOL.

For the year ended December 31, 2024, the Plan identified an employee deferral in the amount of \$338 that was not remitted timely to the Plan, in accordance with the Department of Labor's Rules and Regulation 29 CFR 2510.3-102. This delinquent contribution along with lost earnings will be transmitted to the Plan during 2025.

#### NOTE 9 – CONCENTRATION

As of December 31, 2024 and 2023, the Plan had investments of \$82,380,609 and \$70,531,394, that were concentrated in one fund.
