Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the financial statements of Miami Jewish Health Systems Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements (2024 Financial Statements).

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Note 1. Plan Description

The following description of Miami Jewish Health Systems Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan, which was originally adopted effective July 1, 2010, is classified as a 403(b) tax-deferred annuity plan. The employees of the Plan’s sponsor, Miami Jewish Health Systems, Inc. (“MJHS” or the “Plan Sponsor”), who are not leased employees, are eligible to make deferral contributions to the Plan immediately upon employment. The primary purpose of the Plan is to provide MJHS’s employees with financial benefits upon retirement. The Plan’s funds were held by VALIC Trust Company Inc. (the “Previous Plan Custodian”) as of December 31, 2023. During the year ended December 31, 2024, the Plan’s funds were transferred to Lincoln Financial Group Trust Company, Inc. (the “Current Plan Custodian”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Contributions

Each year a participant may contribute a maximum of 80% of pre-tax annual compensation, as defined in the Plan, subject to Internal Revenue Service (“IRS”) limitations, that may be pre-tax or Roth (after tax) contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. MJHS employees are eligible to receive employer contributions upon attainment of age 21 and completion of one year of service (as defined in the Plan). Participants’ contributions are made through a salary reduction agreement. MJHS may make a discretionary contribution for the benefit of all eligible participants. The discretionary contribution for the year ended December 31, 2024 was \$998,151.

Participant Investment Account Options

Participants direct the investment of their accounts into various investment options offered by the Plan. Investment account options available include an unallocated contract and mutual funds.

Participant Accounts

Under the Plan, a separate account is maintained for each participant. Each participant’s account is credited with the participant’s contribution, MJHS’s contribution, and allocations of Plan earnings, and charged with an allocation of administrative expenses, if any. Participant contributions and all employer contributions are allocated, at the participant’s election, to investment funds held at either the Previous Plan Custodian or Current Plan Custodian. Participants may change their investment options at any time with certain exceptions. Plan earnings are allocated based on the actual earnings of the respective participants’ investments. The benefit to which a participant is entitled is the vested benefit that can be provided from the participant’s account.

Notes Receivable from Participants

Participants may borrow a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their vested balances by executing a note in accordance with the Plan’s provisions. The notes are collateralized by the balance in the participant’s account and bear interest at a rate equal to 4.25% to 9.50%. Participants may only have one outstanding loan at any one time, and the loan must be generally repaid within five years from the date of the loan. Principal and interest are paid ratably through payroll deductions.

Vesting

Participants are immediately vested their voluntary contributions and employer safe harbor contributions (prior to January 1, 2024), plus actual earnings or losses thereon. Vesting in the qualified non-elective contributions is based on a six-year graded schedule with 0% vesting after year 1 and increasing 20% each year thereafter.

Payment of Benefits

Upon the death, permanent disability, or retirement of participants, distributions of benefits are made in lump-sum or installment payment, as elected by the participant of their vested account balance. As of December 31, 2024 and 2023, there were no amounts allocated to the accounts of individuals who have elected to withdraw from the Plan but have not been paid.

Forfeitures

Non-vested employer contributions forfeited by participants are used by MJHS to reduce future employer matching contributions or pay plan expenses. As of December 31, 2024 and 2023, the forfeiture account had a balance of approximately \$38,600 and \$0, respectively. There were no significant forfeitures used during the year ended December 31, 2024.

Note 2. Summary of Significant Accounting Policies

The following is a summary of significant accounting policies followed in the preparation of these financial statements, which have been prepared in accordance with accounting principles generally accepted in the United States of America.

Basis of Accounting

The financial statements of the Plan are presented on the accrual basis of accounting.

Investment Valuation and Income Recognition

Investments in mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan Custodian offers a fully benefit-responsive fixed annuity contract (the "Lincoln Stable Value Account") issued by The Lincoln National Life Insurance Company (the "Issuing Company"). The Lincoln Stable Value Account has a minimum guaranteed interest rate, which is 1.70% for all years. The investments in the Lincoln Stable Value Account are backed by the general account of the Issuing Company. Investments held in the Lincoln Stable Value Account are deemed to be fully benefit-responsive, and contract value is the relevant measurement attribute because that is the amount participants normally will receive if they were to initiate permitted transactions under the terms of the Plan. The Plan Custodian values the Lincoln Stable Value Account by crediting the declared rate of interest to the amounts allocated to the account. This value represents the amount Plan participants would receive if they were to withdraw or transfer funds within the Plan. The Plan's ability to receive amounts due in accordance with the fully benefit-responsive contract is dependent upon the third-party issuer's

ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer.

Investments held in unallocated contracts consist of the VALIC Fixed Interest Option (the "Fixed Interest Option"). Investments held in the Fixed Interest Option are deemed to be fully benefit-responsive investment contracts. Contract value is the relevant measurement attribute for fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan (see Note 4). The Plan's ability to receive amounts due in accordance with the fully benefit-responsive investment contract is dependent upon the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. There are no reserves against contract value for credit risk of the contract issuer. The Plan administrator believes that any events that would limit the Plan's ability to transact at contract value with participants or the issuer are not probable of occurring.

Purchases and sales of funds are reflected on a trade-date basis. Interest income is recorded as earned on the accrual basis. Interest is automatically reinvested in additional fund units.

In accordance with the Plan's policy of stating marketable securities at fair value, the net appreciation for the year ended December 31, 2024 is reflected in the statement of changes in net assets available for benefits as net appreciation in fair value of investments.

Notes Receivable from Participants

Notes receivable from participants are recorded at their unpaid principal balance, plus accrued but unpaid interest.

Contributions

Contributions to the Plan are recorded in the period in which they become obligations of the Plan Sponsor.

Payment of Benefits

Benefit payments to participant benefits are recorded when paid.

Administrative Expenses

During the year ended December 31, 2024, administrative expenses of approximately \$80,000 were charged by the Plan Custodian directly to the Plan. Certain investment fees, commissions, and reporting expenses are included in net appreciation of fair value of investments. The Plan Sponsor incurred administrative expenses on behalf of the Plan of approximately \$16,000 for the year ended December 31, 2024.

Estimates

The preparation of financial statements in conformity with generally accepted accounting principles and with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Subsequent Events

The Plan Sponsor has evaluated subsequent events for recognition and disclosure through October 15, 2025, which is the date the financial statements were available to be issued.

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Previous Plan Custodian and Current Plan Custodian has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income and interest income from notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 4. Fair Value Measurements

The fair value of financial instruments is presented based upon a hierarchy of levels that prioritize the inputs of valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described below:

- Level 1** Unadjusted quoted prices in active markets for identical assets or liabilities the Plan has the ability to access at the measurement date.
- Level 2** Inputs to the valuation methodology that are observable, either directly or indirectly, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3** Significant, unobservable inputs used for valuing the asset or liability in which little or no market data exists.

A financial instrument's level, within the fair value hierarchy, is based on the lowest level of input that is significant to the fair value measurement in its entirety.

Note 5. Exempt Party-in-Interest Transactions

Certain plan investments are funds managed by the Current Plan Custodian as defined by the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions. During 2024, administrative, advisory services, and other custodian costs associated with investment accounts were charged directly to the Plan. The Company also absorbs significant costs related to various administrative and investment advisory services on behalf of the Plan.

Note 6. Risks and Uncertainties

The Plan's investments are not insured and are subject to risk. Financial information relating to those investments is included in these financial statements based on information provided by the Plan Custodian.

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 7. Income Tax Status

The original plan is a volume submitter plan adopted by the Plan Sponsor. The volume submitter plan obtained its latest determination letter on April 5, 2018, in which the IRS stated that the prototype plan, as then designed, was in compliance with the applicable requirements of Section 403(b) of the Internal Revenue Code (the "Code"). The Plan is required to operate in conformity with the Code to maintain the tax-exempt status for Plan participants under Section 403(b). The Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Note 8. Plan Termination

Although it has not expressed any intent to do so, MJHS has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts, and the Plan assets shall be distributed in proportion to participants' respective account balances as of the date of termination.
