Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Ohio Laborers Annuity Fund (the "Fund"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Note 1: Description of Fund

The following description of the Ohio Laborers Annuity Fund (the “Fund”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Fund’s provisions.

General

The Fund is a multiemployer defined contribution retirement plan. The Fund was established on April 18, 2023 as a result of a collective bargaining agreement (CBA) between the Laborers Relations Division of the Ohio Contractors Association, the Associated General Contractors of America, Inc., which represents the participating employers and the Laborers’ District Council of Ohio, an affiliate of the Laborers’ International Union of North America, AFL-CIO (the “Union”), to provide retirement benefits to eligible participants and beneficiaries. To be eligible, an employee must be working for a participating employer who is subject to the CBA or for a participating employer subject to a Board of Trustee approved participation agreement. The Fund is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Fund’s Board of Trustees is responsible for oversight of the Fund.

The Board of Trustees, comprised of equal representation from the participating employers and the Union, have overall responsibility for the operation and administration of the Fund. The Board of Trustees, with assistance from professional advisors, determine the appropriateness of the Fund’s investments and monitor investment performance. Empower Trust Company, LLC serves as the custodian of the Fund’s investments.

Contributions

Beginning May 1, 2023 and under the terms of the CBA, participating employers contribute various amounts based upon the employee’s classification and hourly contribution rates as agreed upon between the Union and employers pursuant to a collective bargaining agreement or a participation agreement. Beginning May 1, 2023, participants may contribute amounts representing distributions from other qualified defined contribution plans (rollover), as defined by the plan agreement. Participants direct the investment of the employer contributions into various investment options offered by the Fund. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant’s account is credited with the rollover and employer contributions, as well as allocations of plan earnings. Allocations are based on participant account balances, as defined. Participant accounts are charged with an allocation of administrative expenses that are paid by the Fund. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are vested immediately in their rollover contributions and employer contributions plus actual earnings thereon.

Payment of Benefits

On termination of service due to death, disability, retirement, or a break in service, a participant may elect to receive benefits. The benefit amount the participant receives depends upon specific qualifications as outlined in the plan agreement. For termination for services for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Fund are prepared on the accrual basis of accounting.

Basis of Presentation

The Fund follows authoritative guidance issued by the Financial Accounting Standards Board (FASB), which established the FASB Accounting Standards Codification (ASC) as the single source of authoritative accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Fund's Board of Trustees determines the Fund's valuation policies utilizing information provided by its investment adviser and custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Fund's gains and losses on investments bought and sold as well as held during the period.

Note 2: Summary of Significant Accounting Policies (continued)

Employer Contributions and Receivables

Employer contributions, pertaining to participating employee hours worked during the year, are recorded as revenue. Contributions due from employers at year-end represent amounts received subsequent to year-end for hours worked prior to year-end. Therefore, the carrying amount of these receivables is not reduced by an allowance for amounts that will not be collected. In addition, it is impractical to estimate a recognition of revenue amounts due but erroneously unreported by employers.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

The Fund's expenses are paid by the Fund, as provided by the plan agreement. Fees related to the administration of benefit payments are charged directly to the participant's account and are included in administrative expenses. Expenses incurred in connection with the general administration of the Fund are recorded as deductions in the accompanying statements of changes in net assets available for benefits. The Fund shares certain administrative expenses with other entities. In computing these allocated costs, various factors were considered, including the time spent, space used, costs incurred, and volume of transactions relating to the Fund, in relation to other related entities in the allocation (See Note 6). In addition, certain investment related expenses are included in net appreciation (depreciation) in fair value of investments presented in the accompanying statements of changes in net assets available for benefits.

Subsequent Events

Management has evaluated subsequent events for the Fund through August 15, 2025, the date the financial statements were available to be issued.

Note 3: Certified Investments

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net (depreciation)/appreciation in fair value of investments and interest and dividends for the year ended December 31, 2024 and the period from inception, April 18, 2023 to December 31, 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company, LLC (the "Custodian").

Note 4: Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Fund has the ability to access.
- Level 2 Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability; and
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered investment companies: Valued at the daily closing price as reported by the fund. Mutual funds held by the Fund are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Fund are deemed to be actively traded.

Common collective trust fund: Valued at the NAV of units of the fund. The NAV, as provided by the investment manager, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying assets held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the Fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchased and sales) may occur daily. If the Fund initiates a full redemption, the issuer reserves the right to temporarily delay withdrawal in order to ensure that securities liquidations will be carried out in an orderly business manner.

Note 6: Related-Party and Party-in Interest Transactions

Under the terms of separate operating agreements between the Board of Trustees of the Fund, the Laborers’ District Council and Contractors’ Pension Fund of Ohio (the “Pension Fund”), Ohio Laborers’ District Council – Ohio Contractors’ Association Insurance Fund, the Ohio Laborers’ Training and Apprenticeship Trust Fund, the Ohio Laborers’ District Council – Ohio Contractors’ Association Cooperation and Education Trust (collectively, the “five funds”) and Laborers’ Local No. 265 Pension Plan, the Self-Administration Program of the Pension Fund purchases assets, employs personnel, and performs whatever services are necessary to provide effective administration for the five funds and the Local 265 Plan. The estimated cost of providing these services is charged monthly to the individual funds and annually adjusted to actual cost. The Fund’s share of administrative expenses under this arrangement for the years then ended December 31, 2024 and 2023 totaled \$128,949 and \$89,952, which is included in due to other funds, net on the statements of net assets available for benefits. In addition, the Fund owed other expenses to related entities in the amount of \$-0- and \$48,172 at December 31, 2024 and 2023.

The Self-Administration Program of the Pension Fund collects late fines and penalties from delinquent employers, which are netted with payments made related to collection costs incurred. The Fund receives a portion of the excess of amounts collected over the costs incurred and pays a portion of the excess of costs incurred over amounts collected. At December 31, 2024 and 2023, the Fund was owed \$79,563 and \$8,119, from the Pension Fund related to this activity.

The activities of the Self-Administration Program are directed by the Joint Administration Committee which is comprised of two representative trustees (one management and one labor) from each of the five funds and the Local 265 Plan.

The Fund paid certain expenses related to Fund operations and investment activity to various service providers. These transactions are considered exempt party in interest transactions under ERISA.

Note 7: Plan Termination

It is the intent of the Fund's Board of Trustees to continue the Fund in full force and effect; however, the right to discontinue the Fund is reserved by the Fund's Board of Trustees. During termination, the Fund's assets should not be used for and diverted to purposes other than the exclusive benefit of the participants. In the event of termination, after providing for the plan expenses, the net assets of the Fund will be allocated and shall be distributed in the same ratio as the participants' individual accounts to the total individual accounts of all participants, as prescribed by ERISA and related regulations.

Note 8: Tax Status

The Fund obtained its latest determination letter dated June 11, 2025, in which the Internal Revenue Service (IRS) states that the Fund, as then designed, was in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Fund and recognize a tax liability (or asset) if the Fund has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS or state taxing authorities. The Fund is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 9: Risk and Uncertainties

The Fund invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
