## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator and Participants of the  
Columbia Food Service Company 401(k) Profit Sharing Plan & Trust

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of the Columbia Food Service Company 401(k) Profit Sharing Plan & Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023 and the related statement of changes in net assets available for benefits for the year ended December 31, 2024 and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### *Opinion*

In our opinion, based on our audits and on the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. ### Note 1 - Description of plan:

The following description of the Columbia Food Service Company 401(k) Profit Sharing Plan & Trust (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan covering substantially all employees of the Columbia Food Service Company and its subsidiaries (the Company), who have attained age 21 and have completed 1 year of service, as defined in the Plan document. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Board of Trustees is responsible for oversight of the Plan and determining the appropriateness of the Plan's investment offerings and monitoring investment performance.

#### Contributions

Each year, participants may contribute up to the maximum amount allowed by the Internal Revenue Code (IRC). The Plan also allows participants to make Roth contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions, as defined in the Plan document. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover contributions).

The Plan has adopted an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically-enrolled participants have their deferral rate initially set at 2% of eligible compensation, unless they elect a different percentage, with a 1% annual increase up to a maximum of 5% and their contributions are invested in a designated default investment fund, unless alternative investments were selected, or until changed by the participant.

The Plan has adopted a Safe Harbor Provision resulting in the Company having fixed matching contributions of 100% of each participant's elective deferrals up to 3% of compensation plus an additional 50% of elective deferrals that exceed 3% of eligible compensation up to 5%. The Company may also make discretionary nonelective contributions to participants that completed 1,000 hours of service. However, no such discretionary non-elective contributions were made in 2024.

#### Investment options

Participants direct the investment of their contributions into various investment options offered by the Plan. Participants may invest in various funds, each with different risk exposure and return potential. The Plan currently offers various mutual funds, variable annuities, and a guaranteed interest account invested in the general asset account of Empower Annuity Insurance Company of America.

#### Participant accounts

Each participant's account is credited with the participant's contributions, Safe Harbor matching contributions, Company discretionary non-elective contributions, and allocations of Plan earnings and losses thereon. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are immediately vested in their contributions, Safe Harbor matching contributions, and actual earnings thereon. Vesting in Company discretionary non-elective contributions and earnings thereon is in accordance with the following schedule:

Participants are immediately vested upon termination of the Plan, upon reaching the normal retirement age of 65, or upon disability or death while an employee of the Company.

#### Forfeitures

The Plan allows the Company to use forfeitures to pay administrative expenses, restore forfeited account balances of rehires eligible for a restoration of forfeitures, or to reduce Company contributions. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$0 and \$1,284, respectively. During the year ended December 31, 2024, forfeitures amounting to approximately \$1,300 were used to reduce Company Safe Harbor matching contributions.

#### Payment of benefits

A participant, or their beneficiary, as applicable, is entitled to receive a lump-sum amount equal to the vested value of his or her account upon attainment of age 59½, termination of service, retirement, disability, or death. Participants or their beneficiaries also have the option to have their account balance paid in a series of installment payments. A participant may request a withdrawal from eligible account balances, as defined by the Plan document, while still under the employment of the Company for reasons of financial hardship.

If the participant's vested account balance exceeds \$5,000, a participant may elect to receive a lump sum distribution or to remain in the Plan. If the vested account balance is less than or equal to \$5,000 but greater than \$1,000, the plan administrator will distribute the participants entire vested account balance, as a direct rollover to an individual retirement account or another employer's tax qualified plan. If the vested account balance is less than or equal to \$1,000 the plan administrator will distribute the participants entire vested account balance, as a lump sum distribution.

#### Notes receivable from participants

The plan does not allow participant notes.

#### Administrative expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. The Company reserves the right to elect to pay, or have the Plan pay, administrative costs in the future. Investment related expenses are included in net appreciation of fair value of investments.

### Note 2 - Summary of significant accounting policies:

#### Basis of accounting

The financial statements of the Plan are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

#### Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Board of Trustee's determines the Plan's valuation policies utilizing information provided by their investment advisors, custodian, and trustee.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### Guaranteed interest account

The guaranteed interest account, at the fund level, is composed primarily of fully benefit-responsive investment contracts held by Empower Annuity Insurance Company of America and Empower Trust Company, LLC (collectively, Empower). These contracts are not considered fully benefit-responsive to the Plan as the underlying contracts are not direct investments between the Plan and the issuer. These contracts consist of guaranteed interest investments that invest only in fixed investments, as defined in the contracts. The guaranteed interest account is included in the financial statements at fair value. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at fair value.

#### Payment of benefits

Benefits are recorded when paid.

#### Use of estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate risk, market risk, and credit risk. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the accompanying statements of net assets available for benefits.

#### Recent legislative developments

The SECURE 2.0 Act of 2022 was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, becoming effective in 2023 and beyond. Plan management adopted mandatory provisions effective for the years ended December 31, 2024 and 2023. Plan management continues to evaluate the impact of the optional provisions of SECURE 2.0 and is awaiting additional regulatory guidance from the Internal Revenue Service (IRS) and Department of Labor. The application of SECURE 2.0 Act did not have a material effect on the Plan's financial statements for the plan years ended December 31, 2024 and 2023.

#### Subsequent events

The Plan has evaluated subsequent events through October 14, 2025, which is the date these financial statements were available to be issued. All subsequent events, if any, requiring recognition as of December 31, 2024, have been incorporated into these financial statements.

#### Note 3 - Investments and information certified by Empower:

Empower is the trustee of the Plan and holds the Plan's investment assets and executes investment transactions. Management has determined that Empower is a qualified institution and the information prepared and certified by Empower meets the requirements of ERISA Section 103(a)(3)(C). Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividend income for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Empower.

#### Note 4 - Fair value measurements:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification No. 820 are described as follows:

Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2      Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets and liabilities measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- Mutual funds (or shares of registered investment companies) are valued by the Plan at year-end by obtaining quoted prices on nationally recognized securities exchanges and are classified within Level 1 of the valuation hierarchy.
- Interest-bearing cash is stated at cost, which approximates fair value due to the short term nature of the investment, and is classified within Level 1 of the valuation hierarchy.
- Variable annuities are valued at the net asset value (NAV) provided by the custodian as a practical expedient to estimate fair value. The NAV is based on the quoted market prices of the underlying investments held in the variable annuities at year end.
- The guaranteed interest account is invested in the general asset accounts of Empower and fair value is based upon information reported by Empower by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the creditworthiness of the issuer. The items on which payments are based, such as the credited rate, account balance, and formulas included in the contract, are based on observable inputs. This investment is not fully benefit-responsive. In determining the reasonableness of the methodology used to value the investment, the Company evaluates a variety of factors, including reviewing existing contracts, economic conditions, industry and market developments, and overall credit ratings. This account is classified within Level 2 of the valuation hierarchy.

The methodologies described above may produce fair value calculations that may not be indicative of net realizable values or reflective of future fair values. Furthermore, while the Plan believes its valuation methodologies are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair values of certain financial instruments could result in different fair value measurements at the reporting dates.

Note 5 - Related-party transactions:

The Plan invests in certain investments managed by Empower. Transactions in such investments qualify as party-in-interest transactions and are exempt from the prohibited transaction rules. Fees incurred by the Plan for the investment management services are included in net appreciation of fair value of investments.

The Plan's administrative expenses are paid in part by the Plan and in part by the Company, as provided by the Plan document. In addition, certain administrative functions are performed by employees of the Company. No such employee receives compensation from the Plan.

Note 6 - Plan termination:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 7 - Tax status:

The underlying non-standardized pre-approved profit sharing plan has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020 stating that the form of the Plan is qualified under Section 401(a) of the Internal Revenue Code (IRC) and; therefore, the related trust is tax-exempt. The Plan Administrator has determined that it is eligible to and has chosen to rely on the current IRS pre-approved plan opinion letter. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan Administrator believes the Plan is being operated in compliance with the applicable requirements of the IRC and; therefore, believes that the Plan is qualified and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
