## **Independent Auditors' Report**

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the accompanying financial statements of Mast-Jagermeister US, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. **Note 1      Plan Description**

The following brief description of the Mast-Jagermeister US, Inc. 401(k) Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan document or the Summary of Plan Description for a more complete description of the Plan's provisions.

**General**

The Mast-Jagermeister US, Inc. 401(k) Plan is a participant-directed, defined contribution 401(k) plan that was created effective January 1, 1994, which covers all eligible employees (as defined by the Plan) of Mast-Jagermeister US, Inc. (the "Company" or "Sponsor"). All employees who are at least twenty-one years of age and are not subject to a collective bargaining agreement, are eligible to participate. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended. The Plan's Trustees and Administrator are responsible for oversight of the Plan, determines the appropriateness of the Plan's investment offerings, and monitors investment performance.

Effective September 2023, the Plan was amended to include eligible Tap Machine, Inc. employees as participants in the Plan.

**Plan Contributions**

Participants may contribute up to 100% of pretax annual compensation as defined in the Plan and subject to certain limitations under the Internal Revenue Code ("IRC"). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified, defined contribution plans. Participants direct the investment of their contributions into various options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. The Plan currently offers various mutual funds, a guaranteed investment contract, and self-directed brokerage accounts as investment options for participants. This makes matching contributions equal to 100% of the first 3% of eligible compensation that a participant contributes to the Plan; plus 50% of participant contributions that exceed 3% of eligible compensation, up to a maximum of 5% of eligible compensation.

In a prior year, the Plan was amended to allow participants to elect to have a portion of their annual compensation contributed to the Plan on an after-tax basis pursuant to Code Section 401(k).

**Participant Accounts**

Each participant's account is credited with the participant's contribution, allocations of Company contributions, and a share of Plan earnings. The participant's account is also charged with an allocation of certain expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are immediately vested in their contributions and employer matching contributions and the earnings thereon.

**Participant Loans Receivable**

Participants may borrow from their account up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Loan terms range from one to five years or as deemed reasonable, by the administrator, for loans taken to purchase a primary residence. Notes are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates at the time the loan is approved. At December 31, 2024, interest rates on the outstanding loans ranged from 4.25% - 9.50%. Principal and interest are paid ratably, generally through payroll deductions. Processing fees are charged against participant accounts.

**Payment of Benefits**

On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

**Hardship Benefits**

The Plan allows for "hardship withdrawals" of employee benefits from participant's pre-tax elective deferral and ROTH elective deferral accounts based the provisions of the Plan document.

**Forfeitures**

During the year ended December 31, 2024, a return of \$3,696 in excess employer match contributions based upon the 402g limits was forfeited to the Plan. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$4,352 and \$201, respectively. These accounts will be available to reduce future employer matching contributions.

**Note 2      Summary of Significant Accounting Policies**

**Basis of Presentation**

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management of the Plan to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value and contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's trustees determine the Plan's valuation policies by utilizing information provided by the investment advisers and custodians.

Contract value is the relevant measurement attributed for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. See Note 5.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

**Participants Loans Receivable**

Loans receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

**Payment of Benefits**

Benefit payments to participants are recorded when paid.

**Expenses**

Expenses related to the administration of the Plan are primarily paid by the Company. Investment related expenses, other than those paid directly by the Plan, are integrated with investment performance.

**Subsequent Events**

Management has evaluated subsequent events and transactions for potential recognition or disclosure through the date of the auditors' report, which is the date the financial statements were available to be issued.

**Note 3      Certified Investments**

The information related to the investments (see Note 4), the guaranteed investment contract (see Note 5), and loans receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and loans receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Fidelity Management Trust Company (the trustee and custodian of the Plan).

**Note 4      Fair Value Measurements**

Generally accepted accounting principles in the United States ("U.S. GAAP") establish a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

At December 31, 2024 and 2023, the Plan only held Level 1 investments, as described below:

**Level 1**

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Mutual Funds and Money Market Mutual Funds**

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Self-Directed Brokerage Accounts**

Self-directed brokerage accounts include mutual funds and exchange-traded securities such as common and preferred stock, which are valued at the closing price reported on the active market on which the individual securities are traded. The accounts may also hold money market funds and cash balances. Money market funds are reported at fair value based on the closing price reported by the fund sponsor from an actively traded exchange. Cash balances are carried at cost, which approximates fair value, and are not included in the fair value hierarchy disclosure.

**Note 5 Investment Contract with Insurance Company**

The Plan has a fully benefit-responsive guaranteed investment contract with Principal Life Insurance Company ("Principal"). Principal maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract is reported in the accompanying financial statements at contract value as provided by Principal.

Contract value represents contributions made under the contract, plus credited earnings, less participant withdrawals and administrative expenses. Because the contract is fully benefit-responsive, contract value is the relevant measurement attribute for the portion of net assets available for benefits attributable to the contract. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The issuer is contractually obligated to repay principal and a specified rate of interest to the Plan. The crediting interest rate is determined under a formula established with the issuer and is reviewed quarterly for potential reset. The crediting interest rate was 2.90% and 2.75% at December 31, 2024 and 2023, respectively. As of year-end, there were no reserves against contract value for credit risk of the issuer or otherwise.

Certain events may limit the Plan's ability to transact with the issuer at contract value. Such events include:

- 1) Amendments to the Plan documents (including complete or partial Plan termination or merger with another plan);
- 2) Changes to the Plan's prohibition on competing investment options or the removal of equity-wash provisions;
- 3) Bankruptcy of the Plan sponsor or other sponsor events (such as divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan; and
- 4) Loss of the trust's tax-exempt status or the failure to maintain a required prohibited-transaction exemption under ERISA.

**Note 6 Party-in-Interest and Related Party Transactions**

Plan investments are held in units managed by Fidelity Management Trust Company ("FMTC") under a custodial agreement. Accordingly, these transactions qualify as party-in-interest transactions. Fees paid to FMTC by the Plan for administrative services amounted to \$13,914 for the year ended December 31, 2024. The Plan also engaged Strategic Advisors, Inc., for advisory services. As a result, these transactions likewise qualify as party-in-interest transactions. Fees paid by the Plan for investment advisory services totaled \$14,471 for the year ended December 31, 2024.

**Note 7 Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination or partial termination, participants will become fully vested, and net assets will be distributed to participants and beneficiaries in proportion to their respective account balances.

**Note 8 Tax Status**

The IRS has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Under U.S. GAAP, Plan management must evaluate the tax positions taken by the Plan and record a liability for any position that is unlikely to be sustained if examined by the taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan remains subject to examination by taxing authorities for up to three years from the filing date of each respective return.

**Note 9 Risks and Uncertainties**

Plan invests in various investment securities that are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Plan Benefits and participant account balances.

The Plan's exposure to a concentration of credit risk is limited by the diversification of investments across a variety of participant-directed fund elections. Additionally, the investments within each participant-directed fund election are further diversified into varied financial instruments.

At December 31, 2024, three investment options accounted for more than 10% of the Plan's total net assets:
