## Independent Auditors' Report

To the Plan Participants and Plan Administrator  
Duane Morris Employee Incentive Savings 401(k) Plan:

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of Duane Morris Employee Incentive Savings 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. ### (1) Description of the Plan

The following description of the Duane Morris Employee Incentive Savings 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

#### (a) General

The Plan is a defined contribution plan established as a savings plan for nonlegal employees and partners of Duane Morris LLP (the Partnership), and for employees of subsidiary and affiliate companies of the Partnership that have adopted the Plan.

#### (b) Eligibility

Full-time individuals are eligible to begin participating in the Plan as of the first of the month following their date of hire or promotion to partner. Part-time individuals are eligible to begin participating in the Plan as of the first of the month following their date of hire if they are regularly scheduled to work a minimum of 20 hours per week.

#### (c) Contributions

Participants may contribute up to the lesser of 50% of their compensation or \$23,000 for 2024. Participants who have attained age 50 by December 31, 2024 may contribute up to \$30,500 for 2024 if they have elected to make a catch-up contribution. Participants may elect to contribute on a pretax and/or after-tax (Roth) basis.

The Partnership may elect to make an employer discretionary profit sharing contribution in addition to the Salary Deferral Contribution and employer matching contributions made for any plan year. The Partnership, in its sole discretion, shall determine the amount of the employer contribution for any plan year. Additional employer contributions of \$240,975 and \$279,932 were made in 2024 and 2023, respectively.

#### (d) Rollovers

The Plan will accept rollover contributions from eligible tax-qualified retirement plans on behalf of any active participant.

#### (e) Transfers

Transfers to the Plan are principally from newly promoted partners transferring their investment funds from the Duane Morris Associates' 401(k) Plan. In 2024, these transfers totaled \$1,941,549.

#### (f) Vesting

Participants are immediately 100% vested in both their own and employer contributions to the Plan.

#### (g) Distributions to Participants

The Plan provides for single-sum distributions of amounts due to participants or their beneficiaries upon their death, disability, retirement, or separation from the Partnership.

### **(h) Administration of the Plan**

The Plan is administered by the Pension Committee of the Partnership, which is designated as the plan administrator for purposes of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Partnership pays substantially all administrative expenses of the Plan. All record-keeping expenses are paid by the Plan.

### **(i) Notes Receivable from Participants**

Participants may borrow from their fund accounts up to a maximum amount of the lesser of 50% of their vested account balance or \$50,000 and a minimum of \$500. Loans must be repaid within five years except for a purchase of a primary residence, which may be repaid within 15 years. A fixed rate of interest of prime plus 1% (ranging from 4.25% to 8.75% for loans outstanding at December 31, 2024) is established at the time of the loan and interest payments are credited to the participant's account when received. Principal and interest are paid ratably through semi-monthly or monthly payroll deductions. Participant loans are valued at amortized cost, which approximates fair value.

## **(2) Summary of Significant Accounting Policies**

### **(a) Basis of Accounting**

The accompanying financial statements have been prepared using the accrual basis of accounting.

### **(b) Valuation of Investments**

The Plan's investments are stated at fair value. Refer to note 8 for additional information on the Plan's fair value measurement policy.

Security transactions are accounted for on the date securities are purchased or sold (trade date). Dividend income is recorded on the ex-dividend date. Interest income is recognized when earned. Appreciation and depreciation in the fair value of investments are recorded based upon the ending fair market value of securities.

### **(c) Contributions**

Employee contributions are recorded in the period during which the Partnership makes payroll deductions from the plan participants' earnings.

### **(d) Distributions to Participants**

Distributions are recorded when paid. There were no pending distributions to plan participants as of December 31, 2024 and 2023.

### **(e) Use of Estimates**

The preparation of financial statements requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

## **(3) Federal Income Taxes**

The Partnership has requested and received an updated determination letter, dated September 27, 2013, from the Internal Revenue Service (IRS). The plan administrator and the Plan's tax counsel believe that the

Plan currently is designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan continues to qualify under Section 401(a) and the related trust continues to be tax-exempt as of December 31, 2024 and 2023. Therefore, no provision for income taxes is included in the Plan's financial statements.

U.S. generally accepted accounting principles (U.S. GAAP) requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The IRS has the ability to examine the Plan's tax return filings for all open tax years, which is generally the three prior years.

#### **(4) Related-Party Transactions**

During 2024 and 2023, certain plan investments were shares of mutual funds managed by the Charles Schwab Trust Bank. The Charles Schwab Trust Bank is the trustee and custodian as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for administrative expenses of the Plan amounted to \$42,177 during 2024.

#### **(5) Plan Termination**

Although it has not expressed any intent to do so, the Partnership has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants remain fully vested in their accounts and distributions occur pursuant to the Plan.

#### **(6) Certified Information**

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The assets of the Plan are held by the trustee and custodian. The trustee and custodian has certified that the following data included in the accompanying financial statements and supplemental schedules are complete and accurate:

- (a) Investments and notes receivable from participants, as shown in the statements of net assets available for benefits, as of December 31, 2024 and 2023;
- (b) Investment activity (interest, dividends, and other income, and net appreciation in the fair value of investments), as shown in the statement of changes in net assets available for benefits, for the year ended December 31, 2024;
- (c) The Schedule of Delinquent Participant Contributions, Year ended December 31, 2024, as shown on Schedule H, Line 4a; and
- (d) The Schedule of Assets (Held at End of Year), December 31, 2024, as shown on Schedule H, Line 4i

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedules.

### (7) Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances in the statement of net assets available for benefits.

Recent market conditions have resulted in an unusually high degree of volatility and increased the risks and short-term liquidity associated with certain investments held by the Plan, which could impact the value of investments after the date of these financial statements.

### (8) Fair Value Measurements

The Financial Accounting Standards Board (FASB) Accounting Standard Codification (ASC) Topic 820, *Fair Value Measurement* (ASC 820), defines fair value, establishes a framework for measuring fair value in U.S. GAAP, and enhances disclosures about fair value measurements. ASC 820 applies when other accounting pronouncements require fair value measurements, but does not require new fair value measurements. ASC 820 establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of fair value hierarchy are further described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include the following:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Shares of mutual funds are valued at the quoted net asset value of shares held by the Plan at year end.

The investments in the collective investment trust are securities traded on an exchange or in the over-the-counter market and are valued at the net asset value for a given day, or if a sale is not reported for that day, at the mean between the most recent quoted bid and asked prices.

The Plan has \$33,116,742 and \$33,586,675 of investments in a collective investment trust, which are reported at fair value and categorized as Level 2 in the tables above for 2024 and 2023, respectively. The Plan has concluded that the net asset value reported by the underlying fund approximates the fair value of the investment. These investments are redeemable with the fund at net asset value under the original terms of the partnership agreements and/or subscription agreements and operations of the underlying funds. However, it is possible that these redemption rights may be restricted or eliminated by the funds in the future in accordance with the underlying fund agreements. Due to the nature of the investments held by the funds, changes in market conditions and the economic environment may significantly impact the net asset value of the fund and, consequently, the fair value of the Plan's interest in the funds. Furthermore, changes to the liquidity provisions of the fund may significantly impact the fair value of the Plan's interest in the fund.

**(9) Prohibited Party-in-Interest Transactions**

During 2024, participants' contributions totaling \$250,709 were withheld from the participants' pay, but were not remitted to the Plan's trust within the time frame required by the Department of Labor under the plan asset rules. These late remittances constituted a \$250,709 loan from the Plan to the Plan Sponsor for the periods such plan assets would have been otherwise remitted through the dates such plan assets were remitted during 2024. The Plan is taking corrective action to correct these instances of late remittances.
