Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Note 1 Description of the Plan

The following brief description of TRM Labs 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering eligible employees of TRM Labs, Inc. (the “Company”) who are age twenty-one or older with no minimum service requirement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

Contributions

Subject to annual limitations established by the Internal Revenue Code (“IRC”) each year, participants may contribute up to 90% of their eligible compensation on a pre-tax basis or up to 50% of their eligible compensation on an after-tax (Roth) basis. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan includes an auto-enrollment provision whereby all newly eligible employees are enrolled in the Plan, unless they affirmatively elect not to participate. Automatically enrolled participants’ initial deferral rate is set at 10% of eligible compensation. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

The Company may make discretionary matching contributions. The Company may also make additional non-elective contributions at its sole discretion. The Company did not make any discretionary matching contributions or non-elective contributions during the year ended December 31, 2024.

Participant Accounts

Each participant’s account is credited with the participant’s contribution, employer contributions, if any, and an allocation of Plan earnings. Participant accounts are charged with direct expenses and an allocation of Plan expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Payment of Benefits

On termination of service due to retirement, termination of employment, or termination of service due to death, a participant may elect to receive a lump-sum amount equal to the participant’s vested interest in their account. Hardship withdrawals are permitted by the Plan. Partial or installment distributions are only permitted to satisfy requirement minimum distribution rules.

Note 1 Description of the Plan (continued)

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum amount equal of the lessor of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at a rate to be fixed by the plan administrator (rates similar to those of commercial lenders). Principal and interest would be paid ratably through payroll deductions. There were no loans issued or outstanding for each of the years presented.

Vesting

Participants are immediately vested in their elective deferral contributions, employer matching contributions, non-elective contributions, and rollover accounts plus actual earnings thereon.

Forfeited Accounts

Forfeited non-vested account balances may be applied to reduce future employer contributions or may be used to pay administrative expenses. As of December 31, 2024 there were no forfeited non-vested accounts.

Note 2 Summary of Significant Accounting Policies

Basis of Presentation

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates

The preparation of financial statements in conformity with GAAP requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Payments of Benefits

Benefits are recorded when paid.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Note 2 Summary of Significant Accounting Policies (continued)

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as benefit payments, reducing the participant notes receivable balance, based upon the provisions of the Plan Document.

Expenses

The Plan allows certain administrative expenses to be paid from Plan assets, unless otherwise paid by the Company. Expenses paid by the Company are excluded from these financial statements. Fees related to administration of participant accounts are charged directly to the respective accounts and are included in administrative expenses. Certain investment-related expenses are included in net appreciation in fair value of investments.

Note 3 Fair Value Measurement

The Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) Topic 820, *Fair Value Measurement*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC Topic 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Note 3 Fair Value Measurement (continued)

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. There have been no changes in the methodologies used at December 31, 2024 and 2023.

The following is a description of the valuation methodology used for assets measured at fair value:

Mutual funds and money market funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 4 Information Certified by the Plan’s Custodian

Plan management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s (“DOL”) Rules and Regulations for Reporting and Disclosure under ERISA. Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024, and net appreciation in fair value of investments and interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by the custodian, Matrix Trust Company.

Note 5 Plan Termination

Although it has not expressed any intent to do so, the Plan sponsor has the right to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their account balance. The net assets of the Plan will be allocated as prescribed by ERISA and regulations pursuant thereto.

Note 6 Tax Status

The Plan is an adoption of the Non-Standardized Pre-Approved Profit-Sharing Plan with CODA (cash or deferred arrangements) sponsored by CCH Incorporated DBA FTWilliam.com. The Internal Revenue Service has issued an opinion letter dated June 30, 2020, that stated that the form of the pre-approved plan was designed in accordance with the applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified, and the related trust is tax exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7 Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

Note 8 Party-In-Interest Transactions

A party-in-interest is defined under DOL regulations as any fiduciary of the Plan, any party rendering services to the Plan, the employer and certain others. As described in Note 1, fees related to the administration of participant accounts are paid from Plan assets. Therefore, payments to such service providers by the Plan qualify as party-in-interest transactions.

Matrix Trust Company is the custodian of the Plan and is therefore considered to be a party-in-interest. Human Interest, Inc., serves as recordkeeper and administrator for the Plan and is therefore considered to be a party-in-interest.

Note 9 Nonexempt Transactions

During the year ended December 31, 2023, the Plan sponsor did not timely remit a participant contribution for one pay period totaling \$2,631. It was remitted during 2023 but was considered late as the time to fund the contribution was longer than the Plan's average remittance period. Interest was calculated and funded for the restoration of lost earnings related to the late participant contribution during 2024.

Note 10 Subsequent Events

Plan management has evaluated subsequent events through October 15, 2025, the date on which the financial statements were available to be issued.
