Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2024 Financial Statements

We have performed an audit of the financial statements of Lumina Foundation for Education, Inc. Savings Investment Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Basis for Opinion on the 2024 Financial Statements

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the 2024 Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion on the 2024 financial statements.

Responsibilities of Management for the 2024 Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

NOTE 1 - DESCRIPTION OF PLAN

The following description of the Lumina Foundation for Education, Inc. Savings Investment Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General: Lumina Foundation for Education, Inc. (the Plan Sponsor or the Company) established the Plan for qualifying employees of the Company. Prior to the establishment of the Plan, qualifying employees were enrolled in the USA Group Plan. The USA Group was sold, and the Company was formed. The Plan is a defined contribution plan covering eligible employees of the Company. To be eligible, an employee must have reached age 21. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions: Under the terms of the Plan agreement, participants may contribute on a pre-tax or post-tax basis of their eligible compensation as defined by the Plan and limited to 75% of their compensation or the maximum amount established by the applicable sections of the Internal Revenue Code. Participants are also able to contribute amounts representing qualified rollovers from other qualified plans. Company contributions consist of a matching contribution, which is based on 100% of the first 6% of annual compensation contributed by the participant. Contributions are subject to certain limitations. Participants direct the investment of contributions into their individual accounts based on the various investment options offered under the Plan.

Participant Accounts: Each participant's account is credited with his or her contribution, an allocation of the Company's contribution and of Plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant contributions, earnings, or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are immediately vested in their contributions plus actual earnings thereon, and the Company's matching contributions portion of their accounts, plus actual earnings thereon.

Notes Receivable from Participants: Participants may borrow from their accounts a minimum of \$500 up to a maximum of the lesser of \$50,000, or 50% of their vested account balances, reduced by outstanding loan balances. Loans are collateralized by the participant's vested account and bear interest at a fixed rate commensurate with the prevailing market rates for such a loan, which ranged from 3.75% to 9.00% during 2024. Should the participant terminate as an employee, the balance of the outstanding loan becomes due and payable, or the participant's vested account will be used to pay the outstanding loan. Maximum maturity is five years, with home loans having a maximum maturity of 10 years.

Payment of Benefits: Upon termination of service, a participant or participant's beneficiary is entitled to receive a lump-sum amount equal to the vested value of the account. Participants with account balances transferred from the USA Group, Inc. Savings Investment Plan may also elect one of several annuity payment options as specified by the Plan. Participants may withdraw their elective deferral and rollover contributions only for financial hardships, as defined in the Plan. Prior to receiving a withdrawal for financial hardship, a participant previously must have taken all available distributions, withdrawals, and loans under all applicable plans maintained by the Plan Sponsor. The amount that may be withdrawn for financial hardship shall be limited to the lesser of: (1) the total amount of elective deferral and rollover contributions in the participant's account as of the date of the withdrawal, or (2) the amount required to meet the need created by the financial hardship and anticipated income taxes and penalties resulting from early withdrawal.

Termination of the Plan: Although the Company has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA and its related regulations. In the event of Plan termination, participants' vesting would not be impacted since they are already 100% vested in their accounts.

Administrative Expenses: The Company bears substantially all costs associated with administering the Plan, except minor expenses paid by the participants. Investment management fees are charged to the Plan as a reduction of investment return and included in the investment appreciation reported by the Plan.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States (U.S. GAAP).

Investment Valuation and Income Recognition: The Plan's investments are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Shares of mutual funds are valued at quoted market prices, which represent the net asset value (NAV) of shares held by the Plan at year end.

The net appreciation/depreciation in the fair value of investments consists of the realized gains or losses and the unrealized appreciation/depreciation on those investments. The net realized gain or loss on investments is the difference between the proceeds received and the costs of investments sold determined on an average cost basis. Unrealized appreciation/depreciation in the fair value of investments is the difference between the fair value and the costs of investments from the beginning of the year to the end of year. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Management fees and operating expenses charged to the Plan for investments in the mutual funds are deducted from income earned on a daily basis and are not reflected separately. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions, and the notes are collateralized by the participants' account balances.

Payment of Benefits: Benefits are recorded when paid.

Use of Estimates: The preparation of financial statements in conformity with U.S. GAAP requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

Risks and Uncertainties: The Plan invests in various investment securities that are exposed to several risks, such as market, liquidity, and credit risks. Due to the level of risk associated with certain investment securities and the sensitivity of certain fair value estimates to change in valuation assumptions, it is at least reasonably possible that changes in the values of investment securities will occur in the near term. The changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 3 - CERTIFIED INVESTMENTS AND NOTES RECEIVABLE FROM PARTICIPANTS

All investment information disclosed in the accompanying financial statements and supplemental schedule, including investments held and notes receivable from participants at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest, dividends and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information provided to the plan administrator and certified as complete and accurate by Fidelity Management Trust Company who is the trustee of the plan.

NOTE 4 - FAIR VALUE MEASUREMENTS

The Plan's investments are subject to the provisions of Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, which clarifies the definition of fair value for financial reporting, establishes a framework used to measure fair value, and enhances disclosure requirements for fair value measurements. In accordance with ASC 820, the Plan has categorized its financial instruments based on the priority of the valuation technique into a three level fair value hierarchy. The valuation hierarchy is based on the observability of the inputs to the valuation of the asset or liability as of the measurement date.

The three levels of the fair value hierarchy in ASC 820 are described below:

Level 1: Inputs to the valuation methodology are quoted prices (unadjusted) for identical assets or liabilities in active markets.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets, and inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the financial instrument.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement. This includes situations where there is little, if any, market activity for the asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following descriptions of the valuation methods and assumptions used by the Plan to estimate the fair values of investments apply to investments held directly by the Plan.

Mutual Funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 - INCOME TAX STATUS

The Internal Revenue Service issued a determination letter dated May 22, 2014, that stated the plan was designed in accordance with applicable requirements of the Internal Revenue Code ("IRC"). Although the Plan has since been amended, the plan administrator believes that the Plan is currently designed and operating in compliance with the applicable requirements of the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan, and management concluded that as of December 31, 2024 and 2023, there were no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by the Department of Labor (DOL) or IRS; however, there are currently no audits for tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 6 - PARTIES-IN-INTEREST

Parties-in-interest are defined under the Department of Labor ("DOL") regulations as any fiduciary of the Plan, any party rendering service to the Plan, the Employer and certain others. The Plan's payment of recordkeeping fees to Fidelity Management Trust Company qualify as party-in-interest transactions. The Company provides certain accounting, recordkeeping, and administrative services to the plan for which it received no compensation. Notes receivable from participants held by the Plan are also considered party-in-interest transactions.

NOTE 7 – SUBSEQUENT EVENTS

Plan management has evaluated subsequent events for recognition and disclosure through October 15, 2025 which is the date the financial statements were available to be issued.

The Plan was amended subsequent to the end of the year. Effective January 1, 2025, employees ages 60-63 are eligible for expanded catch up contributions up to the maximum amount allowed. Additionally, the Plan added an auto-enrollment provision effective March 1, 2025, which will enroll employees in the plan at 6% unless they opt out of the plan. The Plan was also amended to require catch up contributions to be ROTH contributions if the participant meets certain conditions. No additional matters requiring recognition or disclosure were identified.
