## NOTES TO FINANCIAL STATEMENTS

### 1. Description Of The Plan

The following description of the JCM Industries, Inc. 401(k) Profit Sharing Savings Plan (the Plan) is provided for general information purposes only. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution 401(k) plan covering substantially all employees of JCM Industries, Inc. (the Employer) who have attained 20 ½ years of age and completed one year of employment with 1,000 hours of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### Plan Merger

Effective December 31, 2024, the Plan was merged into the A.Y. McDonald Industries, Inc. 401(k) Plan (AYM Plan) pursuant to a formal agreement approved by the plan sponsors. The merger was conducted in accordance with the applicable provisions of ERISA and the Internal Revenue Code. As of December 31, 2024, the Plan recognized a transfer payable of \$1,331,527, representing the net assets to be transferred to the AYM Plan. The transfer is expected to be completed within 30 days, subject to final reconciliation and approval by the plan fiduciaries and service providers.

The transfer payable is recorded as a liability in the accompanying statement of net assets available for benefits. The amount is based on preliminary financial information provided by the Plan and may be adjusted upon settlement. The merger did not result in any changes to participant account balances or plan provisions. All participant rights and benefits under the Plan were preserved and transferred to the AYM Plan without reduction.

#### Contributions

Participants may contribute up to 50% of eligible compensation in the form of pre-tax or after-tax (ROTH) contributions not to exceed Internal Revenue Code (IRC) limits. Entry dates to the Plan are semi-annually on the first day of the first and seventh month of the plan year concluding with or following eligibility. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

Under the provisions of the Plan, the Employer has the option to make discretionary matching contributions equal to a percentage of eligible participants' elective deferral contributions. Participants are eligible for the discretionary match upon becoming eligible to make elective deferral contributions. The Employer elected to make matching contributions equal to 25% of each participant's deferral contribution limited to 6% of the participant's compensation for the year ended December 31, 2024.

Under the provisions of the Plan, the Employer has the option to make discretionary profit-sharing contributions. Participants are eligible for the discretionary profit-sharing contributions upon becoming eligible to make elective deferral contributions and by completing 1,000 hours of service during the plan year. There were no discretionary profit-sharing contributions during the year ended December 31, 2024.

### **Participant Accounts**

Each participant's account is credited with the participant's contributions and discretionary employer matching and profit-sharing contributions as well as allocations of the Plan's earnings and expenses. Allocations are based on the participant's eligible compensation, the value of account balances or specific participant transactions, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### **Notes Receivable From Participants**

Participants may borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The number of outstanding loans for any participant at any one time is limited to two. The loans are secured by the participant's vested account balance and bear interest at the prime rate plus 2.0%. Loan terms may not exceed five years, except for a loan for the purchase of a principal residence. Principal and interest are paid ratably through payroll deductions or directly by the participant.

### **Vesting**

Participants are immediately vested in their rollover and voluntary contributions, plus actual earnings thereon. Vesting of the Employer's discretionary matching and profit-sharing contributions is based on a rate of 20% for each year of credited service beginning in the second year of service. Participants are fully vested after six years of credited service or upon death, disability or attainment of normal retirement age of 65.

### **Payment Of Benefits**

Upon termination of service due to death, disability or retirement, participants with an account balance greater than \$1,000 may elect to receive either a lump-sum amount equal to the value of their account, receive installments over a period of time or leave their balance in the Plan subject to minimum distribution requirements. Participants with a vested balance of \$1,000 or less will receive a lump-sum payment upon termination.

### **In-Service Withdrawals**

Active participants who reach age 65 may withdraw all or part of their vested accounts.

### **Forfeited Accounts**

As of December 31, 2024 and 2023, forfeited accounts totaled \$0 and \$26,597, respectively. These accounts may be used to pay plan expenses or reduce employer discretionary matching and profit-sharing contributions. For the year ended December 31, 2024, no forfeitures were used and forfeitures of \$33,257 were transferred out of the plan.

## **2. Summary Of Accounting Policies**

### **Basis Of Accounting**

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

### **Use Of Estimates**

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

### **Investment Valuation And Income Recognition**

Investments are reported at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value in 2023. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's trustees determine the Plan's valuation policies utilizing information provided by the investment advisor, custodian and contract holder. See Note 4 for discussion of fair value measurements and Note 5 for discussion of contract value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

### **Notes Receivable From Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant does not make loan repayments and the plan administrator considers the loan to be in default, the loan balance is reduced and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the plan agreement.

#### **Contributions**

Contributions from plan participants and matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation. Profit-sharing contributions are recorded in the year in which they are declared by the Employer.

#### **Payment Of Benefits**

Benefit payments to participants are recorded when paid.

#### **Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

#### **Subsequent Events**

The Plan has evaluated subsequent events through October 15, 2025, the date the financial statements were available to be issued.

### **3. Certified Investments**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023 and net appreciation in fair value of investments, interest and dividends and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company, LLC and Empower Annuity Insurance Company of America (EAICA), the custodian and contract holder, respectively, of the Plan.

### **4. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

- Level 2: Inputs to the valuation methodology include:
  - Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability and
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Funds held by the Plan are open-ended funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded.

*Guaranteed Interest Account:* Valued using pricing models maximizing the use of observable inputs for similar securities.

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another.

At December 31, 2024, the Plan determined the guaranteed interest account (GIA) should be valued at fair value as opposed to contract value as had been reported as of December 31, 2023. It was determined the GIA was no longer deemed fully benefit-responsive due to the merger of the Plan into the AYM Plan effective December 31, 2024 as described in Note 1, which limits the Plan's ability to transact at contract value.

### **5. Investment Contract With Insurance Company**

The Plan's GIA utilized a group annuity contract (the contract) with the contract holder under which the contract holder maintained certain participant directed contributions in the GIA which were commingled with the general assets of the contract holder. The GIA was considered fully benefit-responsive and was reported at contract value. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. The GIA could be terminated if the total fair value of the investments or the annual contribution amounts fell below minimum levels as stated in the contract. The GIA could have also been terminated by either the Plan or the contract holder for additional reasons as defined in the contract. Certain events, such as the premature termination of the GIA by the Plan or the termination of the Plan, would have limited the Plan's ability to transact at contract value. Total participant withdrawals from the contract, made during preceding twelve months, were limited to 12% of the contract's balance in the preceding twelve months. At December 31, 2023, the plan administrator believed the occurrence of such events (which would also limit the plan's ability to transact at contract value with plan participants) was not probable.

The crediting interest rate for the contract at December 31, 2023 was 3.0%. The crediting interest rate was determined and periodically changed but could not be less than 3.0%.

### **6. Related-Party And Party-In-Interest Transactions**

Certain plan investments are shares of a GIA managed by EAICA, the contract holder as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

Notes receivable from participants given to parties-in-interest totaled \$0 and \$443,626 as of December 31, 2024 and 2023, respectively.

### **7. Plan Termination And Subsequent Event**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their accounts.

Subsequent to year end, as described in Note 1, the remaining assets of the Plan were merged into the AYM Plan and the Plan was terminated.

### **8. Tax Status**

The Employer has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated November 14, 2022 stating that the form of the pre-approved plan document was in accordance with the applicable requirements of the IRC. Although the Plan has been amended since adopting the pre-approved plan document, the plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and therefore, believes that the Plan is qualified and the related trust is tax-exempt.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Department of Labor or IRS. Management evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **9. Risks And Uncertainties**

The Plan invests in a variety of investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

### 10. Prior Period Adjustment

During 2024 and years prior, compensation used for calculating participant deferrals excluded bonus and commission wages, which are defined as eligible compensation within the plan document. As a result, contributions and net assets available for benefits were understated as of December 31, 2023. The effects of the restatement on the Plan's statement of net assets available for benefits as of December 31, 2023 are as follows:
