- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter – Supplemental Schedule Required by ERISA

the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

Notes to Financial Statements

1. Description of Plan

The following description of the Bumble Bee Foods, LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General

The Plan was established on August 1, 2003 as a defined contribution plan. The Plan covers all eligible employees of Bumble Bee Foods, LLC (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Trustee and Administration of the Plan

The Plan is administered by an employee of the Company, who is the Plan Administrator. The Retirement Plan Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance. Fidelity Management Trust Company (Trustee or Fidelity), under a trust agreement holds the assets of the Plan, including all contributions and earnings thereon.

Eligibility

The Plan covers all eligible employees of the Company. There is no age and no service requirement for eligibility.

Contributions

Participants may contribute up to 60% of their pre-tax annual compensation, as defined in the Plan. Participants may also elect to designate all or any portion of their elective deferral contributions as Roth elective contributions, as defined by the Plan. Participants may also contribute amounts representing distributions from other qualified retirement plans as well as eligible compensation on an after-tax basis. The Plan limits the amount of after-tax participant contributions to 25% of the participant's pre-tax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. All contributions are subject to annual limitations established by the Internal Revenue Service (IRS).

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate initially set at 3% of eligible compensation which automatically increases 1% each year, beginning 30 days after such employee's date of hire up until the deferral rate of 12% is reached.

The Company matches participant contributions, within prescribed limits, as determined on an annual basis. The Company match was 50% of the first 6% of compensation that a participant contributed to the Plan for the year ended December 31, 2024. The Plan allows for the Company to also make discretionary contributions. No discretionary contributions were made during the year ended December 31, 2024.

Participant Accounts

Participant accounts are credited with the participant's contribution, an allocation of the Company's contributions and plan earnings, as well as an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined. Upon enrollment in the Plan, participants may direct contributions in any of several investment options. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings or losses thereon. Vesting in the Company's contribution portion of their account plus actual earnings thereon is based on years of continuous service as follows: 33% vested after one year of service, 67% vested after two years, and 100% after three years of service.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan transactions are treated as a transfer to (from) the investment fund from (to) the notes receivable from participant's fund. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan Administrator. Loans outstanding as of December 31, 2024, bear an interest rate from 4.25% to 9.5% and have maturities through July 2030. Principal and interest is paid ratably through payroll deductions over a period of five years or less, unless used to purchase a principal residence.

Payment of Benefits

Participants are eligible to receive a lump-sum distribution of benefits upon termination of employment, death, disability, retirement, or Plan termination. Distributions may also be made for hardship withdrawals, which are authorized by the Plan Administrator and conform to the "deemed hardship" standards set forth in Treasury Regulation Section 1.401(k)(d)(2). Such hardship distributions are subject to certain limitations.

Participants may elect to rollover their vested balance to another qualified retirement plan or Individual Retirement Account (IRA).

Forfeitures

Forfeited balances of terminated participants' non-vested accounts can be used to reduce future employer matching contributions and administrative expenses of the Plan. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$61,411 and \$38,200, respectively. The Plan used \$29,357 from forfeitures to reduce employer contributions and \$587 were used to pay administrative expenses during the year ended December 31, 2024.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make certain estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and the disclosure of contingent assets and liabilities. Actual results could materially differ from those estimates.

Plan Expenses

The Plan is sponsored by the Company. Personnel within the Company perform various administrative services for the Plan. The payroll and related overhead costs associated with these services are not included as Plan expenses. Most administrative expenses of the Plan, including consulting, legal, and audit fees, are paid by the Company and are not included in these financial statements. Other record keeping and investment management expenses are paid by the Plan. Fees related to participant-initiated transactions are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value, including a common collective trust (CCT), which holds investments in fully benefit responsive investment contracts. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The CCT is valued at net asset value (NAV) per share, as determined by the Trustee at year end. The NAV is used as the practical expedient to estimate fair value. See Note 7 for discussion of fair value measurements.

Purchase and sales of securities are recorded on trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis.

The net appreciation (depreciation) in fair value of investments consists of both the realized gains or losses and unrealized appreciation and depreciation of those investments.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent notes receivable are reclassified as distributions based upon the terms of the Plan Document. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be a distribution, the participant loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid. As of December 31, 2024, and 2023, there were no benefit amounts that participants had elected to withdraw which had not been paid.

3. Certified Investment Information

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company, a qualified institution.

4. Tax Status

The Plan uses a pre-approved Plan Document sponsored by Fidelity Management & Research Company (FMR). FMR received an opinion letter from the IRS, dated June 30, 2020, which states that the pre-approved Plan Document, as then designed, satisfies the applicable provisions of the Internal Revenue Code (IRC). Although the Plan has been amended since the date of the opinion letter, Plan management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

5. Plan Termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event that the Plan is terminated, participants would become 100% vested in their accounts.

6. Related Party and Party-in-Interest Transactions

Certain Plan investments are in funds and accounts that are managed by an affiliate of Fidelity Management Trust Company. Fidelity Management Trust Company is the trustee as defined by the Plan and therefore, these transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules. Participant loan and distribution processing fees are paid to Fidelity Management Trust Company by participants. The Plan also issues loans to participants which are secured by the vested balance of the participants' accounts.

For the year ended December 31, 2024, administrative expenses of \$9,795 for loan set up fee, cancellation fee, loan maintenance fee, and overnight fee.

These transactions are party-in-interest transactions, which are exempt from prohibited transaction rules. There were no outstanding payables to Fidelity Management Trust Company as of December 31, 2024 and 2023.

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan for these services.

7. Fair Value Measurements

Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds - Mutual funds are valued at the daily quoted market prices in active markets, based on number of shares held by the Plan. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price.

CCT - CCTs are valued as a practical expedient utilizing the net asset value. The use of NAV is deemed appropriate as the CCT does not have finite lives, unfunded commitments relating to these types of investments, or significant restriction or redemptions. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not

used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. The Plan's trustee certified the net asset value of the common/collective trust fund as of December 31, 2024 and 2023. The CCT is a direct filing entity.

The preceding methods described may produce a fair value calculation which may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is responsible for maintaining a current plan instrument, including all plan amendments. Management is also responsible for administering the Plan and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Notes to Financial Statements

1. Description of Plan

The following description of the Bumble Bee Foods, LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General

The Plan was established on August 1, 2003 as a defined contribution plan. The Plan covers all eligible employees of Bumble Bee Foods, LLC (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Trustee and Administration of the Plan

The Plan is administered by an employee of the Company, who is the Plan Administrator. The Retirement Plan Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance. Fidelity Management Trust Company (Trustee or Fidelity), under a trust agreement holds the assets of the Plan, including all contributions and earnings thereon.

Eligibility

The Plan covers all eligible employees of the Company. There is no age and no service requirement for eligibility.

Contributions

Participants may contribute up to 60% of their pre-tax annual compensation, as defined in the Plan. Participants may also elect to designate all or any portion of their elective deferral contributions as Roth elective contributions, as defined by the Plan. Participants may also contribute amounts representing distributions from other qualified retirement plans as well as eligible compensation on an after-tax basis. The Plan limits the amount of after-tax participant contributions to 25% of the participant's pre-tax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. All contributions are subject to annual limitations established by the Internal Revenue Service (IRS).

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate initially set at 3% of eligible compensation which automatically increases 1% each year, beginning 30 days after such employee's date of hire up until the deferral rate of 12% is reached.

The Company matches participant contributions, within prescribed limits, as determined on an annual basis. The Company match was 50% of the first 6% of compensation that a participant contributed to the Plan for the year ended December 31, 2024. The Plan allows for the Company to also make discretionary contributions. No discretionary contributions were made during the year ended December 31, 2024.

Participant Accounts

Participant accounts are credited with the participant's contribution, an allocation of the Company's contributions and plan earnings, as well as an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined. Upon enrollment in the Plan, participants may direct contributions in any of several investment options. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings or losses thereon. Vesting in the Company's contribution portion of their account plus actual earnings thereon is based on years of continuous service as follows: 33% vested after one year of service, 67% vested after two years, and 100% after three years of service.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan transactions are treated as a transfer to (from) the investment fund from (to) the notes receivable from participant's fund. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan Administrator. Loans outstanding as of December 31, 2024, bear an interest rate from 4.25% to 9.5% and have maturities through July 2030. Principal and interest is paid ratably through payroll deductions over a period of five years or less, unless used to purchase a principal residence.

Payment of Benefits

Participants are eligible to receive a lump-sum distribution of benefits upon termination of employment, death, disability, retirement, or Plan termination. Distributions may also be made for hardship withdrawals, which are authorized by the Plan Administrator and conform to the "deemed hardship" standards set forth in Treasury Regulation Section 1.401(k)(d)(2). Such hardship distributions are subject to certain limitations.

Participants may elect to rollover their vested balance to another qualified retirement plan or Individual Retirement Account (IRA).

Forfeitures

Forfeited balances of terminated participants' non-vested accounts can be used to reduce future employer matching contributions and administrative expenses of the Plan. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$61,411 and \$38,200, respectively. The Plan used \$29,357 from forfeitures to reduce employer contributions and \$587 were used to pay administrative expenses during the year ended December 31, 2024.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make certain estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and the disclosure of contingent assets and liabilities. Actual results could materially differ from those estimates.

Plan Expenses

The Plan is sponsored by the Company. Personnel within the Company perform various administrative services for the Plan. The payroll and related overhead costs associated with these services are not included as Plan expenses. Most administrative expenses of the Plan, including consulting, legal, and audit fees, are paid by the Company and are not included in these financial statements. Other record keeping and investment management expenses are paid by the Plan. Fees related to participant-initiated transactions are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value, including a common collective trust (CCT), which holds investments in fully benefit responsive investment contracts. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The CCT is valued at net asset value (NAV) per share, as determined by the Trustee at year end. The NAV is used as the practical expedient to estimate fair value. See Note 7 for discussion of fair value measurements.

Purchase and sales of securities are recorded on trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis.

The net appreciation (depreciation) in fair value of investments consists of both the realized gains or losses and unrealized appreciation and depreciation of those investments.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent notes receivable are reclassified as distributions based upon the terms of the Plan Document. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be a distribution, the participant loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid. As of December 31, 2024, and 2023, there were no benefit amounts that participants had elected to withdraw which had not been paid.

3. Certified Investment Information

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company, a qualified institution.

4. Tax Status

The Plan uses a pre-approved Plan Document sponsored by Fidelity Management & Research Company (FMR). FMR received an opinion letter from the IRS, dated June 30, 2020, which states that the pre-approved Plan Document, as then designed, satisfies the applicable provisions of the Internal Revenue Code (IRC). Although the Plan has been amended since the date of the opinion letter, Plan management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

5. Plan Termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event that the Plan is terminated, participants would become 100% vested in their accounts.

6. Related Party and Party-in-Interest Transactions

Certain Plan investments are in funds and accounts that are managed by an affiliate of Fidelity Management Trust Company. Fidelity Management Trust Company is the trustee as defined by the Plan and therefore, these transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules. Participant loan and distribution processing fees are paid to Fidelity Management Trust Company by participants. The Plan also issues loans to participants which are secured by the vested balance of the participants' accounts.

For the year ended December 31, 2024, administrative expenses of \$9,795 for loan set up fee, cancellation fee, loan maintenance fee, and overnight fee.

These transactions are party-in-interest transactions, which are exempt from prohibited transaction rules. There were no outstanding payables to Fidelity Management Trust Company as of December 31, 2024 and 2023.

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan for these services.

7. Fair Value Measurements

Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds - Mutual funds are valued at the daily quoted market prices in active markets, based on number of shares held by the Plan. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price.

CCT - CCTs are valued as a practical expedient utilizing the net asset value. The use of NAV is deemed appropriate as the CCT does not have finite lives, unfunded commitments relating to these types of investments, or significant restriction or redemptions. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not

used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. The Plan's trustee certified the net asset value of the common/collective trust fund as of December 31, 2024 and 2023. The CCT is a direct filing entity.

The preceding methods described may produce a fair value calculation which may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
