Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2024 Financial Statements



1. Description of Plan

The following description of the True North Medical Group LLC 401(k) Profit Sharing Plan & Trust (the "Plan"), provides only general information. Participants should refer to the Plan documents for a more complete description of the Plan's provisions.

General – The Plan is a defined contribution plan covering substantially all full-time employees of True North Medical Group LLC and certain related employers that have adopted the Plan (the "Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Eligibility – Employees of the Company are eligible to participate in the Plan immediately upon their employment commencement date and attaining 21 years of age.

Contributions – Participants can elect to defer up to 92% of eligible compensation, subject to applicable Internal Revenue Service ("IRS") limitations. A participant's compensation, for federal tax purposes, shall be reduced by the amount of the elected pre-tax deferral contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make additional catch-up contributions to the Plan subject to statutory limitations. A participant may designate all or a portion of their 401(k) elective deferral contributions, including catch ups, as Roth 401(k) contributions. Participants may also contribute eligible distributions from other qualified defined benefit or defined contribution plans (rollover). The Plan includes an auto-enrollment provision under which newly eligible employees are automatically enrolled at a 3% deferral rate, with annual 1% increases up to a maximum of 6%. Contributions are initially invested in a designated balanced fund that may be changed by the participant. Employees can elect not to participate in the Plan.

The Company provides safe harbor contributions in accordance with the applicable provisions of the Internal Revenue Code ("IRC"). Under this provision, the Company makes a nonelective contribution equal to at least 3% of eligible compensation for all eligible employees, regardless of whether the employee elects to make salary deferral contributions.

The Company may also make discretionary profit sharing or qualified nonelective contributions ("QNECs"), determined annually. These contributions, if made, are allocated to participants' accounts on a pro rata basis according to each participant's eligible compensation for the Plan year. Eligibility for a profit sharing contribution is limited to participants employed on the last day of the Plan year. QNECs, if made, are limited to non-highly compensated employees with no service or employment conditions. For the year ended December 31, 2024, the Company did not make any discretionary profit sharing or qualified nonelective contributions.

Participant Accounts – Each participant's account is credited with the participant's contributions and Company discretionary contributions, as well as Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan and Plan losses. Allocations are based on participant earnings, account balances, or specific transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting – Participants are 100% vested immediately in all contributions, including those made by the Company, rollover contributions, plus actual earnings thereon.

Investment Options – Upon enrollment in the Plan, a participant may direct their contributions to any of the Plan’s investment options. Participants may change their investment options at any time.

Notes Receivable from Participants – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participants may not have more than one loan outstanding at one time. Loan terms range from one to five years or up to 30 years for the purchase of a primary residence. The loans are secured by the vested balance in the participant’s account and bear a reasonable rate of interest based on the prime interest rate plus 1%. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits – The payment of benefits under this Plan begins as soon as administratively feasible. Distributions are allowed in the event of termination of employment, disability, death, or retirement. Also, in-service distributions are allowed in the event of financial hardship or upon attainment of age 59-1/2, and only from fully vested accounts.

Participants must consent to any distribution from their account before they reach normal retirement age if their account balance exceeds \$5,000. Account balances of \$5,000 or less, including rollover contributions, are subject to automatic distribution in accordance with the Plan’s cash-out provisions. If the account balance is \$1,000 or less, a mandatory single lump-sum distribution is paid directly to the participant in cash. If the account balance exceeds \$1,000 but is \$5,000 or less, the amount is automatically rolled over to an individual retirement account established for the participant.

2. Summary of Significant Accounting Policies

Basis of Accounting – The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates – The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition – The Plan’s investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). Plan management determines the Plan’s valuation policies utilizing information provided by the investment advisor, trustee, and custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivable from participants are treated as distributions based upon the terms of the Plan document.

Payment of Benefits – Benefits are recorded when paid.

Expenses – Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Expenses directly associated with the administration of a participant's account may be charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

3. Information Prepared and Certified by the Trustee and Custodian

Certain information in the accompanying financial statements and ERISA-required supplemental schedule related to investments held as of December 31, 2024, and net appreciation (depreciation) in fair value of investments, and interest and dividends for the year then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by Mid Atlantic Trust Company, a qualified institution.

Notes receivable from participants as of December 31, 2024 and related interest income on notes receivable from participants for the year then ended are not certified.

4. Fair Value Measurements

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability (exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants at the measurement date.

The following fair value hierarchy classifies the inputs to valuation techniques used to measure fair value into one of three levels:

Level 1: unadjusted quoted prices in active markets for identical assets or liabilities;

Level 2: inputs other than quoted prices that are observable for the asset or liability, either directly or indirectly. These include quoted prices for similar assets or liabilities in active markets and quoted prices for identical or similar assets or liabilities in inactive markets;

Level 3: unobservable inputs that reflect the reporting entity's own assumptions.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual and money market funds: Valued at the daily closing price as reported by the fund. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual and money market funds held by the Plan are deemed to be actively traded.

5. Related-Party Transactions and Party in Interest Transactions

Certain administrative fees paid to the custodian and other service providers, as well as participant loans, are considered party-in-interest transactions under ERISA. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

6. Plan Termination

Although it has not expressed intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

7. Tax Status

The Company has adopted a pre-approved plan document that has received an opinion letter from the IRS dated August 31, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the determination letter, however, the plan administrator and the Plan's tax counsel believe that the Plan was designed and was being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2024 Financial Statements



1. Description of Plan

The following description of the True North Medical Group LLC 401(k) Profit Sharing Plan & Trust (the "Plan"), provides only general information. Participants should refer to the Plan documents for a more complete description of the Plan's provisions.

General – The Plan is a defined contribution plan covering substantially all full-time employees of True North Medical Group LLC and certain related employers that have adopted the Plan (the "Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Eligibility – Employees of the Company are eligible to participate in the Plan immediately upon their employment commencement date and attaining 21 years of age.

Contributions – Participants can elect to defer up to 92% of eligible compensation, subject to applicable Internal Revenue Service ("IRS") limitations. A participant's compensation, for federal tax purposes, shall be reduced by the amount of the elected pre-tax deferral contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make additional catch-up contributions to the Plan subject to statutory limitations. A participant may designate all or a portion of their 401(k) elective deferral contributions, including catch ups, as Roth 401(k) contributions. Participants may also contribute eligible distributions from other qualified defined benefit or defined contribution plans (rollover). The Plan includes an auto-enrollment provision under which newly eligible employees are automatically enrolled at a 3% deferral rate, with annual 1% increases up to a maximum of 6%. Contributions are initially invested in a designated balanced fund that may be changed by the participant. Employees can elect not to participate in the Plan.

The Company provides safe harbor contributions in accordance with the applicable provisions of the Internal Revenue Code ("IRC"). Under this provision, the Company makes a nonelective contribution equal to at least 3% of eligible compensation for all eligible employees, regardless of whether the employee elects to make salary deferral contributions.

The Company may also make discretionary profit sharing or qualified nonelective contributions ("QNECs"), determined annually. These contributions, if made, are allocated to participants' accounts on a pro rata basis according to each participant's eligible compensation for the Plan year. Eligibility for a profit sharing contribution is limited to participants employed on the last day of the Plan year. QNECs, if made, are limited to non-highly compensated employees with no service or employment conditions. For the year ended December 31, 2024, the Company did not make any discretionary profit sharing or qualified nonelective contributions.

Participant Accounts – Each participant's account is credited with the participant's contributions and Company discretionary contributions, as well as Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan and Plan losses. Allocations are based on participant earnings, account balances, or specific transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting – Participants are 100% vested immediately in all contributions, including those made by the Company, rollover contributions, plus actual earnings thereon.

Investment Options – Upon enrollment in the Plan, a participant may direct their contributions to any of the Plan’s investment options. Participants may change their investment options at any time.

Notes Receivable from Participants – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participants may not have more than one loan outstanding at one time. Loan terms range from one to five years or up to 30 years for the purchase of a primary residence. The loans are secured by the vested balance in the participant’s account and bear a reasonable rate of interest based on the prime interest rate plus 1%. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits – The payment of benefits under this Plan begins as soon as administratively feasible. Distributions are allowed in the event of termination of employment, disability, death, or retirement. Also, in-service distributions are allowed in the event of financial hardship or upon attainment of age 59-1/2, and only from fully vested accounts.

Participants must consent to any distribution from their account before they reach normal retirement age if their account balance exceeds \$5,000. Account balances of \$5,000 or less, including rollover contributions, are subject to automatic distribution in accordance with the Plan’s cash-out provisions. If the account balance is \$1,000 or less, a mandatory single lump-sum distribution is paid directly to the participant in cash. If the account balance exceeds \$1,000 but is \$5,000 or less, the amount is automatically rolled over to an individual retirement account established for the participant.

2. Summary of Significant Accounting Policies

Basis of Accounting – The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates – The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition – The Plan’s investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). Plan management determines the Plan’s valuation policies utilizing information provided by the investment advisor, trustee, and custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivable from participants are treated as distributions based upon the terms of the Plan document.

Payment of Benefits – Benefits are recorded when paid.

Expenses – Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Expenses directly associated with the administration of a participant's account may be charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

3. Information Prepared and Certified by the Trustee and Custodian

Certain information in the accompanying financial statements and ERISA-required supplemental schedule related to investments held as of December 31, 2024, and net appreciation (depreciation) in fair value of investments, and interest and dividends for the year then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by Mid Atlantic Trust Company, a qualified institution.

Notes receivable from participants as of December 31, 2024 and related interest income on notes receivable from participants for the year then ended are not certified.

4. Fair Value Measurements

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability (exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants at the measurement date.

The following fair value hierarchy classifies the inputs to valuation techniques used to measure fair value into one of three levels:

Level 1: unadjusted quoted prices in active markets for identical assets or liabilities;

Level 2: inputs other than quoted prices that are observable for the asset or liability, either directly or indirectly. These include quoted prices for similar assets or liabilities in active markets and quoted prices for identical or similar assets or liabilities in inactive markets;

Level 3: unobservable inputs that reflect the reporting entity's own assumptions.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual and money market funds: Valued at the daily closing price as reported by the fund. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual and money market funds held by the Plan are deemed to be actively traded.

5. Related-Party Transactions and Party in Interest Transactions

Certain administrative fees paid to the custodian and other service providers, as well as participant loans, are considered party-in-interest transactions under ERISA. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

6. Plan Termination

Although it has not expressed intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

7. Tax Status

The Company has adopted a pre-approved plan document that has received an opinion letter from the IRS dated August 31, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the determination letter, however, the plan administrator and the Plan's tax counsel believe that the Plan was designed and was being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
