INDEPENDENT AUDITORS' REPORT

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Atria Wealth Solutions 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the 2024 Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.

Our audit did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matters

2024 Supplemental Schedules Required by ERISA

The supplemental schedules (Schedule H, Part IV, Line 4a for the year ended December 31, 2024 and Schedule H, Part IV, Line 4i as of December 31, 2024), are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

- the form and content of the supplemental schedules, other than the information in the supplemental schedules that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

The financial statements of Atria Wealth Solutions 401(k) Plan as of December 31, 2023, were audited by predecessor auditors. In accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, the prior year audit did not extend to any statements or information related to assets held for investment of the plan that were certified by a qualified institution. Their report dated October 10, 2024 indicated that in their opinion (a) the amounts and disclosures in the 2023 financial statements, other than those agreed to or derived from the certified investment information, were presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America, and (b) the information in the 2023 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C). Their report also indicated that the form and content of the 2023 supplemental schedules, other than the information in the 2023 supplemental schedules that agrees to or is derived from the certified investment information, were presented, in all material respects, in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, and the information in the 2023 supplemental schedules related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

NOTE 1. DESCRIPTION OF PLAN

The following description of the Atria Wealth Solutions 401(k) Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan, which became effective in January 1999, is a defined contribution plan covering eligible employees of Atria Wealth Solutions, Inc. and its participating employers (collectively, the "Company"). For purposes of the Plan, the Company includes employees of the following employers of a controlled and affiliated group of corporations:

CUSO Financial Services, L.P.
Sorrento Pacific Financial, LLC
Cadaret, Grant & Co., Inc.
Atria Wealth Solutions, Inc.
NEXT Financial Group, Inc.
Western International Securities, Inc.
SCF Securities, Inc.
Grove Point Financial, LLC

Employees who are (i) nonresident aliens with no U.S. source income, (ii) subject to collective bargaining agreements, or (iii) certain classes of temporary employees are not eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") and the provisions of the Internal Revenue Code ("IRC") and is maintained for the exclusive benefit of the participating employees and their beneficiaries.

On October 1, 2024, the Company was acquired by LPL Financial LLC. Although the Plan may be merged into the LPL Financial LLC employee benefit plan at a later time, there are currently no formal arrangements to do so.

Participant Contributions

Elective Contributions – The Plan allows eligible participants to make elective salary reduction contributions. Participant contributions include those made by election of the employee in an amount up to maximum amount allowed by law, as defined by the Plan, and subject to limitations imposed by the IRC. The Plan allows both traditional (pre-tax) deferral contributions and Roth (after-tax) contributions.

Participants who are age 50 or older are eligible to defer additional amounts (called "catch-up contributions") to the Plan up to the maximum allowed by the IRC. Participants may also contribute amounts representing distributions from other qualified sources.

Automatic Enrollment and Contributions – The Plan has adopted automatic enrollment features, such that all participants (except those who affirmatively elect to not participate, or who elect a specific contribution percentage) automatically have a percentage of their eligible pre-tax compensation deferred into the Plan. During 2024, the automatic deferral percentage was 3%.

At any time, participants are able to affirmatively elect deferral percentages of their choosing. Also at any time, participants may decline participation (opt out).

NOTE 1. DESCRIPTION OF PLAN (Continued)

Employer Contributions

The Plan includes provisions for discretionary employer matching contributions. For 2024, the discretionary employer matching contribution is equal to 50% of a participant's deferral contributions up to 6% of the participant's eligible compensation during the plan year.

Participant Accounts

Each participant's account is credited with the participant's contributions, any employer matching contributions, and allocations of (i) Plan earnings or losses and (ii) any administrative expenses. Allocations are based on participant contributions, earnings, or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately 100% vested in their contributions and actual earnings thereon while employer contributions vest at a rate of 20%, 40%, 70% and 100% after two, three, four, and five years of credited service, respectively. A year of credited service is defined as 1,000 hours of service during a plan year. In addition, participants become fully vested in employer contributions in the event of death, disability or eligible retirement from the Company.

Forfeitures

Forfeitures of terminated participants' accounts are held in an unallocated asset account. These amounts may be used to pay Plan administrative expenses and reduce employer contributions. During 2024, \$142,836, including \$6,941 of investment earnings, was added to the forfeitures account while deductions totaling \$324,862 were used primarily to reduce employer matching contributions. As of December 31, 2024 and 2023, the forfeitures account balance was \$118,198 and \$300,224, respectively.

Notes Receivable from Participants (Participant Loans)

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum generally equal to the lesser of \$50,000 or 50% of their vested account balance. Loans bear interest at a reasonable rate as determined by the Plan administrator at the time of application and are generally secured by the participant's vested account balance. Participants are generally permitted to have only two loans outstanding at any time. Principal and interest are paid ratably through payroll deductions over a term not to exceed five years unless the loan is used toward the acquisition of the participant's principal residence, in which case the loan term may be longer. As of December 31, 2024, the interest rates on outstanding loans ranged from 4.25% to 9.50%.

Payment of Benefits

Upon disability, death, termination, or attaining age 59½ or normal retirement age (65), participants (or, if applicable, their beneficiaries) may elect to receive a distribution of their vested account in a lump sum or annual installments over a period of years not exceeding the participant's life expectancy or the normal joint life expectancy of the participant and designated beneficiary. Account balances that do not exceed \$5,000 will be distributed to the participant's beneficiary in the form of a lump sum distribution. Participants may also withdraw all or a percentage of their vested account balances upon approval of the Plan administrator and subject to Internal Revenue Service ("IRS") hardship withdrawal rules.

Payment of Benefits (Continued)

Pursuant to the Setting Every Community Up for Retirement Enhancement Act of 2019 (the “SECURE Act”), which became law on December 20, 2019, and the SECURE 2.0 Act (Note 9), participants may defer taking distributions as follows:

- If a participant reached the age of 70½ in 2019, the participant may defer receiving distributions until the later of April 1, 2020, or the April following the calendar year in which the participant retires;
- If a participant reached the age of 70½ in 2020 or later, the participant may defer receiving distributions until the later of the April following the calendar year in which the participant reaches age 72 or retires, except that –
- Beginning in 2023, the age a participant must begin taking distributions was raised to 73. If a participant reaches the age of 72 during 2023, the participant may defer receiving distributions until April 1, 2025, the latest date that a required minimum distribution may be taken for 2024.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements of the Plan are presented on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”).

Investment Valuation and Recognition of Income or Loss

The Plan’s investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Net realized and unrealized appreciation or depreciation in fair value of common/collective trusts and investment income, net from self-directed brokerage accounts includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants (Participant Loans)

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded when earned. Related fees are recorded as administrative expenses and are expensed as incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Administrative Expenses

Administrative expenses of the Plan are those paid to the recordkeeper, trustee, custodian, and auditor of the Plan as provided in the Plan document. Other than certain fees paid to service providers of the Plan, substantially all costs of administering the Plan are paid by the Company. Certain distribution and loan fees, which may be incurred by the requesting participants, are paid from those participants’ accounts.

Payment of Benefits

Benefits are recorded when paid.

Estimates

The preparation of financial statements in conformity with U.S. GAAP requires Plan management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Subsequent Events

The Plan has evaluated subsequent events through the date of the independent auditors' report, which is the date these financial statements were available to be issued (Note 12).

NOTE 3. INFORMATION CERTIFIED BY THE CUSTODIAN

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and the ERISA-required supplemental schedule (Schedule H, Part IV, Line 4i), including investments in common/collective trusts and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation or depreciation in fair value of common/collective trusts, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by American Trust Company, the custodian of the Plan.

NOTE 4. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to provision of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

NOTE 5. FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs are unadjusted, quoted market prices in active markets for identical assets or liabilities at the measurement date.

Level 2 – Inputs are either directly or indirectly observable for the asset or liability through correlation with related market data at the measurement date and for the duration of the instrument's anticipated life.

NOTE 5. FAIR VALUE MEASUREMENTS (Continued)

Level 3 – Inputs are both unobservable and significant to the overall fair value measurement for the asset or liability at the measurement date. These inputs reflect management’s best estimate of what market participants would use in pricing the asset or liability at the measurement date. Consideration is given to the risk inherent in the valuation technique and in the inputs to the model.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodology used for investments measured at fair value at December 31, 2024 and 2023. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Common/collective trusts: Valued at net asset value (“NAV”) using the fair value of underlying funds of the respective collective investment trust (“CIT”). The fair value of funds held are used in determining the NAV of the CIT, which is not publicly quoted but is available to current investors. The NAV is the basis for current transactions and the CIT can be redeemed at NAV as of the measurement date. Therefore, it is believed that these investments have a readily determinable fair value.

Self-directed brokerage accounts: Accounts consist primarily of money market funds, publicly traded mutual funds, exchange traded funds, and common stocks that are valued on the basis of readily determinable market prices for identical assets.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while Plan management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 6. EXEMPT PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by American Trust, the custodian of the Plan. The Company provides administrative services for the Plan at no cost to the Plan. Certain of the Plan's operating expenses are paid by the Company. These transactions qualify as exempt party-in-interest transactions.

NOTE 7. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the accompanying financial statements.

NOTE 8. TAX STATUS

The Company has adopted a pre-approved defined contribution plan and relies upon the opinion letter dated June 30, 2020 from the IRS which states that, in its opinion, the pre-approved plan and related trust are designed in accordance with applicable sections of the IRC. The Company has not applied for a determination letter from the IRS specific to the Plan. Although the Plan has been subsequently amended, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the accompanying financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 9. SECURE 2.0 ACT

On December 29, 2022, the SECURE 2.0 Act became law. The purpose of the legislation is to expand access to retirement plans and to help working Americans increase their retirement savings. In addition to the change to distributions described in Note 1, the SECURE 2.0 Act includes various required and optional provisions that become effective through 2033, certain of which are described below:

- Beginning in 2023, the age for required minimum distributions increased from age 72 to 73 (Note 1). Beginning in 2033, the age for required minimum distributions will increase from age 73 to 75.
- Beginning January 1, 2025, a participant from the ages of 60 to 63 can elect catch-up contributions up to the limit of the greater of \$10,000 or 150% of the catch-up contribution limit imposed by the IRS.

NOTE 9. SECURE 2.0 ACT (Continued)

- Beginning January 1, 2025, long-term part-time workers (defined as employees who have worked for two consecutive 12 month periods during each of which they have at least 500 hours of service) will become eligible to enroll in their employer's retirement plan after two years.
- Beginning January 1, 2026, catch-up contributions will be made on a Roth basis, unless the participant earns \$145,000 or less.

Plan management has not yet determined which of the remaining optional provisions the Plan will implement.

NOTE 10. DELINQUENT PARTICIPANT CONTRIBUTION

The Company identified one instance in 2023 where amounts withheld from an employee totaling \$1,250 was not forwarded to the custodian within the reasonableness timeframe established by the DOL. The Company remitted the delinquent contribution as well as the corresponding lost earnings in the amount of approximately \$111 to the Plan in October and December 2024, respectively.

Based on such actions, Plan management and the Company believe the delinquent remittances will not cause the Plan to be disqualified by the IRS and that the self-corrective actions will allow the Plan to be in compliance with the Plan documents and ERISA. Accordingly, no provision for income taxes has been included in the accompanying financial statements.

NOTE 11. RECONCILIATION TO FORM 5500

For 2024, investment income, net from self-directed brokerage accounts is presented as its own item on the accompanying statement of changes in net assets. For purposes of Form 5500 reporting, investment income, net from self-directed brokerage accounts is presented as other income.

NOTE 12. SUBSEQUENT EVENTS

Effective July 1, 2025, the Plan was amended such that new participant loans are not permitted.
