INDEPENDENT AUDITOR'S REPORT

Opinion

We have audited the financial statements of Skadden, Arps, Slate, Meagher & Flom Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

NOTE 1 - DESCRIPTION OF PLAN

The following brief description of the Skadden, Arps, Slate, Meagher & Flom Savings Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

General: Effective November 8, 1979, Skadden, Arps, Slate, Meagher & Flom, LLP adopted the Plan to provide non-legal employees with a systematic program of personal savings. The Plan was amended effective April 1, 1985 to include legal employees (associate attorneys and special counsel) and, as of January 1, 1992, to include partners. Effective May 1, 2001, employees can elect to become participants in the Plan at any time following date of hire. Effective for an employee hired or rehired on or after May 1, 2024, other than as a partner, of counsel, summer/winter associate, seasonal employee, or intern (all as identified by the firm in its discretion and reflected in the firm’s employment records), if such employee does not affirmatively elect otherwise, the employee will be automatically enrolled in the Plan at a 5% pre-tax contribution rate. Prior to such automatic enrollment, the employee shall be given (a) notice of the deemed election and automatic enrollment and (b) a reasonable opportunity to affirmatively change the deemed election to a different percentage (including 0%). Absent the employee’s affirmative election, the deemed election shall be automatically increased by 1% as of the first day of each plan year commencing with the plan year that begins on or after the date that is six complete calendar months after such employee’s automatic enrollment date; provided that, in no case will such deemed elected percentage exceed 12%. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

Contributions: Generally, participants may elect to make pre-tax contributions, Roth 401(k) contributions, or traditional after-tax contributions. The aggregate of pre-tax, traditional after-tax, and Roth 401(k) contributions may not exceed 75% of gross eligible compensation (and subject to the relevant IRC limitations).

Effective January 1, 2024, an eligible employee with respect to basic contributions made by the firm shall mean any employee who has completed a year of service and is either (i) not a legal employee, or (ii) is a counsel. The employer makes a basic 4% contribution to the Plan for each eligible employee who is not a counsel. For each eligible employee who is counsel, the firm makes a basic 3% contribution to the Plan. These employees become eligible for the applicable basic contribution the January 1 or July 1 following the completion of one year of eligibility service (a 12-month period from date of hire during which a minimum of 1,000 hours are worked). These basic contributions are made to applicable participants’ individual accounts regardless of whether they make contributions to the Plan.

The employer also makes an additional basic 4% contribution to the Plan for each eligible employee who is not a counsel or a designated firm director.

As required by the Tax Reform Act of 1986 and subsequent legislation, the Plan was amended, effective April 1, 1987, to limit the sum of pre-tax and Roth 401(k) contributions for calendar years subsequent to 1986 (\$23,000 for 2024, after adjustments for periodic cost-of-living increases). The Plan, as amended, qualifies under Section 401(k) of the Internal Revenue Code (the “Code”) as a cash or deferred arrangement plan.

As further required by the Tax Reform Act of 1986 and subsequent legislation, the Plan was amended, effective January 1, 1989, to limit the amount of compensation to be taken into account under the Plan for purposes of determining basic and additional basic contributions (\$345,000 for 2024, after adjustments for periodic cost-of-living increases).

The Plan accepts eligible rollover distributions received from other qualified retirement plans.

Participant Accounts: Individual accounts are maintained for each Plan participant. Participant accounts are credited with employee contributions, employer contributions, and investment gains. Participant accounts also are debited with withdrawals, expenses and investment losses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants' contributions, together with any earnings attributable thereto, vest immediately.

Participants are also immediately vested in basic employer contributions, together with any earnings attributable to such contributions made on their behalf. Participants will become 100% vested in additional basic employer contributions and related earnings upon the completion of three years of service. Participants are fully vested if while actively employed they attain age 62, become totally and permanently disabled or pass away.

Upon participants' termination of employment, employer contributions which are not vested, together with any earnings attributable thereto, become forfeitures. Forfeitures are applied to reduce future employer contributions. Under certain conditions provided for in the Plan, active participants may withdraw funds against their vested interests in the Plan.

Payment of Benefits: Participants' vested interests in the Plan are paid to them or their beneficiaries upon retirement, termination of employment, death, or disability. Participants may elect to receive their distributions in one lump sum or in installments over a period of not more than fifteen years. Terminated participants with vested account balances in excess of \$7,000 also may elect to defer receipt of their benefit until such time that Required Minimum Distributions must commence.

The ultimate benefit to be received by a participant depends on the aggregate amount contributed for the participant over the years and the investment results allocated to the participant's individual account.

Forfeited Accounts: At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$4,017 and \$106, respectively. During the year ended December 31, 2024, \$95,343 of forfeitures were used to reduce employer contributions.

Investments: Participants may elect to invest any portion of their account in one or a combination of investment options. Participants may change the way their account is invested as often as they wish. Investment options include several mutual funds and collective trusts, separate accounts, and a self-directed brokerage account.

Administrative Costs: Certain administrative expenses and fees for custody charges are paid by the Employer. Each participant's account is charged an annual administrative and recordkeeping fee of \$41 (\$48 prior to February 1, 2024), assessed quarterly. See Notes 2 and 4 for a description of administrative expenses paid for by the Plan.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The accompanying financial statements have been prepared under the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Investment Valuation and Income Recognition: The Plan's investments are stated at fair value. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis.

(Continued)

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Certain management fees and operating expenses charged to the Plan for investments in mutual funds, separate accounts, and collective trusts are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

Contributions: Contributions made by the Plan participants and by the employer are recorded in the Plan year to which they relate.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect the reported amounts of assets available for benefits and changes therein. Actual results could differ from those estimates.

Risks and Uncertainties: The Plan utilizes various investment instruments, including mutual funds, separate accounts and collective trusts. Investment securities, in general, are exposed to various risks, such as interest rate, credit, liquidity, and overall market volatility risks, including global events. Due to the level of risk associated with certain investment securities and the sensitivity of certain fair value estimates to changes in valuation assumptions, Plan management believes it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Payment of Benefits: Benefit payments to participants are recorded upon distribution.

NOTE 3 - FAIR VALUE MEASUREMENTS

Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following descriptions of the valuation methods and assumptions used by the Plan to estimate the fair values of investments apply to investments held directly by the Plan.

Mutual Funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

Collective Trusts: The fair values of participation units held in the collective trusts are based on the net asset values (“NAV”) reported by the fund managers as of the financial statement dates and recent transaction prices. The Vanguard Target Retirement collective trusts provide for daily redemptions by the Plan at reported NAVs. The ClearBridge collective trust fund requires a plan sponsor to provide advance written notice of 5 business days for withdrawals that exceed \$1 million or 10% of the assets invested in the fund.

Separate Accounts: The fair value of accumulation units held in separate accounts offered under a guaranteed annuity contract that the Plan participates in are based on the net asset values reported by the fund managers as of the financial statement dates and recent transaction prices. The Capital Group EuroPacific Growth Separate Account wholly invests in the Capital Group EuroPacific Growth Trust, which aims to provide long-term growth of capital by investing in attractively valued companies in developed and emerging markets that are positioned to benefit from innovation, economic growth, and increasing consumer demand. Each separate account provides for daily redemptions by the Plan with no advance notice requirements, and has redemption prices that are determined by the fund’s accumulation unit value.

Self-directed Brokerage Accounts: Accounts consist of mutual funds that are determined by obtaining quoted prices on a nationally recognized securities exchange (Level 1).

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 4 - EXEMPT PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain fees were paid by the Plan directly and indirectly to Empower Retirement for investment management and custodial services. These fees qualify as party-in-interest transactions.

Certain administrative functions are performed by officers and employees of the Employer (who may also be participants in the Plan) at no cost to the Plan.

NOTE 5 - PLAN TERMINATION

Although it has not expressed any intention to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event that the Plan is terminated, participants would become 100% vested in their accounts.

NOTE 6 - TAX STATUS

The Plan has received a determination letter from the Internal Revenue Service dated October 11, 2017, stating that the Plan is qualified under Section 401(a) of the Code and, therefore, the related trust is exempt from taxation. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualification. The Plan has been amended and restated since receipt of the determination letter. However, the Plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes that the Plan is qualified and the related trust is tax exempt.

NOTE 6 - TAX STATUS (Continued)

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by the Department of Labor or Internal Revenue Service; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 7 - SUBSEQUENT EVENT

Plan management has evaluated subsequent events for recognition and disclosure through October 14, 2025, which is the date the financial statements were available to be issued.



